Advances in computational capabilities and in statistical theory for dependent observations have contributed to a resurgence of theoretical development in this area. This volume contains 20 papers whose topics include two-arm clinical trials, adaptive dose-response designs for quantile estimation and maximizing survival in the presence of opposing hazard functions, linear models, multinomial models, quality control and group testing.
