# Existence of Positive Solutions of Semilinear Biharmonic Equations

This paper is concerned with the existence of positive solutions of semilinear biharmonic problem whose associated functionals do not satisfy the Palais-Smale condition.

## 1. Introduction

We consider the semilinear biharmonic problem

& \Delta^{2} u=f(x, u) \quad \text { in } \Omega \\
& u=\Delta u=0 \quad \text { on } \partial \Omega \tag{1}
\end{align*}
$$

where $\Omega$ is a bounded domain with smooth boundary in $\mathbb{R}^{N}, N \geq 5$.

Problems of this type have been studied in [1-7]. In [6] Liu and Wang studied (1) when $f(x, t)$ is asymptotically linear with respect to $t$ at infinity. In order to find critical points of the functional $\Phi$ associated with (1), one usually applies the Mountain Pass Theorem proposed by Ambrosetti and Rabinowitz [8]. For applying the theorem, one often requires the following condition, that is, for some $\theta>2$ and $M>0$ :

\end{equation*}

where $F(x, t)=\int_{0}^{t} f(x, s) d s$. Condition (2) is important for ensuring that each Palais-Smale sequence is bounded in $H^{2}(\Omega) \cap H_{0}^{1}(\Omega)$. We say $\Phi$ satisfies the Palais-Smale condition (henceforth denoted by (PS)) if any sequence $\left\{u_{n}\right\}$ for which $\Phi\left(u_{n}\right)$ is bounded and $\Phi^{\prime}\left(u_{n}\right) \rightarrow 0$ as $n \rightarrow \infty$ possesses a convergent subsequence. Note that the nonlinear term $f(x, t)$ is asymptotically linear, not superlinear, with respect to $t$ at infinity, which means that condition (2) cannot be assumed in their case. Lin et al. use some tricks and techniques to prove
that the (PS) sequence is bounded. Then they use Mountain Pass Theorem to get a positive solution to (1).

In [2] Ramos and Rodrigues considered (1) with the nonlinearity $f(x, t)=\mu t+a(x) g(t)$, where $\mu$ is a real parameter, $a \in C^{1}(\bar{\Omega})$ changes sign in $\Omega$, and $g \in C^{1}(\mathbb{R})$ is subcritical and has a superlinear behavior both at zero and at infinity. They extended for the biharmonic operator results that were obtained for the corresponding second order problem in [9]. Their assumptions on $f$ do not seem to imply suitable compactness properties (namely, the so-called Palais-Smale condition) for the corresponding functional, if one uses a variational argument. Moreover, due to the absence of sign in the nonlinear term, it is not clear whether the geometric structure of the functional associated with (1) falls into one of the usual schemes used in critical point theory.

In this paper, we suppose that $f$ satisfies the following:
(H1) $f \in C^{1}(\bar{\Omega} \times \mathbb{R}), \partial f_{t}^{\prime} / \partial x_{i} \in C(\bar{\Omega} \times \mathbb{R})(1 \leq i \leq n)$, and $f(x, t) \geq 0$ if $t \geq 0$;
(H2) $f(x, 0)=f_{t}^{\prime}(x, 0)=0$ for all $x \in \bar{\Omega}$;
(H3) there exist $T>0$ and $1<p<(N+4) /(N-4)$ such that

\end{gather*}

for $|t| \geq T$ and $x \in \bar{\Omega} ;$
(H4) there exist $\mu>0$ and $T>0$ such that $f(x, t) \geq \mu t^{p}$ for all $x \in \bar{\Omega}$ and $t \geq T$.

This type of hypotheses assumed here does not imply the (PS) condition and does not fit in the condition that implies a priori bounds. Recently, de Figueiredo and Yang [10], Liu et al. [11], and Ramos et al. [9] have considered semilinear second order elliptic problems without the (PS) condition. Our assumptions (H1)-(H4) exactly come from [10]. In [9, 10] the link between the Morse index and the $L^{\infty}$ bounds of solutions is shown. In [12] Bahri and Lions mentioned that bounds on Morse indices are useful in some problems to prove the Palais-Smale compactness condition.

For the reader's convenience, we give an example: $f(x, t)=t^{p}\left[2+\sin (\ln t) \cos |x|^{2}\right]$ for $x \in \bar{\Omega}, t \geq 0$, where $p>1$. Due to advances of our method and our interest in positive solutions, without loss of generality, we may assume that $f(x, t)=0$ for $t \leq 0$. It is easy to see that $f(x, t)$ satisfies the conditions (H1)-(H4). Moreover, it is obvious that $f(x, t)$ does not satisfy the hypothetical conditions on nonlinearity in [2].

Our main result is the following.
Theorem 1. Suppose $f$ satisfies (H1)-(H4). Problem (1) has at least a positive solution.

The organization of the paper is as follows. In Section 2 we prove some new nonlinear Liouville type theorems which may be useful in other situations. In Section 3 we prove Theorem 1. Firstly, we apply the Mountain Pass Theorem to a suitable sequence of truncated problems. In particular, it follows that the Morse index of the solutions of the truncated problems is finite. We use this fact and the blow-up argument to show that the sequence of the truncated problems is bounded. A version of the well-known Pohozaev identity is in turn essential. Throughout this paper, the constant $C$ will denote various generic constants.

## 2. Liouville Type Theorems

For $R>2 r>0$, let $\psi_{r, R} \in C_{0}^{\infty}\left(\mathbb{R}^{N}\right)$ be a cut-off function satisfying

Define

and then

Lemma 2. Suppose that $Q$ is a function satisfying $0<\mu \leq$ $Q \leq C$, where $\mu$ and $C$ are constants. Let $u$ be a nonnegative solution of the following problem:

with finite Morse index, where $1<p<(N+4) /(N-4)$. Then there exists $r_{0}>0$ such that $J^{\prime \prime}(u)\left(\psi_{r_{0}, R}^{2} u\right)^{2} \geq 0, \forall R>2 r_{0}$.

The Morse index of solutions of (7) is defined as the dimension of the negative space corresponding to the spectral decomposition of the operator $\Delta^{2}-p Q u^{p-1}$.

Proof of Lemma 2. Suppose the assertion is false. Then for $r_{1}>0$, there exists $R_{1}>2 r_{1}$ such that $J^{\prime \prime}(u)\left(\psi_{r_{1}, R_{1}}^{2} u\right)^{2}<0$ and for $r_{2}>2 R_{1}$, we may find $R_{2}>2 r_{2}$ such that $J^{\prime \prime}(u)\left(\psi_{r_{2}, R_{2}}^{2} u\right)^{2}<$ 0 . Then the supports of $\psi_{r_{1}, R_{1}}^{2} u$ and $\psi_{r_{2}, R_{2}}^{2} u$ are disjoint, so the Morse index of $u$ is larger than or equal to 2 . Iterating the argument, we may get a contradiction since the Morse index of $u$ is supposed to be finite.

Proposition 3. Let u be a bounded nonnegative solution with finite Morse index of (7). Then both $\|\Delta u\|_{L^{2}\left(\mathbb{R}^{N}\right)}$ and $\|u\|_{L^{p+1}\left(\mathbb{R}^{N}\right)}$ are finite.

Proof. By Lemma 2, there exists a $r_{0}>0$ such that

That is,

Multiplying (7) by $u \psi_{r_{0}, R}^{4}$, we find

From (9) and (10), it follows that

&\left.+16\left(\psi_{r_{0}, R} \Delta \psi_{r_{0}, R}+\left|\nabla \psi_{r_{0}, R}\right|^{2}\right) u \psi_{r_{0}, R} \nabla \psi_{r_{0}, R} \nabla u\right] d x \\
& \geq(p-1) \int_{\mathbb{R}^{N}}\left(\psi_{r_{0}, R}^{4}|\Delta u|^{2}+8 \psi_{r_{0}, R}^{3} \Delta u \nabla u \nabla \psi_{r_{0}, R}\right. \\
&\left.\quad+4 u \psi_{r_{0}, R}^{3} \Delta \psi_{r_{0}, R} \Delta u\right) d x \\
&+(12 p-4) \int_{\mathbb{R}_{N}} \psi_{r_{0}, R}^{2}\left|\nabla \psi_{r_{0}, R}\right|^{2} u \Delta u d x \\
& \geq(p-1) \int_{\mathbb{R}^{N}}\left[\psi_{r_{0}, R}^{4}|\Delta u|^{2}\right. \\
& \quad-4\left(\varepsilon \psi_{r_{0}, R}^{4}|\Delta u|^{2}+\frac{1}{\varepsilon} \psi_{r_{0}, R}^{2}|\nabla u|^{2}\left|\nabla \psi_{r_{0}, R}\right|^{2}\right) \\
&\left.\quad-2\left(\varepsilon \psi_{r_{0}, R}^{4}|\Delta u|^{2}+\frac{1}{\varepsilon} \psi_{r_{0}, R}^{2} u^{2}\left|\Delta \psi_{r_{0}, R}\right|^{2}\right)\right] d x
\end{align*}

where $\varepsilon>0$ is small enough. Consequently,

& \leq C \int_{\mathbb{R}^{N}} {\left[\left(\psi_{r_{0}, R} \Delta \psi_{r_{0}, R}+\left|\nabla \psi_{r_{0}, R}\right|^{2}\right)^{2} u^{2}\right.} \\
&+\psi_{r_{0}, R}^{2}\left|\nabla \psi_{r_{0}, R}\right|^{2}|\nabla u|^{2} \\
&+\left(\psi_{r_{0}, R} \Delta \psi_{r_{0}, R}+\left|\nabla \psi_{r_{0}, R}\right|^{2}\right) u \psi_{r_{0}, R} \nabla \psi_{r_{0}, R} \nabla u \\

Using the value of $\psi_{r_{0}, R}$, we get

& =C\left[\int_{B_{2 r_{0}} \backslash B_{r_{0}}}\left(\psi_{r_{0}, R}^{2}\left|\Delta \psi_{r_{0}, R}\right|^{2}+C\left|\nabla \psi_{r_{0}, R}\right|^{4}\right) u^{2} d x\right. \\
& \quad+\int_{B_{2 R} \backslash B_{R}}\left(\psi_{r_{0}, R}^{2}\left|\Delta \psi_{r_{0}, R}\right|^{2}+\left|\nabla \psi_{r_{0}, R}\right|^{4}\right) u^{2} d x

\leq C\left(1+\frac{1}{R^{4}} \int_{B_{2 R}} u^{2} d x+\frac{1}{R^{2}} \int_{B_{2 R}} \psi_{r_{0}, R}^{2}|\nabla u|^{2} d x\right) . \tag{13}

Using the interpolation inequality (see [13]), we obtain

Using the value of $\psi_{r_{0}, R}$ again, we have

Estimating the right side of (16) by the argument exactly as above and using (14), we have

where $C$ does not depend on $R$.
Since $\psi_{r_{0}, R}=1$ over $B_{R} \backslash B_{2 r_{0}}$,

& \quad=\int_{B_{R}} Q(x) u^{p+1} d x-\int_{B_{2 r_{0}}} Q(x) u^{p+1}\left(1-\psi_{r_{0}, R}^{4}\right) d x . \tag{18}

By (17), we get

Hence

since $\mu \leq Q(x) \leq C$ and $u$ is bounded.
We will prove $\int_{\mathbb{R}^{N}}|u|^{p+1} d x<+\infty$. Assume to the contrary that $\int_{\mathbb{R}^{N}}|u|^{p+1} d x$ is not finite; by (20), we obtain

for large $R$.
Using Hölder's inequality, we get

Substituting (22) for the right-hand side in (21) gives.

Let $\alpha=-4+(N(p-1) /(p+1)), \beta=2 /(p+1)$, and $I(R)=$ $\int_{B_{R}}|u|^{p+1} d x$. Then iterating (23), we get

where $\gamma=1+\beta+\cdots+\beta^{k}, \delta=\beta+2 \beta^{2}+\cdots+k \beta^{k}$.
Since $u$ is bounded, the left side of (24) is of the order $R^{N}$, while the right side is of the order $R^{M}$, where

M=\alpha \frac{1-\beta^{k+1}}{1-\beta}+N \beta^{k+1} \longrightarrow \frac{\alpha}{1-\beta}, \quad \text { as } k \longrightarrow+\infty \tag{25}
\end{equation*}

which yields a contradiction since $\alpha<0$.
As above using (14), we obtain

\end{equation*}
$$

Combining (26) and (22), we have

& \quad \leq C\left[1+R^{-4+(N(p-1) /(p+1))}\left(\int_{B_{2 R}}|u|^{p+1} d x\right)^{2 /(p+1)}\right] \tag{27}

Using the already proved fact that $\int_{\mathbb{R}^{N}}|u|^{p+1} d x$ is finite, we obtain $\int_{\mathbb{R}^{N}}|\Delta u|^{2} d x<+\infty$.

Using an approach similar to the method used in the proof of Proposition 3, we prove the following proposition.

Proposition 4. Suppose that $Q$ is a function satisfying $0<$ $\mu \leq Q \leq C$, where $\mu$ and $C$ are constants. Let $u$ be a bounded nonnegative solution with finite Morse index of

where $1<p<(N+4) /(N-4)$ and $\mathbb{R}_{+}^{N}=\left\{x=\left(x_{1}, \ldots, x_{N}\right) \in\right.$ $\left.\mathbb{R}_{+}^{N}: x_{N}>0\right\}$. Then both $\|\Delta u\|_{L^{2}\left(\mathbb{R}_{+}^{N}\right)}$ and $\|u\|_{L^{p+1}\left(\mathbb{R}_{+}^{N}\right)}$ are finite.

Proposition 5. Let $u$ be as in Proposition 3. Suppose that

$$

\int_{\mathbb{R}^{N}}|\Delta u|^{2} d x \geq v \int_{\mathbb{R}^{N}} Q(x) u^{p+1} d x \tag{29}
\end{equation*}
$$

where $\nu>1$. Then $u \equiv 0$.
Proof. By Proposition 3 and (7), we obtain

\end{equation*}

By (29), it yields

For future reference, we have the following result at the end of this section.

Lemma 7. Let u be a nonnegative solution of problem (7) with finite Morse index. Then there exists $r_{0}>0$ such that for $R>$ $2 r_{0}$ one has

to the operator $\Delta^{2}-p Q u^{p-1}$. Suppose that $0 \leq i(Q, u)<m$. Let $\psi_{i}, i=1,2, \ldots$, be smooth functions such that

for $i \geq 2$,

\left|\nabla \psi_{i}\right| \leq C, \quad\left|\Delta \psi_{i}\right| \leq C, \quad \text { for } i \geq 1 . \tag{34}
\end{equation*}
$$

Denote $\psi_{i, R}=\psi_{i}(x / R)$ for $R>0$. For each $R>0$, there exists $i=i(R)$ such that

& +16\left(\psi_{i, R} \Delta \psi_{i, R}+\left|\nabla \psi_{i, R}\right|^{2}\right) u \psi_{i, R} \nabla \psi_{i, R} \nabla u \\
& +8 \psi_{i, R}^{3} \Delta u \nabla \psi_{i, R} \nabla u  \tag{35}\\
& \left.+4\left(\psi_{i, R} \Delta \psi_{i, R}+\left|\nabla \psi_{i, R}\right|^{2}\right) u \psi_{i, R}^{2} \Delta u\right] d x \\
\geq & p \int_{\mathbb{R}^{N}} Q(x) u^{p+1} \psi_{i, R}^{4} d x .
\end{align*}

So we deduce as (12) and (15) that

& \times u \psi_{i, R}\left|\nabla \psi_{i, R}\right| \cdot|\nabla u|+\psi_{i, R}^{2}|\nabla u|^{2}\left|\nabla \psi_{i, R}\right|^{2} \\
&\left.+\psi_{i, R}^{2} u^{2}\left|\Delta \psi_{i, R}\right|^{2}+\left|\nabla \psi_{i, R}\right|^{4} u^{2}\right] d x, \\
& \int_{\mathbb{R}^{N}} Q(x) u^{p+1} \psi_{i, R}^{4} d x \\
& \leq C \int_{\mathbb{R}^{N}} {\left[\left(\psi_{i, R} \Delta \psi_{i, R}+\left|\nabla \psi_{i, R}\right|^{2}\right)^{2} u^{2}+\psi_{i, R}^{2}\left(\nabla \psi_{i, R} \nabla u\right)^{2}\right.} \\
&+\left(\psi_{i, R}\left|\Delta \psi_{i, R}\right|+\left|\nabla \psi_{i, R}\right|^{2}\right) u \psi_{i, R}\left|\nabla \psi_{i, R}\right| \cdot|\nabla u| \\
&\left.+8 \psi_{i, R}^{2}\left|\nabla \psi_{i, R}\right|^{2} u|\Delta u|\right] d x . \tag{36}
\end{align*}
$$

By (36), we have

\leq C \int_{\mathbb{R}^{N}} & {\left[\left(\psi_{i, R}\left|\Delta \psi_{i, R}\right|+\left|\nabla \psi_{i, R}\right|^{2}\right)^{2} u^{2}+\psi_{i, R}^{2}\left|\nabla \psi_{i, R}\right|^{2}|\nabla u|^{2}\right.} \\
& +\left(\psi_{i, R}\left|\Delta \psi_{i, R}\right|+\left|\nabla \psi_{i, R}\right|^{2}\right) u \psi_{i, r}\left|\nabla \psi_{i, R}\right| \cdot|\nabla u| \\
& +\psi_{i, R}^{2}\left|\nabla \psi_{i, R}\right|^{2} u|\Delta u|+\psi_{i, R}^{2}\left|\Delta \psi_{i, R}\right|^{2} u^{2} \\
& \left.+\left|\nabla \psi_{i, R}\right|^{4} u^{2}\right] d x \\

& +\left(\psi_{i, R}\left|\Delta \psi_{i, R}\right|+\left|\nabla \psi_{i, R}\right|^{2}\right) u \psi_{i, R}\left|\nabla \psi_{i, R}\right| \\

where $\varepsilon>0$ is small enough.

&\left.\cdot|\nabla u|+\psi_{i, R}^{2}\left|\Delta \psi_{i, R}\right|^{2} u^{2}+\left|\nabla \psi_{i, R}\right|^{4} u^{2}\right] d x \\
& \leq C \int_{\mathbb{R}^{N}} {\left[\left(\psi_{i, R}\left|\Delta \psi_{i, R}\right|+\left|\nabla \psi_{i, R}\right|^{2}\right)^{2} u^{2}+\psi_{i, R}^{2}\left|\nabla \psi_{i, R}\right|^{2}|\nabla u|^{2}\right.} \\
&\left.+\psi_{i, R}^{2}\left|\Delta \psi_{i, R}\right|^{2} u^{2}+\left|\nabla \psi_{i, R}\right|^{4} u^{2}\right] d x . \tag{38}
\end{align*}

Integrating by parts, we obtain

& \leq C\left(\int_{\mathbb{R}^{N}}\left(\psi_{i, R}^{4}|\Delta u|^{2}+u^{2} \psi_{i, R}^{4}\right) d x+\varepsilon \int_{\mathbb{R}^{N}}|\nabla u|^{2} \psi_{i, R}^{4} d x\right. \\
& \left.\quad+\varepsilon^{-1} \int_{\mathbb{R}^{N}} \psi_{i, R}^{2} u^{2}\left|\nabla \psi_{i, R}\right|^{2} d x\right) . \tag{40}
\end{align*}

\left.\quad+\int_{\mathbb{R}^{N}} u^{2}\left|\nabla \psi_{i, R}\right|^{4} d x\right) \\
\leq C\left(\int_{\mathbb{R}^{N}}\left(\psi_{i, R}^{4}|\Delta u|^{2}+u^{2}\left|\nabla \psi_{i, R}\right|^{4}\right) d x\right. \\
\left.\quad+\int_{\mathbb{R}^{N}}\left|\Delta\left(u \psi_{i, R}^{2}\right)\right|^{2} d x\right) \\
\leq C\left(\int_{\mathbb{R}^{N}}\left(\psi_{i, R}^{4}|\Delta u|^{2}+u^{2}\left|\nabla \psi_{i, R}\right|^{4}\right) d x\right. \\
\quad+\int_{\mathbb{R}^{N}}\left(\psi_{i, R}^{2} \Delta u+2 u \psi_{i, R} \Delta \psi_{i, R}+2 u \psi_{i, R} \Delta \psi_{i, R}\right. \\
\left.\left.\quad+2 u\left|\nabla \psi_{i, R}\right|^{2}+4 \psi_{i, R} \nabla u \nabla \psi_{i, R}\right)^{2} d x\right) \\
\leq C \int_{\mathbb{R}^{N}}\left(\psi_{i, R}^{4}|\Delta u|^{2}+u^{2}\left|\nabla \psi_{i, R}\right|^{4}+u^{2} \psi_{i, R}^{2}\left|\Delta \psi_{i, R}\right|^{2}\right. \\
\left.\quad+\psi_{i, R}^{2}|\nabla u|^{2}\left|\nabla \psi_{i, R}\right|^{2}\right) d x .
\end{array}
\end{align*}

Multiplying (7) by $\psi_{i, R}^{4} \Delta u$ and integrating by parts, we obtain

& \leq C R^{(N(p-1) /(p+1))-4}\left(\int_{\mathbb{R}^{N}} u^{p+1} d x\right)^{2 /(p+1)} .
\end{aligned}

Hence, there exists $\bar{R} \in(R,(2 m-1) R)$ such that

## 3. Proof of Theorem 1

Let us first note that hypotheses (H1)-(H4) imply that there exist a sequence $\left\{t_{n}\right\}, t_{n} \rightarrow+\infty$ as $n \rightarrow \infty$ and a continuous function $c$ such that

Using L'Hospital's rule, we obtain

\end{equation*}

Without loss of generality, we may assume that $f(x, t)=0$, if $t \leq 0$. Define a truncation of $f$ by

Note that $f_{n} \in C^{1}$ in the variable $t$.
Let us consider the truncated problem

u=\Delta u=0 \quad \text { on } \partial \Omega
\end{gather*}

Lemma 8. Problem (52) possesses at least one positive solution with finite Morse index.

Proof. Consider the functional associated with problem (52)

where $F_{n}(x, t)=\int_{0}^{t} f_{n}(x, s) d s$. We will use the Mountain Pass Theorem by Ambrosetti and Rabinowitz [8] to obtain existence result for problem (52). One can easily check that there exist $\theta>2$ and $M>0$ such that for $|t| \geq M$,

We note that condition (54) is important for ensuring that $J_{n}$ has a Mountain Pass geometry and satisfies the Palais-Smale condition. So, using the Mountain Pass Theorem, we obtain a nontrivial weak solution $u_{n}$ of (52). By Lemma B3 in [14], $u_{n}$ is a classical solution of (52). By the maximum principle for $\Delta^{2}$ with Navier boundary conditions we get that $u_{n}$ is positive. The geometry of the Mountain Pass, described in [15, 16], implies that the Morse indices of $u_{n}$ are less than or equal to 1. Thus Lemma 8 is proven.

Let $g$ be a function satisfying (H1)-(H3), and consider the problem

Lemma 9. Let $u$ be a solution of (55). Then for any ball $B_{R}(0) \subset \Omega$ one has

\end{aligned}
$$

$$
\begin{align*}
& \quad+(N-2) \int_{\partial B_{R}} \Delta u \frac{\partial u}{\partial \mathbf{n}} d S+\frac{1}{2} R \int_{\partial B_{R}}|\Delta u|^{2} d S \\
& +a b^{-1} \int_{B_{R}}\left\langle x, \nabla_{x} G\left(x_{0}+a x, b u\right)\right\rangle d x \\
& =\frac{N-4}{2} \int_{B_{R}}|\Delta u|^{2} d x+b^{-1} R \int_{\partial B_{R}} G\left(x_{0}+a x, b u\right) d S, \tag{56}
\end{align*}
$$

where $G(x, u)=\int_{0}^{u} g(x, t) d t$ and $\mathbf{n}$ denotes the unit outward normal to $\partial B_{R}$.

Proof. By standard procedures, one can prove the Pohozaev type identity. We give the proof for completeness and for the reader's convenience.

By Proposition 2.2 in [17], we have

&\quad-\langle\nabla(\Delta u), \nabla u\rangle\langle x, \mathbf{n}\rangle\} d S+\frac{N}{2} \int_{B_{R}}|\Delta u|^{2} d x \\
&+(N-2) \int_{B_{R}}\langle\nabla(\Delta u), \nabla u\rangle d x \tag{57}
\end{align*}
$$

It is clear that

g( & \left.x_{0}+a x, b u\right)\langle x, \nabla u\rangle \\
= & b^{-1} \operatorname{div}\left(x G\left(x_{0}+a x, b u\right)\right)-b^{-1} N G\left(x_{0}+a x, b u\right) \\
& -a b^{-1}\left\langle x, \nabla_{x} G\left(x_{0}+a x, b u\right)\right\rangle . \tag{58}
\end{align*}
$$

By (55), we have

& \quad-\langle\nabla(\Delta u), \nabla u\rangle\langle x, \mathbf{n}\rangle\} d S+\frac{N}{2} \int_{B_{R}}|\Delta u|^{2} d x \\
& +(N-2) \int_{B_{R}}\langle\nabla(\Delta u), \nabla u\rangle d x \\
= & b^{-1} \int_{\partial B_{R}} G\left(x_{0}+a x, b u\right)\langle x, \mathbf{n}\rangle d S
\end{aligned}
$$

$$
\begin{align*}
& -b^{-1} N \int_{B_{R}} G\left(x_{0}+a x, b u\right) d x \\
& -a b^{-1} \int_{B_{R}}\left\langle x, \nabla_{x} G\left(x_{0}+a x, b u\right)\right\rangle d x . \tag{60}
\end{align*}
$$

Using the Green's formula, we obtain

If it happens that $\left\|u_{n}\right\| \leq t_{n}$, for some $n$, then $u_{n}$ is also a solution of (1), and the proof of Theorem 1 will be completed. Thus it suffices to prove the following proposition. We prove the proposition by the blow-up technique of Gidas and Spruck [18].

Proposition 10. Suppose that $u_{n}$ is a solution of (52) with finite Morse index. Then there exists a $t_{n}>0$ such that $\left\|u_{n}\right\|_{\infty} \leq$ $t_{n}$.

Proof. Assume by contradiction that there does not exist such a $t_{n}$. So we should have $\left\|u_{n}\right\|>t_{n}$, for all $n$. Then $\left\|u_{n}\right\| \rightarrow \infty$ as $n \rightarrow \infty$.

Let $M_{n}=\max _{\bar{\Omega}} u_{n}(x)=u_{n}\left(x_{n}\right), x_{n} \in \Omega$. Define

Due to compactness of $\bar{\Omega}$ we may also assume that $x_{n} \rightarrow x_{0} \in \bar{\Omega}$. So there are two cases to be considered, $x_{0} \in \Omega$ and $x_{0} \in \partial \Omega$.

## Case 1. $x_{0} \in \Omega$.

Given $R>0$ there is an $n_{0} \in \mathbb{N}$ such that $\bar{B}_{2 R}(0) \subset \Omega_{n}$ for all $n \geq n_{0}$. By the $L^{p}$-estimates due to Agmon et al. [19], we have that for all $\gamma>1$

If $d\left(x_{n}, \partial \Omega\right) M_{n}^{-((p-1) / 4)} \rightarrow+\infty$ as $n \rightarrow \infty$, then for all $R>0$ the ball $B_{R}$ is contained in $\Omega_{n}$ for $n$ large enough. We also obtain a contradiction as in Case 1 .

If $d\left(x_{n}, \partial \Omega\right) M_{n}^{-((p-1) / 4)} \rightarrow L \geq 0$ as $n \rightarrow \infty$, by the blow-up argument we get a solution $v$ of

\end{align*}
$$

with $v \leq 1$ in $\Pi, v(0)=1$, and the Morse index being finite, where $\Pi=\left\{x \in \mathbb{R}^{N}: x_{N}>-L\right\}$. We may deduce as Case 1 that $v \equiv 0$. This is a contradiction since $v(0)=1$. Thus the proof of Proposition 10 is completed.
