Individual and Organizational Memberships. All individual members pay basic membership dues of \$50. Each regular member must elect to receive at least one scientific journal for an additional amount, as follows: The Annals of Applied Probability (\$10), The Annals of Probability (\$20), The Annals of Statistics (\$20) or Statistical Science (\$10). General subscriptions are for libraries, institutions and any multiple-readership use. Air mail rates for delivery outside North America are \$80 per title (excluding The IMS Bulletin).
