UNIQUENESS OF WEAK SOLUTIONS TO A MODEL OF ELECTRO-KINETIC FLUID*

Abstract. In this paper we prove the uniqueness of weak solutions to a model of electro-kinetic fluid which consists of a momentum equation together with transport equations of charges. Our result is new in that it holds even when the momentum vanishes. The existence of weak solutions has been proved in [P.Biler, W. Hebisch and T. Nadzieja, Nonlinear Anal. 1. Introduction

The equations governing the hydrodynamic transport of binary diffuse charge densities are [1, 2, 3],

with boundary and initial conditions

Here $\Omega \subseteq \mathbb{R}^d (d=2,3)$ is a bounded domain with smooth boundary $\partial \Omega$, ν is the unit outward normal to $\partial \Omega$.

The first equation (1.1) is the linear momentum equation of incompressible flow, and (1.1) and (1.2) are Navier-Stokes equation with the Lorentz force $\varepsilon \Delta \varphi \nabla \varphi$. u is the velocity field and π is the pressure.

Equations (1.3), (1.4), and (1.5) are known as the electro-chemical equations [4, 5] or semiconductor equations [6, 7, 8, 9], and electrorheological systems [2, 3, 10, 11, 12] when formally setting u=0. Here, n and p are the charge densities of a negatively and positively charged species, respectively, hence the sign difference in

front of the convective term in either equations, φ is the electrostatic potential, and ε is a small parameter, known as the Debye length, related to vacuum permittivity and characteristic charge density.

Very recently, Ryham, Liu and Wang [13] studied the system (1.1)–(1.8) and proved the global existence of weak solutions when $u_0 \in L^2(\Omega)$ and $n_0, p_0 \in L^2(\Omega)$ and studied the qualitative properties of solutions to the corresponding 1-d stationary problem with the Dirichlet boundary condition as ε goes to zero in [14].

Kurokiba and Ogawa [6] considered the semiconductor device equation (1.3), (1.4) and (1.5) when formally setting u=0 and $\Omega = \mathbb{R}^d (d \ge 2)$ and proved the existence and uniqueness of weak solutions with L^p initial data (n_0, p_0) when $p = \frac{d}{2}(d \ge 4)$, $p > \frac{d}{2}(d=3)$, and $p \ge \frac{4}{3}(d=2)$.

Note that the system (1.1)–(1.5) holds its form under the scaling $(u,\pi,n,p,\varphi) \rightarrow (u_{\lambda},\pi_{\lambda},n_{\lambda},p_{\lambda},\varphi_{\lambda}) := (\lambda u(\lambda^{2}t,\lambda x),\lambda^{2}\pi(\lambda^{2}t,\lambda x),\lambda^{2}n(\lambda^{2}t,\lambda x),\lambda^{2}p(\lambda^{2}t,\lambda x),\varphi(\lambda^{2}t,\lambda x))$. Under this scaling, the space $L^{\theta}(0,T;L^{p})$ is invariant for u when $\frac{2}{\theta} + \frac{d}{p} = 1$ and the space $L^{\theta}(0,T;L^{p})$ is invariant for (n,p) when $\frac{2}{\theta} + \frac{d}{p} = 2$. Furthermore, L^{d} for u_{0} and $L^{d/2}$ for (n_{0},p_{0}) are invariant spaces under this scaling.

The aim of this paper is to study the uniqueness of weak solutions in critical spaces. We will prove the following results.

THEOREM 1.1. Let $(n_0, p_0) \in L\log L, u_0 \in L^2, n_0, p_0 \geq 0$ in $\Omega \subseteq \mathbb{R}^2$ and $\int_{\Omega} \varphi dx = 0$. Then there exists a unique weak solution (u, n, p, φ) to the problem (1.1)-(1.8) satisfying

$$\begin{aligned} &(n,p) \in L^{\infty}(0,T;L\log L) \cap L^{2}(Q_{T}) \cap L^{4/3}(0,T;W^{1,\frac{4}{3}}), \quad n,p \geq 0 \quad \text{in} \quad Q_{T}, \\ &(n_{t},p_{t}) \in L^{4/3}(0,T;(W^{1,4})^{*}), \\ &\varphi \in L^{\infty}(0,T;H^{1}) \cap L^{2}(0,T;H^{2}), \quad \nabla \varphi \in L^{4}(Q_{T}), \\ &u \in V_{2}(Q_{T}) := L^{\infty}(0,T;L^{2}) \cap L^{2}(0,T;H^{1}) \subset L^{4}(Q_{T}), \\ &u_{t} \in L^{4/3}(0,T;H^{-1}). \end{aligned}$$

REMARK 1.2. We point out that the existence part of Theorem 1.1 is a slight modification of the Theorem 1 in Ryham [15], where the author considered the same system, but with the following boundary condition:

$$u=0, \quad (\nabla n-n\nabla \varphi)\cdot \nu = (\nabla p+p\nabla \varphi)\cdot \nu = \varphi = 0 \quad \text{ on } \partial\Omega.$$

Here ν is the unit outward normal to the boundary $\partial\Omega$. However, our method could not be generalized to this case.

THEOREM 1.3. Let $(n_0, p_0) \in L^{3/2}, u_0 \in L^2, n_0, p_0 \ge 0$ in $\Omega \subseteq \mathbb{R}^3$ and $\int_{\Omega} \varphi dx = 0$.

Assume further that

$$u \in L^{s}(0,T; L^{q,\infty}(\Omega))$$
 with $\frac{2}{s} + \frac{3}{q} = 1, \quad 3 < q \le \infty.$ (1.10)

Here $L^{p,\infty}(\Omega) \equiv L^p_w(\Omega)$ denotes the standard Lorentz space [16]. Then there exists a

unique weak solution (u,n,p,φ) to the problem (1.1)–(1.8) satisfying

$$\begin{aligned} &(n^{\frac{3}{4}}, p^{\frac{3}{4}}) \in V_2(Q_T) \subset L^{10/3}(Q_T), & n, p \ge 0 \quad \text{in} \quad Q_T, \\ &(n, p) \in L^{\infty}(0, T; L^{3/2}) \cap L^{5/2}(Q_T) \cap L^{5/3}(0, T; W^{1,5/3}) \cap L^4(0, T; L^2), \\ &(n_t, p_t) \in L^{5/3}(0, T; (W^{1,3})^*), \\ &\varphi \in L^{\infty}(0, T; W^{2,3/2}) \cap L^{5/2}(0, T; W^{2,5/2}), \\ &\nabla \varphi \in L^{\infty}(0, T; L^3) \cap L^{5/2}(0, T; L^{15}), \\ &u \in V_2(Q_T), \quad u_t \in L^2(0, T; (W^{1,3})^*). \end{aligned}$$

REMARK 1.4. Our result is new for equations (1.3), (1.4) and (1.5) when formally setting $u \equiv 0$, and hence (1.10) holds. When (1.10) holds, S. Dubois [17] proved the uniqueness of weak solutions to the Navier-Stokes Equations (1.1), (1.2) when $\varphi \equiv 0$.

REMARK 1.5. The existence part of Theorem 1.3 can be proved by the Galerkin method and thus we omit the details here. We only need to derive the estimates (1.9) and (1.11) and prove the uniqueness.

Our proof will be based on carefully using the low regularity estimates by introducing two auxiliary functions N and P (see (2.10) and (2.11)).

Let $p \in [0, +\infty]$ and $q \in [0, +\infty]$. We define the Lorentz space

where

Here

It is well known that

$$L^{p,p} \equiv L^p.$$

We will use the following generalized Hölder inequality [16]:

$$\|fg\|_{L^{p,q}} \le C \|f\|_{L^{p_1,q_1}} \|g\|_{L^{p_2,q_2}},\tag{1.12}$$

with $\frac{1}{p} = \frac{1}{p_1} + \frac{1}{p_2}$ and $\frac{1}{q} = \frac{1}{q_1} + \frac{1}{q_2}$. We will also use the following notation:

$$LLogL(\Omega) := \{f | \int_{\Omega} |f| \log(e+|f|) dx < +\infty\}.$$

2. Proofs of Theorem 1.1

First, we recall a technical lemma due to D. Chae [18].

LEMMA 2.1 (18, Lem. 2.1)). For any bounded domain $\Omega \subseteq \mathbb{R}^2$ with a smooth boundary we have a continuous imbedding

LEMMA 2.2. $n, p \ge 0$ in Q_T , and

$$\int_{\Omega} n\log n + p\log p dx + 4 \int_{0}^{T} \int_{\Omega} (\nabla \sqrt{n})^{2} + (\nabla \sqrt{p})^{2} dx dt + \varepsilon \int_{0}^{T} \int_{\Omega} (\Delta \varphi)^{2} dx dt = \int_{\Omega} n_{0} \log n_{0} + p_{0} \log p_{0} dx,$$

$$\nabla \varphi \in L^{\infty}(0,T;L^2). \tag{2.3}$$

Proof. By the maximum principle, it is easy to prove that $n \ge 0$ and $p \ge 0$ in Q_T .

Testing (1.3) by $1 + \log n$ and testing (1.4) by $1 + \log p$ respectively, and using the divergence free property, summing up the resulting equality, we easily get (2.2).

Testing (1.5) by φ , we see that

$$\begin{split} \varepsilon \|\nabla \varphi\|_{L^2}^2 &= -\int_{\Omega} (n-p)\varphi \mathrm{d}x \leq \|n-p\|_{(H^1(\Omega))^*} \|\varphi\|_{H^1} \\ &\leq C \|n-p\|_{L\mathrm{Log}L} \|\varphi\|_{H^1} \quad (\mathrm{by} \ (2.1)) \\ &\leq C \|\nabla \varphi\|_{L^2}. \end{split}$$

Here, we used the Poincaré inequality

and the assumption $\int_{\Omega} \varphi dx = 0$. This proves (2.3).

Lemma 2.3.

Proof. Testing (1.1) by u and taking into account the divergence-free property, we find that

$$\begin{split} \frac{1}{2} \frac{d}{dt} \int_{\Omega} u^2 \mathrm{d}x + \int_{\Omega} |\nabla u|^2 \mathrm{d}x &= \varepsilon \int_{\Omega} \Delta \varphi \nabla \varphi \cdot u \mathrm{d}x \\ &\leq \varepsilon \|\Delta \varphi\|_{L^2} \|\nabla \varphi\|_{L^4} \|u\|_{L^4} \\ &\leq \varepsilon \|\Delta \varphi\|_{L^2}^2 + \varepsilon \|\nabla \varphi\|_{L^4}^2 \|u\|_{L^4}^2 \\ &\leq \varepsilon \|\Delta \varphi\|_{L^2}^2 + C\varepsilon \|\nabla \varphi\|_{L^4}^2 \|u\|_{L^2} \|\nabla u\|_{L^2} \\ &\leq \frac{1}{2} \|\nabla u\|_{L^2}^2 + \varepsilon \|\Delta \varphi\|_{L^2}^2 + C\varepsilon \|\nabla \varphi\|_{L^4}^4 \|u\|_{L^2}^2, \end{split}$$

and by the Gagliardo-Nirenberg inequality

$$\|v\|_{L^4}^2 \le C \|v\|_{L^2} \|\nabla v\|_{L^2}, \text{ for any } v \in H^1_0(\Omega).$$

Gronwall's inequality gives (2.5).

Lemma 2.4.

Proof. By the parabolic Sobolev imbedding theorem $V_2(Q_T) \subset L^4(Q_T)$, it is easy to obtain $(n,p) \in L^2(Q_T)$. Since $\nabla n = 2\nabla \sqrt{n} \cdot \sqrt{n}$, $\nabla \sqrt{n} \in L^2(Q_T)$, $\sqrt{n} \in L^4(Q_T)$, we easily infer that $\nabla n \in L^{4/3}(Q_T)$ by the Hölder inequality.

This proves (2.7) by a similar calculations for p.

It is standard to prove (2.8) and (2.9) and thus we omit the details here.

Now we are in a position to prove the uniqueness. Let $(u_i, \pi_i, n_i, p_i, \varphi_i)$ (i = 1, 2) be two weak solutions to the problem (1.1)–(1.8). Also let us denote

$$u := u_1 - u_2, \quad \pi := \pi_1 - \pi_2, \quad n := n_1 - n_2, \quad p := p_1 - p_2, \quad \varphi := \varphi_1 - \varphi_2.$$

Now we can define N and P satisfying the following equations

From (1.5), (2.10), and (2.11), we know that

It is easy to infer that

Testing this equation by N, we obtain

Each term $I_i(i=1,2,3,4)$ can be bounded as follows.

Substituting these estimates into (2.13), we find that

It is easy to find that u satisfies

Testing this equation by u and using the divergence-free property, we obtain

Each term $J_i(i=1,2,3)$ can be bounded as follows.

$$\begin{split} J_{1} &\leq \varepsilon \|\Delta \varphi\|_{L^{2}} \|\nabla \varphi_{1}\|_{L^{4}} \|u\|_{L^{4}} \\ &\leq \frac{1}{8} \|\Delta N\|_{L^{2}}^{2} + \frac{1}{8} \|\Delta P\|_{L^{2}}^{2} + C \|\nabla \varphi_{1}\|_{L^{4}}^{2} \|u\|_{L^{4}}^{2} \\ &\leq \frac{1}{8} \|\Delta N\|_{L^{2}}^{2} + \frac{1}{8} \|\Delta P\|_{L^{2}}^{2} + \frac{1}{8} \|\nabla u\|_{L^{2}}^{2} + C \|\nabla \varphi_{1}\|_{L^{4}}^{4} \|u\|_{L^{2}}^{2} \quad (by \ (2.6)) \\ J_{2} &\leq \varepsilon \|\Delta \varphi_{2}\|_{L^{2}} \|\nabla \varphi\|_{L^{4}} \|u\|_{L^{4}} \\ &\leq \varepsilon \|\Delta \varphi_{2}\|_{L^{2}} (\|\nabla N\|_{L^{4}} + \|\nabla P\|_{L^{4}}) \|u\|_{L^{4}} \quad (by \ (2.12)) \\ &\leq \varepsilon \|\Delta \varphi_{2}\|_{L^{2}} (\|\nabla N\|_{L^{4}}^{2} + \|\nabla P\|_{L^{4}}^{2}) + \varepsilon \|\Delta \varphi_{2}\|_{L^{2}} \|u\|_{L^{4}}^{2} \\ &\leq \frac{1}{8} \|\Delta N\|_{L^{2}}^{2} + \frac{1}{8} \|\Delta P\|_{L^{2}}^{2} + \frac{1}{8} \|\nabla u\|_{L^{2}}^{2} \\ &+ C \|\Delta \varphi_{2}\|_{L^{2}}^{2} (\|\nabla N\|_{L^{2}}^{2} + \|\nabla P\|_{L^{2}}^{2} + \|u\|_{L^{2}}^{2}), \\ J_{3} &\leq \|u\|_{L^{4}}^{2} \|\nabla u\|_{L^{2}} \leq C \|u\|_{L^{2}} \|\nabla u\|_{L^{2}} \|\nabla u\|_{L^{2}} \|\nabla u\|_{L^{2}} \\ &\leq \frac{1}{8} \|\nabla u\|_{L^{2}}^{2} + C \|\nabla u_{2}\|_{L^{2}}^{2} \|u\|_{L^{2}}^{2}. \end{split}$$

Inserting the above estimate into (2.16), we arrive at

$$\frac{1}{2} \frac{d}{dt} \int_{\Omega} u^{2} dx + \frac{5}{8} \int_{\Omega} |\nabla u|^{2} dx \leq \frac{1}{4} ||\Delta N||_{L^{2}}^{2} + \frac{1}{4} ||\Delta P||_{L^{2}}^{2}
+ C \left(||\nabla \varphi_{1}||_{L^{4}}^{4} + ||\Delta \varphi_{2}||_{L^{2}}^{2} + ||\nabla u_{2}||_{L^{2}}^{2} \right) ||u||_{L^{2}}^{2}
+ C \left(||\Delta \varphi_{2}||_{L^{2}}^{2} \left(||\nabla N||_{L^{2}}^{2} + ||\nabla P||_{L^{2}}^{2} \right) ||u||_{L^{2}}^{2}$$
(2.17)

Adding up (2.14), (2.15), and (2.17) we conclude that

$$\frac{d}{dt}\int_{\Omega}|\nabla N|^2+|\nabla P|^2+|u|^2\mathrm{d}x\leq C(t)\int_{\Omega}|\nabla N|^2+|\nabla P|^2+|u|^2\mathrm{d}x$$

with some $C(t) \in L^1(0,T)$. Gronwall's inequality gives N = 0 = P = u and thus $n = p = 0 = \varphi$, which completes the proof.

3. Proof of Theorem 1.2

First, we derive the estimates (1.11). LEMMA 3.1.

$$\begin{split} \int_{\Omega} n^{\frac{3}{2}} + p^{\frac{3}{2}} \mathrm{d}x + 4 \int_{0}^{T} \int_{\Omega} (\nabla n^{\frac{3}{4}})^{2} + (\nabla p^{\frac{3}{4}})^{2} \mathrm{d}x \mathrm{d}t \\ &+ \frac{1}{2\varepsilon} \int_{0}^{T} \int_{\Omega} (n-p)(n^{\frac{3}{2}} - p^{\frac{3}{2}}) \mathrm{d}x \mathrm{d}t = \int_{\Omega} n^{\frac{3}{2}}_{0} + p^{\frac{3}{2}}_{0} \mathrm{d}x, \end{split} \tag{3.1}$$
$$(n,p) \in L^{\infty}(0,T; L^{\frac{3}{2}}) \cap L^{\frac{5}{2}}(Q_{T}) \cap L^{\frac{5}{3}}(0,T; W^{1,5/3}) \cap L^{4}(0,T; L^{2}). \tag{3.2}$$

Proof. Testing (1.3), (1.4) by
$$\sqrt{n}, \sqrt{p}$$
, respectively, using the divergence-free property, and summing up the resulting equation, we obtain (3.1).

From (3.1), it follows easily that

$$(n^{\frac{3}{4}}, p^{\frac{3}{4}}) \in V_2(Q_T) \subset L^{\frac{10}{3}}(Q_T)$$

and thus

$$(n,p) \in L^{\infty}(0,T;L^{\frac{3}{2}}) \cap L^{\frac{5}{2}}(Q_T).$$

On the other hand, $\nabla n = \frac{4}{3} (\nabla n^{\frac{3}{4}}) \cdot n^{\frac{1}{4}}, \nabla n^{\frac{3}{4}} \in L^2(Q_T), n^{\frac{1}{4}} \in L^{10}(Q_T)$, thus $\nabla n \in L^{\frac{5}{3}}(Q_T)$ by the Hölder's inequality. By the interpolation inequality.

By the interpolation inequality

$$\|n\|_{L^{2}} \leq \|n\|_{L^{\frac{3}{8}}}^{\frac{3}{8}} \|n\|_{L^{\frac{5}{2}}}^{\frac{5}{8}},$$

we obtain

$$n \in L^4(0,T;L^2).$$

This proves (3.2). LEMMA 3.2.

$$\varphi \in L^{\infty}(0,T;W^{2,\frac{3}{2}}) \cap L^{5/2}(0,T;W^{2,5/2}) \cap L^4(0,T;H^2), \tag{3.3}$$

$$\varphi \in L^{\infty}(0,T;W^{1,3}) \cap L^{5/2}(0,T;W^{1,15}).$$
(3.4)

Proof. By the standard regularity theory of elliptic second order equations and (3.2), we easily obtain (3.3) and (3.4) follows from the Sobolev embedding theorem $W^{2,\frac{3}{2}} \subset W^{1,3}$ and $W^{2,\frac{5}{2}} \subset W^{1,15}$.

Lemma 3.3.

$$u \in V_2(Q_T) \subset L^{10/3}(Q_T),$$
 (3.5)

$$u_t \in L^2(0,T;(W^{1,3})^*), \quad (n_t,p_t) \in L^{5/3}(0,T;(W^{1,3})^*).$$
 (3.6)

Proof. Testing (1.1) by u and using (1.2), we see that

$$\begin{split} \frac{1}{2} \frac{d}{dt} \int_{\Omega} u^2 \mathrm{d}x + \int_{\Omega} |\nabla u|^2 \mathrm{d}x &= \int_{\Omega} \varepsilon \Delta \varphi \nabla \varphi \cdot u \mathrm{d}x \\ &\leq \varepsilon \|\Delta \varphi\|_{L^2} \|\nabla \varphi\|_{L^6} \|u\|_{L^3} \\ &\leq C \|\varphi\|_{H^2}^2 \|\nabla u\|_{L^2} \leq \frac{1}{2} \|\nabla u\|_{L^2}^2 + C \|\varphi\|_{H^2}^4. \end{split}$$

Using (3.3) and Gronwall's inequality, we obtain (3.5).

The proof of (3.6) is standard and thus we omit the details here.

Now we are in a position to prove the uniqueness. We still use the same notation as in section 2, and similarly we get (2.13). But each term $I_i(i=1,2,3,4)$ can be bounded as follows

$$I_{1} \leq \|\Delta N\|_{L^{2}} \|\nabla N\|_{L^{\frac{30}{13}}} \|\nabla \varphi_{1}\|_{L^{15}}$$

$$\leq C \|\Delta N\|_{L^{2}}^{\frac{6}{5}} \|\nabla N\|_{L^{2}}^{\frac{4}{5}} \|\nabla \varphi_{1}\|_{L^{15}}$$

$$\leq \frac{1}{8} \|\Delta N\|_{L^{2}}^{2} + C \|\nabla \varphi_{1}\|_{L^{15}}^{\frac{5}{2}} \|\nabla N\|_{L^{2}}^{2},$$

and by the Gagliardo-Nirenberg inequality

$$\|\nabla N\|_{L^{\frac{30}{13}}} \le C \|\nabla N\|_{L^2}^{\frac{4}{5}} \|\Delta N\|_{L^2}^{\frac{1}{5}}.$$
(3.7)

$$\begin{split} I_{2} &\leq \|n_{2}\|_{L^{2}} \|\nabla\varphi\|_{L^{6}} \|\nabla N\|_{L^{3}} \leq C \|n_{2}\|_{L^{2}} (\|\Delta N\|_{L^{2}} + \|\Delta P\|_{L^{2}}) \|\nabla N\|_{L^{3}} \\ &\leq C \|n_{2}\|_{L^{2}} (\|\Delta N\|_{L^{2}} + \|\Delta P\|_{L^{2}}) \|\nabla N\|_{L^{2}}^{\frac{1}{2}} \|\Delta N\|_{L^{2}}^{\frac{1}{2}} \\ &\leq \frac{1}{8} \|\Delta N\|_{L^{2}}^{2} + \frac{1}{8} \|\Delta P\|_{L^{2}}^{2} + C \|n_{2}\|_{L^{2}}^{4} \|\nabla N\|_{L^{2}}^{2}, \end{split}$$

and by the Gagliardo-Nirenberg inequality

$$\|\nabla N\|_{L^3}^2 \le C \|\nabla N\|_{L^2} \|\Delta N\|_{L^2}.$$
(3.8)

$$I_{3} \leq C \|u_{1}\|_{L^{q,\infty}} \|\Delta N\|_{L^{2}} \|\nabla N\|_{L^{\frac{2q}{q-2},2}} \qquad (by(1.12))$$

$$\leq C \|u_{1}\|_{L^{q,\infty}} \|\Delta N\|_{L^{2}}^{1+\frac{3}{q}} \|\nabla N\|_{L^{2}}^{1-\frac{3}{q}}$$

$$\leq \frac{1}{8} \|\Delta N\|_{L^{2}}^{2} + C \|u_{1}\|_{L^{q,\infty}}^{\frac{2q}{q-3}} \|\nabla N\|_{L^{2}}^{2},$$

and by the Gagliardo-Nivenberg inequality ([16])

$$\|\nabla N\|_{L^{\frac{2q}{q-2},2}} \le C \|\nabla N\|_{L^{2}}^{1-\frac{3}{q}} \|\Delta N\|_{L^{2}}^{\frac{3}{q}}, \qquad q > 3.$$
(3.9)

$$\begin{split} I_4 &\leq \|n_2\|_{L^2} \|u\|_{L^6} \|\nabla N\|_{L^3} \leq C \|n_2\|_{L^2} \|\nabla u\|_{L^2} \|\nabla N\|_{L^2}^{\frac{1}{2}} \|\Delta N\|_{L^2}^{\frac{1}{2}} \quad (by(3.8)) \\ &\leq \frac{1}{8} \|\nabla u\|_{L^2}^2 + \frac{1}{8} \|\Delta N\|_{L^2}^2 + C \|n_2\|_{L^2}^4 \|\nabla N\|_{L^2}^2. \end{split}$$

Inserting the above estimates into (2.13), we get

$$\frac{1}{2} \frac{d}{dt} \int_{\Omega} |\nabla N|^2 dx + \frac{1}{2} \int_{\Omega} |\Delta N|^2 dx
\leq C \left(\|\nabla \varphi_1\|_{L^{15}}^{5/2} + \|n_2\|_{L^2}^4 + \|u_1\|_{L^{q,\infty}}^{\frac{2q}{q-3}} \right) \|\nabla N\|_{L^2}^2 + \frac{1}{8} \|\Delta P\|_{L^2}^2 + \frac{1}{8} \|\nabla u\|_{L^2}^2.$$
(3.10)

Similarly for the p-equation, we obtain

$$\frac{1}{2} \frac{d}{dt} \int_{\Omega} |\nabla P|^2 dx + \frac{1}{2} \int_{\Omega} |\Delta P|^2 dx
\leq C \left(\|\nabla \varphi_1\|_{L^{15}}^{5/2} + \|p_2\|_{L^2}^4 + \|u_1\|_{L^{q,\infty}}^{\frac{2q}{q-3}} \right) \|\nabla N\|_{L^2}^2 + \frac{1}{8} \|\Delta N\|_{L^2}^2 + \frac{1}{8} \|\nabla u\|_{L^2}^2.$$
(3.11)

As in section 2, we have (2.16).

Each term $J_i(i=1,2,3)$ can be bounded as follows:

$$\begin{aligned} J_{1} &\leq \varepsilon \|\nabla \varphi_{1}\|_{L^{15}} \|\Delta \varphi\|_{L^{2}} \|u\|_{L^{\frac{30}{13}}} \\ &\leq C \|\nabla \varphi_{1}\|_{L^{15}} \left(\|\Delta N\|_{L^{2}} + \|\Delta P\|_{L^{2}}\right) \|u\|_{L^{2}}^{\frac{4}{5}} \|\nabla u\|_{L^{2}}^{\frac{1}{5}} \quad (by(3.7)) \\ &\leq \frac{1}{8} \|\Delta N\|_{L^{2}}^{2} + \frac{1}{8} \|\Delta P\|_{L^{2}}^{2} + \frac{1}{8} \|\nabla u\|_{L^{2}}^{2} + C \|\nabla \varphi_{1}\|_{L^{15}}^{5/2} \|u\|_{L^{2}}^{2}, \end{aligned}$$

$$\begin{split} J_{2} &\leq \varepsilon \|\Delta\varphi_{2}\|_{L^{2}} \|\nabla\varphi\|_{L^{6}} \|u\|_{L^{3}} \\ &\leq C \|n_{2} + p_{2}\|_{L^{2}} (\|\Delta N\|_{L^{2}} + \|\Delta P\|_{L^{2}}) \|u\|_{L^{2}}^{\frac{1}{2}} \|\nabla u\|_{L^{2}}^{\frac{1}{2}} \quad (by(3.8)) \\ &\leq \frac{1}{8} \|\Delta N\|_{L^{2}}^{2} + \frac{1}{8} \|\Delta P\|_{L^{2}}^{2} + \frac{1}{8} \|\nabla u\|_{L^{2}}^{2} + C \|n_{2} + p_{2}\|_{L^{2}}^{4} \|u\|_{L^{2}}^{2}, \\ J_{3} &= \int_{\Omega} (u \cdot \nabla) u \cdot u_{2} dx \leq C \|u_{2}\|_{L^{q,\infty}} \|\nabla u\|_{L^{2}} \|u\|_{L^{\frac{2q}{q-2},2}}^{2} \quad (by(1.12)) \\ &\leq C \|u_{2}\|_{L^{q,\infty}} \|\nabla u\|_{L^{2}}^{1+\frac{3}{q}} \|u\|_{L^{2}}^{1-\frac{3}{q}} \quad (by(3.9)) \\ &\leq \frac{1}{8} \|\nabla u\|_{L^{2}}^{2} + C \|u_{2}\|_{L^{q,\infty}}^{\frac{2q}{q-3}} \|u\|_{L^{2}}^{2}. \end{split}$$

Substituting the above estimates into (2.16), we obtain

$$\frac{1}{2} \frac{d}{dt} \int_{\Omega} u^2 dx + \frac{5}{8} \int_{\Omega} |\nabla u|^2 dx \\
\leq \frac{1}{4} \|\Delta N\|_{L^2}^2 + \frac{1}{4} \|\Delta P\|_{L^2}^2 + C \left(\|\nabla \varphi_1\|_{L^{15}}^{5/2} + \|n_2 + p_2\|_{L^2}^4 + \|u_2\|_{L^{q,\infty}}^{\frac{2q}{q-3}} \right) \|u\|_{L^2}^2.$$
(3.12)

Adding up (3.10), (3.11), and (3.12), we arrive at

$$\frac{d}{dt}\int_{\Omega}|\nabla N|^2+|\nabla P|^2+|u|^2\mathrm{d} x\leq C(t)\int_{\Omega}|\nabla N|^2+|\nabla P|^2+|u|^2\mathrm{d} x$$

with some $C(t) \in L^1(0,T)$. Gronwall's inequality gives N = P = 0, u = 0 and hence $n = p = \varphi = 0$, which proves $u_1 = u_2, n_1 = n_2, p_1 = p_2, \varphi_1 = \varphi_2$.

The proof is completed.
