INFORMATION FOR AUTHORS

Manuscripts

Manuscripts for publication should be sent in duplicate to an appropriate Editor or Honorary Editorial Advisor for communication to the Journal, but may also be sent directly to the Journal of Differential Geometry, Lehigh University, Bethlehem, Pennsylvania 18015, U.S.A.

Manuscripts should be written in English, French, German or Italian, and should be typewritten, double spaced, with generous margins. Diagrams should be drawn with black India ink on glossy white paper.

To eliminate unnecessary delay or difficulties in printing authors may be guided by the article *Manual for authors of mathematical papers*, Bull. Amer. Math. Soc. **68** (1962) 429–444.

Footnotes, except a possible acknowledgement of assistance or financial support on the first page, should be avoided by being incorporated into the text, perhaps parenthetically.

The list of references must be in alphabetic-chronological order; abbreviations of names of journals and references to books should follow the standard form established by Mathematical Reviews. The following references are two typical examples:

Proofs

Authors receive only one set of proofs for corrections and will be responsible for the expense of making excessive alteration of the original manuscripts during the proof-reading.

Reprints

Each sole author receives 100 free reprints of his article with covers; joint authors receive 50 each. Additional reprints may be purchased at a reasonable cost.
