# EXTENSIONS OF DIFFUSION PROCESSES ON INTERVALS AND FELLER'S BOUNDARY CONDITIONS

#### Abstract

For a minimal diffusion process on $(a, b)$, any possible extension of it to a standard process on $[a, b]$ is characterized by the characteristic measures of excursions away from the boundary points $a$ and $b$. The generator of the extension is proved to be characterized by Feller's boundary condition.


## 1. Introduction

The generator of a minimal diffusion process on an interval $(a, b)$ can be characterized by the second order differential operator $\mathcal{L}=\mathcal{D}_{m} \mathcal{D}_{s}$ in Feller's canonical form, where $m$ and $s$ are strictly-increasing continuous functions on $(a, b)$. Feller ([4] and [6]) determined all possibilities of boundary conditions to make $\mathcal{L}$ a generator of some Feller semigroup, which we call Feller's boundary conditions. If the boundary points $a$ and $b$ are both accessible, Feller's boundary condition is of the form

where

\Phi_{a}(f)=p_{1} f(a)-p_{2} \mathcal{D}_{s} f(a)+p_{3} \mathcal{L} f(a)-p_{4}[f-f(a)] \tag{1.2}
\end{equation*}

and

\Phi_{b}(f)=q_{1} f(b)+q_{2} \mathcal{D}_{s} f(b)+q_{3} \mathcal{L} f(b)-q_{4}[f-f(b)] \tag{1.3}
\end{equation*}
$$

for some non-negative constants $p_{i}, q_{i}, i=1,2,3$ and some non-negative measures $p_{4}$ on $(a, b]$ and $q_{4}$ on $[a, b)$. Here, for a measure $\mu$ and an integrable function $f$, we write $\mu[f]=\int f \mathrm{~d} \mu$.

The purpose of this paper is to determine, for a given minimal diffusion process on $(a, b)$, all possibilities of its extensions to standard processes on $[a, b]$. For such an extension, we give the characteristic measure of excursions away from the boundary $\{a, b\}$, construct the process by piecing together excursions and prove that its $C_{b}$-generator is characterized by Feller's boundary condition.

[^0]If the boundaries are regular, Itô-McKean [11] constructed such a process by time change of the reflected process using its local time at the boundaries and an independent Poisson point process. Note that Hutzenthaler-Taylor [8] studied the time reversal property of such process and discussed applications to population genetics. If the boundaries are not regular, then the reflected process does not exist, so that the time change method is not valid. Itô [10] utilized excursion theory to construct such a process and determined the domain of its generator. Note that the resolvent formula which played the key role in [10] was generalized by Rogers [13]. The results of this paper complement the results of [10] and [13]. Note also that Fukushima [7] recently determined, by the help of the Dirichlet form theory, all possibilities of the extensions to symmetric diffusion processes for any minimal one-dimensinoal diffusion process possibly with killing inside $(a, b)$. Our objects exclude killing inside $(a, b)$, but are out of scope of [7] since they have jumps from the boundary so that they are not necessarily symmetric. For an invariance principle for such processes, see Yano [14].

For this purpose, we shall appeal to the excursion theory; the sample path which starts from $a$ up to the killing time or the first hitting time of $b$, whichever comes earlier, will be constructed from the stagnancy rate $p_{3}$ and the characteristic measure of excursions away from $a$ given as

n_{a}^{(b)}=p_{1} \delta_{\Delta}+p_{2} n_{a, \text { refl }}^{(b)}+\int_{(a, b]} p_{4}(\mathrm{~d} x) P_{x}^{\text {stop }}, \tag{1.4}
\end{equation*}
$$

where $\Delta$ stands for the excursion which stays at the cemetery for all time, $n_{a, \text { refl }}^{(b)}$ for the characteristic measure of excursions away from $a$ of the diffusion process reflected at $a$ and stopped at $b$, and $P_{x}^{\text {stop }}$ for the law of the $\mathcal{L}$-diffusion process started at $x$ and stopped at $a$ or $b$. The possible behaviors at $a$ of a generic sample path are as follows:
(i) it is killed (i.e., jumps to the cemetery) according to the rate $p_{1}$;
(ii) it enters the interior $(a, b)$ continuously according to the rate $p_{2}$;
(iii) it stagnates at $a$ according to the rate $p_{3}$;
(iv) it jumps into an interior point $x$ of ( $a, b$ ] picked accordingly to the rate $p_{4}(\mathrm{~d} x)$.

We may carry out the same construction of the sample path which starts from $b$ as that from $a$, where $p_{i}$ 's are replaced by $q_{i}$ 's. We shall prove that the $C_{b}$-generator of the process constructed in such a way as above is characterized by Feller's boundary conditions (1.1).

This paper is organized as follows. In Section 2, we introduce several notations from the theory of excursions and state our main theorems. We give a very general formula about the resolvents and give theorems about $C_{b}$-generators. In Section 3, we prove the resolvent formula. In Section 4, we study several properties of the resolvent operator of the minimal diffusion process. Section 5 is devoted to the proofs of the theorems of $C_{b}$-generators.

## 2. Notations and main theorems

2.1. Excursions and resolvents. Let $\Delta$ denote an isolated point attached to $[-\infty, \infty]$ and we call $\Delta$ the cemetery. For any function $f$ defined on a subinterval of $[-\infty, \infty]$, we always extend $f$ so that $f(\Delta)=0$. Let $W$ denote the space consisting of all càdlàg functions $w:[0, \infty) \rightarrow[-\infty, \infty] \cup\{\Delta\}$ such that, for some $0 \leq T_{\Delta} \leq \infty$, $w(t) \in[-\infty, \infty]$ for all $0 \leq t<T_{\Delta}$ and $w(t)=\Delta$ for all $t \geq T_{\Delta}$. We equip $W$ with the $\sigma$-field generated by the cylinder sets. We denote the coordinate process of $W$ by $(X(t))_{t \geq 0}=\left(X_{t}\right)_{t \geq 0}$ :

We denote the first hitting time of $x \in[-\infty, \infty] \cup\{\Delta\}$ by

T_{x}=T_{x}(X)=\inf \left\{t>0: X_{t}=x\right\} \tag{2.2}
\end{equation*}
$$

and the first exit time of $x \in[-\infty, \infty]$ by

$$
\begin{equation*}
\tau_{x}=\tau_{x}(X)=\inf \left\{t>0: X_{t} \neq x\right\} . \tag{2.3}
\end{equation*}
$$

Here we adopt the usual convention that $\inf \emptyset=\infty$.
Let $a \in[-\infty, \infty]$. We write $E(a)$ for the set of all $e \in W$ such that $e(t)$ is constant for all $t \geq T_{a} \wedge T_{\Delta}$, where $s \wedge t=\min \{s, t\}$. Each element $e$ of $E(a)$ is called an excursion away from $a$. We utilize the theory of excursions away from $a$; see, e.g., [2, Chapter III] and [1, Chapter IV]. Let $I$ be a subinterval of $[-\infty, \infty]$ and let $\left\{\left(X_{t}\right)_{t \geq 0},\left(P_{x}\right)_{x \in I}\right\}$ be a standard process on $I$, i.e., a strong Markov process such that $X_{t} \in I$ for all $t<T_{\Delta}$ a.s. with respect to $P_{x}$ for $x \in I$, and such that its sample paths are right-continuous and quasi-left-continuous up to $T_{\Delta}$; see, e.g., [3]. Suppose that $a \in I$. We write $P_{x}^{(a)}$ for the law under $P_{x}$ of the stopped process $\left(X_{t}^{(a)}\right)_{t \geq 0}$ defined as

X_{t}^{(a)}= \begin{cases}X_{t} & \text { if } t<T_{a},  \tag{2.4}\\ a & \text { if } t \geq T_{a} .\end{cases}
$$

For the process $\left\{\left(X_{t}\right)_{t \geq 0}, P_{a}\right\}$, we would like to obtain a positive additive functional $\left(L_{a}(t)\right)_{t \geq 0}$ which increases only when the process stays at $a$, and a non-negative constant $\zeta_{a}$ called the stagnancy rate. The following three cases are only possible:
(i) Suppose that $a$ is regular-for-itself, i.e., $P_{a}\left(T_{a}=0\right)=1$, and also that $a$ is instantaneous, i.e., $P_{a}\left(\tau_{a}=0\right)=1$. Let $L_{a}(t)$ be a choice of the local time at $a$ up to time $t$. Then there exists a constant $\zeta_{a} \geq 0$ such that

\int_{0}^{t} 1_{\left\{X_{s}=a\right\}} \mathrm{d} s=\varsigma_{a} L_{a}(t) \tag{2.5}
\end{equation*}
$$

(ii) Suppose that $a$ is regular-for-itself but not instantaneous. Then $a$ is holding, i.e., $P_{x}\left(\tau_{a}>0\right)=1$. Let $\zeta_{a}>0$ be a fixed constant and set

L_{a}(t)=\frac{1}{\varsigma_{a}} \int_{0}^{t} 1_{\left\{X_{s}=a\right\}} \mathrm{d} s \tag{2.6}
\end{equation*}
$$

(iii) Suppose that $a$ is irregular-for-itself. Then we have $P_{a}\left(T_{a}>0\right)=1$. Then the set $\left\{t>0: X_{t}=a\right\}$ is locally finite so that can be enumerated as $\left\{\tau_{1}<\tau_{2}<\cdots\right\}$. Extending the probability space, we let $\left\{e_{n}\right\}_{n=0}^{\infty}$ be a sequence of independent standard exponential variables which is independent of $\left(X_{t}\right)_{t \geq 0}$. We now define

L_{a}(t)=e_{0}+\sum_{n=1}^{\infty} e_{n} 1_{\left\{\tau_{n} \leq t\right\}} \tag{2.7}
\end{equation*}
$$

and define $\zeta_{a}=0$.
Let $\eta_{a}(l)=\inf \left\{t>0: L_{a}(t)>l\right\}$. Then, in any one of the above three cases (i)-(iii), the process $\left(\eta_{a}(l)\right)_{l \geq 0}$ is a subordinator which explodes at $L_{a}(\infty)$. We define a point process $\left(p_{a}(l)\right)_{l \in D_{a}}$ taking values in $E(a)$ as

p_{a}(l)(t)=\left\{\begin{array}{lll}
X\left(t+\eta_{a}(l-)\right) & \text { if } \quad 0 \leq t<\eta_{a}(l)-\eta_{a}(l-),  \tag{2.8}\\
X\left(\eta_{a}(l)\right) & \text { if } \quad t \geq \eta_{a}(l)-\eta_{a}(l-)
\end{array}\right.
$$

for all $l$ belonging to the domain $D_{a}=\left\{l: \eta_{a}(l-)<\eta_{a}(l)\right\}$. We see that $\left(p_{a}(l)\right)_{l \in D_{a}}$ is a stationary Poisson point process stopped at $L_{a}(\infty)$, so that it is called the excursion point process. Its characteristic measure will be denoted by $n_{a}$ and called the characteristic measure of excursions away from $a$. The process $\left(\eta_{a}(l)\right)_{l \geq 0}$ can be recovered from the excursion point process as

\eta_{a}(l)=\varsigma_{a} l+\sum_{s \leq l} T_{a}\left(p_{a}(s)\right) . \tag{2.9}
\end{equation*}
$$

By (2.9), we have $P_{a}\left[\mathrm{e}^{-r \eta_{a}(l)}\right]=\mathrm{e}^{-l \psi_{a}(r)}$, where

\psi_{a}(r)=\varsigma_{a} r+n_{a}\left[1-\mathrm{e}^{-r T_{a}}\right] . \tag{2.10}
\end{equation*}
$$

Since $P_{a}\left(\eta_{a}(l)<\infty\right)>0$, we obtain

$$
\begin{equation*}
n_{a}\left[1-\mathrm{e}^{-T_{a}}\right]<\infty, \tag{2.11}
\end{equation*}
$$

and, in particular, $n_{a}$ is $\sigma$-finite. If $a$ is regular-for-itself, the process $\eta_{a}(l)$ is strictly increasing until it explodes, so that we have

\varsigma_{a}>0 \quad \text { or } \quad\left[n_{a}\left(T_{a}<t\right)=\infty \text { for all } t>0\right] . \tag{2.12}
\end{equation*}
$$

We know that the strong Markov property holds in the following sense: for any stopping time $T$, any constant time $t$ and any non-negative Borel functions $f$ and $g$, one has

n_{a}\left[f\left(X_{T}\right) g\left(X_{T+t}\right)\right]=n_{a}\left[f\left(X_{T}\right) P_{X_{T}}^{(a)}\left[g\left(X_{t}\right)\right]\right] . \tag{2.13}
\end{equation*}

If we write

k_{a}=n_{a}(\{\Delta\}), \quad v_{a}(\cdot)=n_{a}\left(\cdot ; X_{0}=a\right), \quad j_{a}(\cdot)=n_{a}\left(X_{0} \in \cdot ; X_{0} \neq a\right), \tag{2.14}
\end{equation*}
$$

then $n_{a}$ may be represented as

$$
\begin{equation*}
n_{a}=k_{a} \delta_{\Delta}+v_{a}+\int_{I \backslash\{a\}} j_{a}(\mathrm{~d} x) P_{x}^{(a)} . \tag{2.15}
\end{equation*}
$$

The quantities $k_{a}, v_{a}$ and $j_{a}$ are called the killing rate, the characteristic measure of excursions of continuous entrance, and the jumping-in measure, respectively.

REmARK 2.1. Suppose that $0<n_{a}\left(X_{0}=a\right)<\infty$. Then the first index $\lambda$ such that $p_{a}(\lambda)(0)=a$ is positive and finite a.s., so that $\eta_{a}(\lambda)$ is a finite stopping time such that $X\left(\eta_{a}(\lambda)\right)=a$. Hence it follows that $a$ may not be regular-for-itself and that $n_{a}=$ $\nu_{a}=P_{a}^{(a)}$.

Let $\mathcal{B}_{b}(I)$ or simply $\mathcal{B}_{b}$ denote the set of all bounded Borel functions on $I$. Let us study the resolvent operator:

Let $b \in I \backslash\{a\}$ be fixed and write

T_{a, b}=T_{a} \wedge T_{b}=\inf \left\{t>0: X_{t} \in\{a, b\}\right\} \tag{2.17}
\end{equation*}
$$

Let $\varsigma_{a}^{(b)}$ and $n_{a}^{(b)}$ be the stagnancy rate and the characteristic measure of excursions away from $a$ for the process $\left\{\left(X_{t}^{(b)}\right)_{t \geq 0}, P_{a}\right\}$ starting from $a$ and stopped at $b$. For $r>0$, we define

\psi_{a}^{(b)}(r)=s_{a}^{(b)} r+n_{a}^{(b)}\left[1-\mathrm{e}^{-r T_{a}}\right] \tag{2.18}
\end{equation*}
$$

and, for $r>0$ and $g \in \mathcal{B}_{b}$, we define

N_{a, r}^{(b)}(g)=\varsigma_{a}^{(b)} g(a)+n_{a}^{(b)}\left[\int_{0}^{T_{a, b}} \mathrm{e}^{-r t} g\left(X_{t}\right) \mathrm{d} t\right] \tag{2.19}
\end{equation*}

The following resolvent formula will play a key role:

Theorem 2.2. One has

$$
\begin{equation*}
\psi_{a}^{(b)}(r) R_{r} g(a)=N_{a, r}^{(b)}(g)+n_{a}^{(b)}\left[\mathrm{e}^{-r T_{b}} ; T_{b}<\infty\right] R_{r} g(b) \tag{2.20}
\end{equation*}
$$

Theorem 2.2 will be proved in Section 3. We remark that Theorem 2.2 contains Theorem 5.3 of Itô [10] and Theorem 1 of Rogers [13] as special cases where $b$ is not accessible.

Before closing this subsection, we introduce another notation. Recall that the resolvent operator is defined in (2.16). It is easy to see that the resolvent equation

holds. Let $C_{b}(I)$ or simply $C_{b}$ denote the set of all bounded continuous functions on $I$. If $g \in C_{b}$, we see, by the dominated convergence theorem, that $r R_{r} g(x)$ converges to $g(x)$ as $r \rightarrow \infty$ for all $x \in I$. Hence we see that the range $R_{r}\left(C_{b}\right)$ does not depend on $r>0$ and that $R_{r}: C_{b} \rightarrow R_{r}\left(C_{b}\right)$ is injective. Now we define the operator $\mathcal{G}$ as

D(\mathcal{G})=R_{r}\left(C_{b}\right),  \tag{2.22}\\
\mathcal{G} f=r f-R_{r}^{-1} f \quad \text { for } \quad f \in D(\mathcal{G}),
\end{array}\right.
$$

which turns out to be independent of the choice of $r>0$. We call $\mathcal{G}$ the $C_{b}(I)$ generator or simply the $C_{b}$-generator.
2.2. Feller's boundary classification. Let us prepare several notations of Feller's characteristics of one-dimensional diffusions.

Let $(a, b)$ be a subinterval of $[-\infty, \infty]$. Let $m$ and $s$ be strictly-increasing continuous functions on $(a, b)$ with values in $[-\infty, \infty]$. We extend such functions so that $m(a)=m(a+), m(b)=m(b-), s(a)=s(a+)$ and $s(b)=s(b-)$. For $a \leq x<y \leq b$, we write $m(x, y)=m(y)-m(x)$ and $s(x, y)=s(y)-s(x)$.

We adopt Feller's classification of boundaries taken from [4] and [5] as follows. Let $c \in(a, b)$. We use the following terminology ${ }^{1}$ :

a \text { is called accessible if } \int_{a}^{c} \mathrm{~d} s(x) \int_{x}^{c} \mathrm{~d} m(y)<\infty  \tag{2.23}\\
a \text { is called enterable if } \int_{a}^{c} \mathrm{~d} m(x) \int_{x}^{c} \mathrm{~d} s(y)<\infty
\end{array}\right.
$$

where we write $\int_{c_{1}}^{c_{2}}$ for $\int_{\left(c_{1}, c_{2}\right]}$ if $c_{1} \leq c_{2}$ and for $-\int_{\left(c_{2}, c_{1}\right]}$ if $c_{1}>c_{2}$. These classifications

[^1]do not depend on the particular choice of $c \in(a, b)$. We also use the following terminology ${ }^{2}$ :

a \text { is called regular if it is both accessible and enterable, }  \tag{2.24}\\
a \text { is called exit if it is accessible but not enterable, } \\
a \text { is called entrance if it is enterable but not accessible, } \\
a \text { is called natural if it is neither accessible nor enterable. }
\end{array}
$$\right.
\]

The same classification is made for the boundary $b$ by switching the roles between $a$ and $b$.
2.3. Minimal one-dimensional diffusion processes. We call $\left\{\left(X_{t}\right)_{t \geq 0},\left(P_{x}^{0}\right)_{x \in(a, b)}\right\}$ a minimal diffusion process if it is a standard process on $(a, b)$ such that the following conditions hold $P_{x}$-a.s. for all $x \in(a, b)$ :
(i) $t \mapsto X_{t}$ is continuous in $t<T_{\Delta}$;
(ii) $X_{t} \in(a, b)$ for all $t<T_{\Delta}$;
(iii) $X_{t} \rightarrow a$ or $X_{t} \rightarrow b$ as $t \rightarrow T_{\Delta}-$.

In addition, we assume the following condition:

P_{x}\left(T_{y}<\infty\right)>0 \quad \text { for all } \quad x, y \in(a, b) \tag{2.25}
\end{equation*}

We denote its resolvent by

R_{r}^{0} g(x)=P_{x}^{0}\left[\int_{0}^{\infty} \mathrm{e}^{-r t} g\left(X_{t}\right) \mathrm{d} t\right] \quad \text { for } \quad g \in \mathcal{B}_{b}((a, b)), \quad r>0 \quad \text { and } \quad x \in(a, b) \tag{2.26}
\end{equation*}

It is well-known that there exist some strictly-increasing continuous functions $m$ and $s$ such that

P_{x}^{0}\left(T_{a^{\prime}}>T_{b^{\prime}}\right)=\frac{s\left(a^{\prime}, x\right)}{s\left(a^{\prime}, b^{\prime}\right)} \quad \text { for all } \quad a<a^{\prime}<x<b^{\prime}<b \tag{2.27}
\end{equation*}
$$

and

$$
\begin{equation*}
P_{x}^{0}\left[T_{a^{\prime}} \wedge T_{b^{\prime}}\right]=\int_{\left(a^{\prime}, b^{\prime}\right)} K_{a^{\prime}, b^{\prime}}(x, y) \mathrm{d} m(y) \quad \text { for all } \quad a<a^{\prime}<x<b^{\prime}<b, \tag{2.28}
\end{equation*}
$$

where

$$
\begin{equation*}
K_{a^{\prime}, b^{\prime}}(x, y)=K_{a^{\prime}, b^{\prime}}(y, x)=\frac{s\left(a^{\prime}, x\right) s\left(y, b^{\prime}\right)}{s\left(a^{\prime}, b^{\prime}\right)} \quad \text { for all } \quad a^{\prime} \leq x \leq y \leq b^{\prime} \tag{2.29}
\end{equation*}
$$

[^2]The functions $m$ and $s$ will be called the speed measure and the canonical scale, respectively. We write $D\left(\mathcal{D}_{s}\right)$ for the set of measurable functions $f$ on $[a, b]$ such that $f(x)-f(y)=\int_{x}^{y} g(z) \mathrm{d} s(z)$ for all $x, y \in(a, b)$ for some locally $s$-integrable function $g$, and in this case, we write $\mathcal{D}_{s} f=g$. We write $D(\mathcal{L})$ for the set of measurable functions $f$ on $[a, b]$ such that $f \in D\left(\mathcal{D}_{s}\right)$ and $\mathcal{D}_{s} f(x)-\mathcal{D}_{s} f(y)=\int_{x}^{y} g(z) \mathrm{d} m(z)$ for all $x, y \in(a, b)$ for some locally $m$-integrable function $g$, and in this case, we write $\mathcal{L} f=\mathcal{D}_{m} \mathcal{D}_{s} f=g$. For $f \in D(\mathcal{L})$, we say that $\mathcal{L} f \in C_{b}([a, b))$ if $\mathcal{L} f(a+)$ exists, and in this case we write $\mathcal{L} f(a)=\mathcal{L} f(a+)$. We will use the following property for the resolvent $\left(R_{r}^{0}\right)_{r>0}$.

Proposition 2.3. For all $g \in \mathcal{B}_{b}((a, b))$ and $r>0$, it follows that

R_{r}^{0} g \in D(\mathcal{L}) \quad \text { and } \quad \mathcal{L} R_{r}^{0} g=r R_{r}^{0} g-g \tag{2.30}

and that $f=R_{r}^{0} g$ satisfies the following:
(i) $f(a+)=0$, if $a$ is accessible;
(ii) $f(a+)=u_{r}(a) \int_{a}^{b-} g(x) v_{r}(x) \mathrm{d} m(x)$ and $\mathcal{D}_{s} f(a+)=0$, if $a$ is entrance;
(iii) $f(a+)=g(a+) / r$, if $a$ is natural and the limit $g(a+)$ exists.

For the proof of Proposition 2.3, see, e.g., [9, Theorem 62.1]. We note that, when $a$ is entrance, $r \int_{a}^{b-} v_{r}(x) \mathrm{d} m(x)=\mathcal{D}_{s} v_{r}(b)-\mathcal{D}_{s} v_{r}(a)<\infty$.

For $x=a$ and $b$, let $\gamma(x)=1$ if $x$ is accessible and $\gamma(x)=0$ otherwise. The $C_{b}((a, b))$-generator $\mathcal{G}^{0}$ of the minimal diffusion process can be characterized as follows.

Theorem 2.4. The $C_{b}((a, b))$-generator $\mathcal{G}^{0}$ of the resolvent $\left(R_{r}^{0}\right)_{r>0}$ is given as

\begin{equation*}
D\left(\mathcal{G}^{0}\right)=\left\{f \in D(\mathcal{L}): f, \mathcal{L} f \in C_{b}((a, b)), \gamma(a) f(a+)=\gamma(b) f(b-)=0\right\} \tag{2.31}
\end{equation*}
$$

and

$$
\begin{equation*}
\mathcal{G}^{0} f(x)=\mathcal{L} f(x) \quad \text { for } \quad f \in D\left(\mathcal{G}^{0}\right) \quad \text { and } \quad x \in(a, b) \tag{2.32}
\end{equation*}
$$

Theorem 2.4 is well-known, so that we omit the proof.
2.4. Extensions of the minimal process. Let $\left\{\left(X_{t}\right)_{t \geq 0},\left(P_{x}^{0}\right)_{x \in(a, b)}\right\}$ be a minimal diffusion process and let $m$ and $s$ be the corresponding speed measure and the canonical scale, respectively. Let $I=[a, b)$ or $[a, b]$ and let $\left\{\left(X_{t}\right)_{t \geq 0},\left(P_{x}\right)_{x \in I}\right\}$ be an extension to a standard process of the minimal process $\left\{\left(X_{t}\right)_{t \geq 0},\left(P_{x}^{0}\right)_{x \in(a, b)}\right\}$, i.e., the killed process $\left(X_{t}^{0}\right)_{t \geq 0}$ defined by

X_{t}^{0}= \begin{cases}X_{t} & \text { if } \quad 0 \leq t<T_{a} \wedge T_{b},  \tag{2.33}\\ \Delta & \text { if } \quad t \geq T_{a} \wedge T_{b}\end{cases}
$$

considered under $P_{x}$ has the law $P_{x}^{0}$ for all $x \in(a, b)$. We have essentially the following four cases:
$1^{\circ}$ ). $I=[a, b), a$ is accessible and $b$ is not;
$2^{\circ}$ ). $I=[a, b], a$ is accessible, and $b$ is not;
$\left.3^{\circ}\right) . I=[a, b]$, and neither $a$ nor $b$ is accessible;
$4^{\circ}$ ). $I=[a, b]$, and both $a$ and $b$ are accessible.
In each case, we would like to characterize the $C_{b}(I)$-generator of the extension.
As we will discuss the case of $4^{\circ}$ ) after a while, let us assume that $a$ is accessible. For the stopped process $\left\{\left(X_{t}^{(b)}\right)_{t \geq 0}, P_{a}\right\}$, we let $\zeta_{a}^{(b)}$ and $n_{a}^{(b)}$ be the stagnancy rate and the characteristic measure of excursions away from $a$. Let $\varsigma_{b}^{(a)}$ and $n_{b}^{(a)}$ be their counterparts for the stopped process $\left\{\left(X_{t}^{(a)}\right)_{t \geq 0}, P_{b}\right\}$.

If $a$ is regular, then there exists, uniquely in the sense of law, a conservative diffusion process on $[a, b]$ which is stopped at $b$ and whose stagnancy rate at $a$ is zero. This process will be called the reflected process at $a$. We denote by $n_{a, \text { refl }}^{(b)}$ the characteristic measure of excursions away from $a$ which is normalized so that

$$
\begin{equation*}
n_{a, \text { refl }}^{(b)}\left(T_{x}<\infty\right)=\frac{1}{s(a, x)} \quad \text { for } \quad x \in(a, b) \tag{2.34}
\end{equation*}
$$

We do not define $n_{a, \text { refl }}^{(b)}$ if $a$ is exit.
Applying the decomposition (2.15) of the excursion measure to the stopped process $\left\{\left(X_{t}^{(b)}\right)_{t \geq 0}, P_{a}\right\}$, we have

\begin{equation*}
n_{a}^{(b)}=p_{1} \delta_{\Delta}+p_{2} n_{a, \text { refl }}^{(b)}+\int_{(a, b]} p_{4}(\mathrm{~d} x) P_{x}^{\text {stop }} \tag{2.35}
\end{equation*}
$$

for some non-negative constants $p_{1}$ and $p_{2}$ and some non-negative measure $p_{4}$; in fact, we have the representation (2.15) so that $v_{a}$ should be proportional to $n_{a, \text { refl }}^{(b)}$ if $a$ is regular. We let

$$
\begin{equation*}
p_{3}=\varsigma_{a}^{(b)} \tag{2.36}
\end{equation*}
$$

If $a$ is exit, $v_{a}$ should be zero, so that we let $p_{2}=0$ and discard the term $p_{2} n_{a, \text { reff }}^{(b)}$. By the conditions (2.11) and (2.12), the coefficients must satisfy the conditions:

$$
\begin{equation*}
\int_{(a, b]} p_{4}(\mathrm{~d} x) P_{x}^{\mathrm{stop}}\left[1-\mathrm{e}^{-T_{a}}\right]<\infty \tag{2.37}
\end{equation*}
$$

and

$$
\begin{equation*}
p_{2}+p_{3}>0 \quad \text { or } \quad\left[p_{4}((a, a+\varepsilon))=\infty \text { for all } \varepsilon>0\right] . \tag{2.38}
\end{equation*}
$$

REMARK 2.5. The condition (2.37) is equivalent to the following condition:
(i) $\int_{a}^{a+\varepsilon} p_{4}(\mathrm{~d} x) s(a, x)<\infty$ for some $\varepsilon>0$ if $a$ is regular;
(ii) $\int_{a}^{a+\varepsilon} p_{4}(\mathrm{~d} x) \int_{a}^{x} m(y, c) \mathrm{d} s(y)<\infty$ for some $\varepsilon>0$ if $a$ is exit.

REMARK 2.6. The behavior at $a$ of the process $\left\{\left(X_{t}\right)_{t \geq 0},\left(P_{x}\right)_{x \in[a, b]}\right\}$ is as follows: (i) $a$ is regular-for-itself and instantaneous if either one of the following holds:
(i-1) $a$ is regular and either $p_{2}>0$ or $p_{4}((a, a+\varepsilon))=\infty$ for all $\varepsilon>0$;
(i-2) $a$ is exit and $p_{4}(a, a+\varepsilon)=\infty$ for all $\varepsilon>0$;
(ii) $a$ is regular-for-itself but not instantaneous if either one of the following holds:
(ii-1) $a$ is regular, $p_{2}=0$ and $p_{4}((a, a+\varepsilon))<\infty$ for some $\varepsilon>0$;
(ii-2) $a$ is exit and $p_{4}((a, a+\varepsilon))<\infty$ for some $\varepsilon>0$.
We state our main theorems which determine the $C_{b}$-generator of all possible extensions. The proofs will be given in Section 5.
$1^{\circ}$ ). Suppose that $I=[a, b), a$ is accessible and $b$ is not. The following theorem generalizes Theorem 5.3 of Itô [10].

Theorem 2.7. Let $p_{1}, p_{2}, p_{3}$ and $p_{4}$ be as introduced in (2.35) and (2.36). Then the $C_{b}([a, b))$-generator $\mathcal{G}$ is such that its domain is given as

\begin{equation*}
D(\mathcal{G})=\left\{f \in D(\mathcal{L}): f, \mathcal{L} f \in C_{b}([a, b)) \text { and } \Phi_{a}(f)=0\right\} \tag{2.39}
\end{equation*}
$$

where $\Phi_{a}$ has been defined in (1.2), and it satisfies

$$
\begin{equation*}
\mathcal{G} f(x)=\mathcal{L} f(x) \quad \text { for } \quad f \in D(\mathcal{G}) \quad \text { and } \quad x \in[a, b) \tag{2.40}
\end{equation*}
$$

REMARK 2.8. If, in addition, $b$ is entrance, then one has, for any $f \in D(\mathcal{G})$,

\mathcal{D}_{s} f(b-)=0 . \tag{2.41}
\end{equation*}
$$

This remark holds true also in any other case below.
$2^{\circ}$ ). Suppose that $I=[a, b], a$ is accessible and that $b$ is not. If $b$ is entrance and irregular-for-itself, then we have

q_{3}:=\varsigma_{b}^{(a)}>0 \quad \text { and } \quad n_{b}^{(a)}=q_{1} \delta_{\{\Delta\}}+\int_{[a, b)} q_{4}(\mathrm{~d} x) P_{x}^{\text {stop }} \tag{2.43}
\end{equation*}
$$

for some non-negative constant $q_{1}$ and some non-negative finite measure $q_{4}$ on $[a, b)$, and we put $q_{2}=0$ for convenience.

Theorem 2.9. Let $p_{1}, p_{2}, p_{3}$ and $p_{4}$ be as introduced in (2.35) and (2.36). Let $q_{1}, q_{2}, q_{3}$ and $q_{4}$ be as above. Then the domain of the $C_{b}([a, b])$-generator $\mathcal{G}$ is given as follows: if $b$ is entrance and irregular-for-itself, then

$$
\begin{equation*}
D(\mathcal{G})=\left\{f \in D(\mathcal{L}): f, \mathcal{L} f \in C_{b}([a, b]), \Phi_{a}(f)=p_{4}(\{b\}) f(b)\right\} ; \tag{2.44}
\end{equation*}
$$

if $b$ is natural or (entrance and regular-for-itself), then
(2.45) $D(\mathcal{G})=\left\{f \in D(\mathcal{L}): f, \mathcal{L} f \in C_{b}([a, b]), \Phi_{a}(f)=p_{4}(\{b\}) f(b), \Phi_{b}(f)=0\right\}$,
where $\Phi_{b}$ has been defined in (1.3). In both cases, one has, for any $f \in D(\mathcal{G})$,

\begin{equation*}
\mathcal{G} f(x)=\mathcal{L} f(x) \quad \text { for } \quad x \in[a, b] . \tag{2.46}
\end{equation*}
$$

$3^{\circ}$ ). Suppose that $I=[a, b]$ and neither $a$ nor $b$ is accessible. We only state a special case; the necessary modifications in the other cases are obvious. Let us assume that $a$ is natural and that $b$ is entrance and irregular-for-itself. For the stopped process $\left\{\left(X_{t}^{(b)}\right)_{t \geq 0}, P_{a}\right\}$, we have

\begin{equation*}
p_{3}:=\varsigma_{a}^{(b)}>0 \quad \text { and } \quad n_{a}^{(b)}=p_{1} \delta_{\{\Delta\}}+\int_{(a, b]} p_{4}(\mathrm{~d} x) P_{x}^{\text {stop }} \tag{2.47}
\end{equation*}
$$

for some non-negative constant $p_{1}$ and some non-negative finite measure $p_{4}$ on $(a, b]$, and we put $p_{2}=0$ for convenience. For the stopped process $\left\{\left(X_{t}^{(a)}\right)_{t \geq 0}, P_{b}\right\}$, we have

$$
\begin{equation*}
\varsigma_{b}^{(a)}=0 \quad \text { and } \quad n_{b}^{(a)}=P_{b}^{\text {stop }} \tag{2.48}
\end{equation*}
$$

Theorem 2.10. Let $p_{1}, p_{2}, p_{3}$ and $p_{4}$ be as above. Then the $C_{b}([a, b])$-generator $\mathcal{G}$ is such that its domain is given as

$$
\begin{equation*}
D(\mathcal{G})=\left\{f \in D(\mathcal{L}): f, \mathcal{L} f \in C_{b}([a, b]), \Phi_{a}(f)=p_{4}(\{b\}) f(b)\right\} . \tag{2.49}
\end{equation*}
$$

For any $f \in D(\mathcal{G})$, one has

$$
\begin{equation*}
\mathcal{G} f(x)=\mathcal{L} f(x) \quad \text { for } \quad x \in[a, b] . \tag{2.50}
\end{equation*}
$$

$4^{\circ}$ ). Suppose that $I=[a, b]$ and both $a$ and $b$ are accessible. For the stopped process $\left\{\left(X_{t}^{(a)}\right)_{t \geq 0}, P_{b}\right\}$, we have

$$
\begin{equation*}
n_{b}^{(a)}=q_{1} \delta_{\Delta}+q_{2} n_{b, \text { refl }}^{(a)}+\int_{[a, b)} q_{4}(\mathrm{~d} x) P_{x}^{\text {stop }} \tag{2.51}
\end{equation*}
$$

for some non-negative constants $q_{1}$ and $q_{2}$ and some non-negative measure $q_{4}$ on $[a, b)$ such that,

$$
\begin{equation*}
\int_{[a, b)} q_{4}(\mathrm{~d} x) P_{x}^{\mathrm{stop}}\left[1-\mathrm{e}^{-T_{a}}\right]<\infty \tag{2.52}
\end{equation*}
$$

and, for $q_{3}:=\varsigma_{b}^{(a)}$,

$$
\begin{equation*}
q_{2}+q_{3}>0 \quad \text { or } \quad\left[q_{4}((b-\varepsilon, b))=\infty \text { for all } \varepsilon>0\right] . \tag{2.53}
\end{equation*}
$$

Theorem 2.11. Let $p_{1}, p_{2}, p_{3}$ and $p_{4}$ be as introduced in (2.35) and (2.36). Let $q_{1}, q_{2}, q_{3}$ and $q_{4}$ be as above. Then the $C_{b}([a, b])$-generator $\mathcal{G}$ is such that its domain is given as

$$
\begin{equation*}
D(\mathcal{G})=\left\{f \in D(\mathcal{L}): f, \mathcal{L} f \in C_{b}([a, b]) \text { and } \Phi_{a}(f)=\Phi_{b}(f)=0\right\} \tag{2.54}
\end{equation*}
$$

and it satisfies

$$
\begin{equation*}
\mathcal{G} f(x)=\mathcal{L} f(x) \quad \text { for } \quad f \in D(\mathcal{G}) \quad \text { and } \quad x \in[a, b] \tag{2.55}
\end{equation*}
$$

## 3. The resolvent formula

Let $\left\{\left(X_{t}\right)_{t \geq 0},\left(P_{x}\right)_{x \in[a, b]}\right\}$ be a standard process and follow the notations in Subsection 2.1. We utilize the following lemma:

Lemma 3.1. For any $r>0$, one has

\int_{0}^{\eta_{a}(l)} \mathrm{e}^{-r t} 1_{\{X(t)=a\}} \mathrm{d} t=\varsigma_{a} \int_{0}^{l} \mathrm{e}^{-r \eta_{a}(s)} \mathrm{d} s \quad \text { for all } \quad l \geq 0, P_{a}-a . s . \tag{3.1}
\end{equation*}
$$

Proof. Take a sample point from a set of full probability. Note that

\int_{0}^{\eta_{a}(l)} 1_{\{X(t)=a\}} \mathrm{d} t=\eta_{a}(l)-\sum_{s \leq l}\left\{\eta_{a}(s)-\eta_{a}(s-)\right\}=\varsigma_{a} l . \tag{3.2}
\end{equation*}
$$

Let $\varepsilon>0$. Then we have

\int_{\eta_{a}(l)}^{\eta_{a}(l+\varepsilon)} \mathrm{e}^{-r t} 1_{\{X(t)=a\}} \mathrm{d} t \leq \mathrm{e}^{-r \eta_{a}(l)} \int_{\eta_{a}(l)}^{\eta_{a}(l+\varepsilon)} 1_{\{X(t)=a\}} \mathrm{d} t=\mathrm{e}^{-r \eta_{a}(l)} \varsigma_{a} \varepsilon \tag{3.3}
\end{equation*}
$$

and

$$
\begin{equation*}
\int_{\eta_{a}(l)}^{\eta_{a}(l+\varepsilon)} \mathrm{e}^{-r t} 1_{\{X(t)=a\}} \mathrm{d} t \geq \mathrm{e}^{-r \eta_{a}(l+\varepsilon)} \int_{\eta_{a}(l)}^{\eta_{a}(l+\varepsilon)} 1_{\{X(t)=a\}} \mathrm{d} t=\mathrm{e}^{-r \eta_{a}(l+\varepsilon)} \varsigma_{a} \varepsilon . \tag{3.4}
\end{equation*}
$$

By (3.3), we see that the function $F(l)=\int_{0}^{\eta_{a}(l)} \mathrm{e}^{-r t} 1_{\{X(t)=a\}} \mathrm{d} t$ is absolutely continuous, so that there exists a locally integrable function $f(l)$ such that $F(l)=\int_{0}^{l} f(s) \mathrm{d} s$. By (3.3) and (3.4), we have the right-derivative of $F(l)$ is equal to $\zeta_{a} \mathrm{e}^{-r \eta_{a}(l)}$. Hence we obtain $f(l)=\zeta_{a} \mathrm{e}^{-r \eta_{a}(l)}$ for almost every $l \geq 0$. The proof is now complete.

For the proof of Theorem 2.2, we prove three more lemmas in what follows.
Let us construct a sample path of the process $\left\{\left(X_{t}\right)_{t \geq 0}, P_{a}\right\}$. Let $\left(p_{a}^{(b)}(l)\right)_{l \in D_{a}^{(b)}}$ be a Poisson point process with characteristic measure $n_{a}^{(b)}$ and let $\left(X_{b}(t)\right)_{t \geq 0}$ be a process
with law $P_{b}$. We assume that $\left(p_{a}^{(b)}(l)\right)_{l \geq 0}$ and $\left(X_{b}(t)\right)_{t \geq 0}$ are independent. We define the subordinator $\left(\eta_{a}^{(b)}(l)\right)_{l \geq 0}$ as

\begin{equation*}
\eta_{a}^{(b)}(l)=\varsigma_{a}^{(b)} l+\sum_{s \leq l} T_{a, b}\left(p_{a}^{(b)}(s)\right) \quad \text { for } \quad l \geq 0 \tag{3.5}
\end{equation*}
$$

Note that we have

$$
\begin{align*}
E\left[\mathrm{e}^{-r l_{a}^{(b)}(l)}\right] & =\exp \left\{-l\left(\varsigma_{a}^{(b)} r+n_{a}^{(b)}\left[1-\mathrm{e}^{-r T_{a, b}}\right]\right)\right\}  \tag{3.6}\\
& =\exp \left\{-l\left(\psi_{a}^{(b)}(r)-n_{a}^{(b)}\left[\mathrm{e}^{-r T_{b}} ; T_{b}<\infty\right]\right)\right\} . \tag{3.7}
\end{align*}
$$

Let $\lambda$ denote the first index $l \geq 0$ that $p_{a}^{(b)}(l)$ hits $b$, or in other words,

$$
\begin{equation*}
\lambda=\inf \left\{l \geq 0: T_{b}\left(p_{a}^{(b)}(l)\right)<\infty\right\} \tag{3.8}
\end{equation*}
$$

We define the process $\left(X_{a}^{(b)}(t): 0 \leq t<\eta_{a}^{(b)}(\lambda)\right)$ as
(3.9) $\quad X_{a}^{(b)}(t)= \begin{cases}p_{a}^{(b)}(l)\left(t-\eta_{a}^{(b)}(l-)\right) & \text { if } \quad \eta_{a}^{(b)}(l-) \leq t<\eta_{a}^{(b)}(l) \text { for some } 0 \leq l \leq \lambda, \\ a & \text { otherwise. }\end{cases}$

Now we construct the process $\left(X_{a}(t)\right)_{t \geq 0}$ as

$$
X_{a}(t)= \begin{cases}X_{a}^{(b)}(t) & \text { if } \quad t<\eta_{a}^{(b)}(\lambda),  \tag{3.10}\\ X_{b}\left(t-\eta_{a}^{(b)}(\lambda)\right) & \text { if } \quad t \geq \eta_{a}^{(b)}(\lambda) .\end{cases}
$$

Then it is obvious that the process $\left(X_{a}(t)\right)_{t \geq 0}$ is a realization of the process $\left\{\left(X_{t}\right)_{t \geq 0}, P_{a}\right\}$.
The first one of the three lemmas is the following.

Lemma 3.2. Let $g \in \mathcal{B}_{b}$. Then

\begin{equation*}
E\left[\int_{r_{a}^{(b)}(\lambda)}^{\infty} \mathrm{e}^{-r t} g\left(X_{a}(t)\right) \mathrm{d} t\right]=\frac{n_{a}^{(b)}\left[\mathrm{e}^{-r T_{b}} ; T_{b}<\infty\right]}{\psi_{a}^{(b)}(r)} \cdot R_{r} g(b) . \tag{3.11}
\end{equation*}
$$

Proof. Let $\left(p_{a}^{0}(l)\right)_{l \in D_{a}^{0}}$ denote the restriction of $\left(p_{a}^{(b)}(l)\right)_{l \in D_{a}^{(b)}}$ on the set of excursions which fail to hit $b$; more precisely, we define

\begin{equation*}
D_{a}^{0}=\left\{l \in D_{a}^{(b)}: T_{b}\left(p_{a}^{(b)}(l)\right)=\infty\right\} \tag{3.12}
\end{equation*}
$$

and $p_{a}^{0}(l)=p_{a}^{(b)}(l)$ for all $l \in D_{a}^{0}$. Let $\varepsilon=p_{a}^{(b)}(\lambda)$. Then we see that the three quantities $\left(p_{a}^{0}(l)\right)_{l \geq 0}, \lambda$ and $\varepsilon$ are mutually independent, and that $\left(p_{a}^{0}(l)\right)_{l \in D_{a}^{0}}$ is a Poisson point process with characteristic measure $n_{a}^{(b)}\left(\cdot ; T_{b}=\infty\right)$, the law of $\lambda$ is given as

$$
\begin{equation*}
P(\lambda>l)=\mathrm{e}^{-l \cdot n_{a}^{(b)}\left(T_{b}<\infty\right)} \tag{3.13}
\end{equation*}
$$

and the law of $\varepsilon$ is given as

$$
\begin{equation*}
P(\varepsilon \in \cdot)=\frac{n_{a}^{(b)}\left(\cdot ; T_{b}<\infty\right)}{n_{a}^{(b)}\left(T_{b}<\infty\right)} \tag{3.14}
\end{equation*}
$$

If we write

$$
\begin{equation*}
\eta_{a}^{0}(l)=\varsigma_{a}^{(b)} l+\sum_{s \leq l} T_{a}\left(p_{a}^{0}(s)\right) \tag{3.15}
\end{equation*}
$$

we have $E\left[\mathrm{e}^{-r \eta_{a}^{0}(l)}\right]=\mathrm{e}^{-l \psi_{a}^{0}(r)}$, where

$$
\begin{equation*}
\psi_{a}^{0}(r)=\varsigma_{a}^{(b)} r+n_{a}^{(b)}\left[1-\mathrm{e}^{-r T_{a}} ; T_{b}=\infty\right] \tag{3.16}
\end{equation*}
$$

By definition, we have

$$
\begin{equation*}
\eta_{a}^{(b)}(\lambda)=\eta_{a}^{0}(\lambda)+T_{b}(\varepsilon) \tag{3.17}
\end{equation*}
$$

Thus we obtain

$$
\begin{align*}
E\left[\int_{\eta_{a}^{(b)}(\lambda)}^{\infty} \mathrm{e}^{-r t} g\left(X_{a}(t)\right) \mathrm{d} t\right] & =E\left[\mathrm{e}^{-r \eta_{a}^{(b)}(\lambda)} \int_{0}^{\infty} \mathrm{e}^{-r t} g\left(X_{a}\left(t+\eta_{a}^{(b)}(\lambda)\right)\right) \mathrm{d} t\right]  \tag{3.18}\\
& =E\left[\mathrm{e}^{-r \eta_{a}^{(b)}(\lambda)}\right] E\left[\int_{0}^{\infty} \mathrm{e}^{-r t} g\left(X_{b}(t)\right) \mathrm{d} t\right]  \tag{3.19}\\

& =E\left[\mathrm{e}^{-r \eta_{a}^{0}(\lambda)}\right] \cdot E\left[\mathrm{e}^{-r T_{b}(\varepsilon)}\right] R_{r} g(b) \tag{3.21}
\end{align*}
$$

The expectations in the last expression can be computed as

& =\frac{1}{\psi_{a}^{0}(r)}\left\{1-\frac{n_{a}^{(b)}\left(T_{b}<\infty\right)}{n_{a}^{(b)}\left(T_{b}<\infty\right)+\psi_{a}^{0}(r)}\right\}  \tag{3.31}\\
& =\frac{1}{n_{a}^{(b)}\left(T_{b}<\infty\right)+\psi_{a}^{0}(r)}  \tag{3.32}\\
& =\frac{1}{\psi_{a}^{(b)}(r)}, \tag{3.33}
\end{align*}

which completes the proof.

## 4. The resolvent of the minimal diffusion

4.1. Non-negative increasing and decreasing eigenfunctions. Let $\left\{\left(X_{t}\right)_{t \geq 0}\right.$, $\left.\left(P_{x}^{0}\right)_{x \in(a, b)}\right\}$ be a minimal diffusion process and follow the notations in Subsection 2.3.

We recall non-negative increasing and decreasing eigenfunctions of $\mathcal{L}$. All results in this subsection are well-known; see, for example, [12] for details.

Let $c \in(a, b)$ and $r>0$ be fixed. Let $v=\varphi_{r}$ and $\psi_{r}$ denote the unique nonnegative increasing solutions of $\mathcal{L} v=r v$ such that

\varphi_{r}(c)=1, & \mathcal{D}_{s} \varphi_{r}(c)=0 \\
\psi_{r}(c)=0, & \mathcal{D}_{s} \psi_{r}(c)=1 \tag{4.2}
\end{array}

These solutions can be obtained via successive approximation by solving the following integral equations:

& \varphi_{r}(x)=1+r \int_{c}^{x} \mathrm{~d} s(y) \int_{c}^{y} \varphi_{r}(z) \mathrm{d} m(z)  \tag{4.3}\\
& \psi_{r}(x)=s(x)-s(c)+r \int_{c}^{x} \mathrm{~d} s(y) \int_{c}^{y} \psi_{r}(z) \mathrm{d} m(z) \tag{4.4}
\end{align*}

Then any solution of $\mathcal{L} v=r v$ with $v(c)=1$ is of the form $v=\varphi_{r}-\gamma \psi_{r}$. Note that $v=\varphi_{r}-\gamma \psi_{r}$ is non-negative and decreasing when restricted on $[c, b)$, then so is it on the whole interval $(a, b)$. Let $\underline{\gamma}$ and $\bar{\gamma}$ denote the infimum and the supremum among all $\gamma>0$ such that $\varphi_{r}-\gamma \psi_{r}$ is a non-negative decreasing function. Then we see that $0<\underline{\gamma} \leq \bar{\gamma}<\infty$ and that $\varphi_{r}-\gamma \psi_{r}$ is a non-negative decreasing function for all $\underline{\gamma} \leq \gamma \leq \bar{\gamma}$. Now we take the minimal one: $v_{r}=\varphi_{r}-\bar{\gamma} \psi_{r}$. The boundary behaviors of $\overline{v_{r}}$ at $a$ are as follows:

v_{r}(a) \begin{cases}\in(0, \infty) & \text { if } a \text { is accessible } \\
=\infty & \text { otherwise }\end{cases} & v_{r}(b) \begin{cases}\in(0, \infty) & \text { if } b \text { is entrance } \\
0 & \text { otherwise }\end{cases} \\
\hline-\mathcal{D}_{s} v_{r}(a) \begin{cases}\in(0, \infty) & \text { if } a \text { is enterable } \\
=\infty & \text { otherwise }\end{cases} & -\mathcal{D}_{s} v_{r}(b) \begin{cases}\in(0, \infty) & \text { if } b \text { is accessible } \\
=0 & \text { otherwise }\end{cases}
\end{array}
$$

We also note that $\int_{c}^{b-} v_{r}(x) \mathrm{d} m(x)<\infty$ in any case. By the same way, we obtain a non-negative increasing solution $u=u_{r}$ of $\mathcal{L} u=r u$ whose boundary behaviors are as follows:

We also note that $\int_{a}^{c} u_{r}(x) \mathrm{d} m(x)<\infty$ in any case.
4.2. Several limits at the boundary points. We multiply $u_{r}$ (or $v_{r}$ ) by a certain constant and we may assume without loss of generality that

Here we understand $1 /+\infty=0$ and $1 /+0=+\infty$.
Proof. By the symmetry, it suffices only to prove that $\mathcal{D}_{s} u_{r}(a)=1 / v_{r}(a)$. If $a$ is not accessible, then this is obvious, because we have $\mathcal{D}_{s} u_{r}(a)=0$ and $v_{r}(a)=\infty$.

Suppose that $a$ is accessible. By (4.5), we have

& \leq 1-\frac{(k-\varepsilon)^{2}}{(k+\varepsilon)^{2}} s(a, x)\left\{\frac{1}{s(a, x)}-\frac{1}{s(a, b)}\right\} \\
& \leq 1-\frac{(k-\varepsilon)^{2}}{(k+\varepsilon)^{2}}+\frac{(k-\varepsilon)^{2}}{(k+\varepsilon)^{2}} \cdot \frac{s(a, x)}{s(a, b)} .

Since $s(a, a)=0$ and since $\varepsilon>0$ is arbitrary, we obtain (4.8) and hence we obtain the desired result.

### 4.3. The resolvent of the minimal diffusion process. Define

From Theorem 2.4, it follows that

In our study, however, we need $R_{r}^{0} \mathcal{L} f$ for $f \in D(\mathcal{L})$ with $f, \mathcal{L} f \in C_{b}$. The formula (4.20) can be generalized to the following proposition:

Proposition 4.2. For any $f \in D(\mathcal{L})$ with $f, \mathcal{L} f \in C_{b}$, one has

& =u_{r}(c)\left\{\mathcal{D}_{s} f(x)-\mathcal{D}_{s} f(c)\right\}+\int_{c}^{x} \mathrm{~d} s(z) \mathcal{D}_{s} u_{r}(z) \int_{z}^{x} \mathcal{L} f(y) \mathrm{d} m(y)  \tag{4.28}\\
& =u_{r}(c)\left\{\mathcal{D}_{s} f(x)-\mathcal{D}_{s} f(c)\right\}+\int_{c}^{x} \mathrm{~d} s(z) \mathcal{D}_{s} u_{r}(z)\left\{\mathcal{D}_{s} f(x)-\mathcal{D}_{s} f(z)\right\}  \tag{4.29}\\
& =u_{r}(x) \mathcal{D}_{s} f(x)-u_{r}(c) \mathcal{D}_{s} f(c)-\int_{c}^{x} \mathrm{~d} s(z) \mathcal{D}_{s} u_{r}(z) \mathcal{D}_{s} f(z) . \tag{4.30}
\end{align*}

(4.33) $=\mathcal{D}_{s} u_{r}(x)\{f(x)-f(c)\}-r \int_{c}^{x} \mathrm{~d} s(z) \mathcal{D}_{s} f(z) \int_{z}^{x} u_{r}(y) \mathrm{d} m(y)$
(4.34) $=\mathcal{D}_{s} u_{r}(x)\{f(x)-f(c)\}-r \int_{c}^{x} \mathrm{~d} m(y) u_{r}(y) \int_{c}^{y} \mathcal{D}_{s} f(z) \mathrm{d} s(z)$
(4.35) $=\mathcal{D}_{s} u_{r}(x)\{f(x)-f(c)\}-r \int_{c}^{x} f(y) u_{r}(y) \mathrm{d} m(y)+f(c) \cdot r \int_{c}^{x} u_{r}(y) \mathrm{d} m(y)$.

Hence we obtain $\lim _{c \rightarrow a+}\left\{-u_{r}(c) \mathcal{D}_{s} f(c)\right\}=0$. Hence, by Proposition 4.1, we obtain $Q_{a}=f(a) \mathcal{D}_{s} u_{r}(a)=f(a) / v_{r}(a)$.
(ii) Suppose that $a$ is not accessible. On one hand, we have $v_{r}(a)=\infty$. On the other hand, since $f$ and $\mathcal{L} f$ are bounded, we see by (4.44) that $Q_{a} v_{r}(x)$ should be bounded near $a$. Hence we obtain $Q_{a}=0=f(a) / v_{r}(a)$.
We can make the same argument for $b$ and obtain $Q_{b}=f(b) / u_{r}(b)$. Therefore, from (4.44), we obtain the formula (4.21).

If $a$ is entrance, then we have $u_{r}(a) \in(0, \infty)$ and $\mathcal{D}_{s} u_{r}(a)=0$. Since $Q_{a}=0$, we obtain $\mathcal{D}_{s} f(a)=0$.

The proof is now complete.

## 5. The $\boldsymbol{C}_{b}$-generator

We now suppose that $\left\{\left(X_{t}\right)_{t \geq 0},\left(P_{x}\right)_{x \in[a, b]}\right\}$ is an extension to a standard process of the minimal process $\left\{\left(X_{t}\right)_{t \geq 0},\left(P_{x}^{0}\right)_{x \in(a, b)}\right\}$ and follow the notations in Subsection 2.4. It is well-known that

R_{r}^{0} g=f-f(a) \frac{v_{r}}{v_{r}(a)} \tag{5.62}
\end{equation*}
$$

Set $h=R_{r} g-f$. By (5.60), we have $\Phi_{a}\left(R_{r} g\right)=p_{4}(\{b\}) R_{r} g(b)$, and hence we have $\Phi_{a}(h)=p_{4}(\{b\}) h(b)$. From (5.56) and (5.62), it follows that

$$
\begin{equation*}
h=\left\{R_{r} g(a)-f(a)\right\} \frac{v_{r}}{v_{r}(a)} . \tag{5.63}
\end{equation*}
$$

Hence, by Lemma 5.1 and by (5.1), we have

$$
\begin{align*}
0 & =\Phi_{a}(h)-p_{4}(\{b\}) h(b)  \tag{5.64}\\
& =\left\{R_{r} g(a)-f(a)\right\}\left\{\frac{\Phi_{a}\left(v_{r}\right)}{v_{r}(a)}-p_{4}(\{b\}) \frac{v_{r}(b)}{v_{r}(a)}\right\}  \tag{5.65}\\
& =\left\{R_{r} g(a)-f(a)\right\}\left\{\psi_{a}^{(b)}(r)-p_{4}(\{b\}) P_{b}^{\mathrm{stop}}\left[\mathrm{e}^{-r T_{a}}\right]\right\} . \tag{5.66}
\end{align*}
$$

Since

$$
\begin{equation*}
\lim _{r \rightarrow \infty} \psi_{a}^{(b)}(r)=\infty \tag{5.67}
\end{equation*}
$$

by the assumption (2.38) and since

$$
\begin{equation*}
\lim _{r \rightarrow \infty} P_{b}^{\text {stop }}\left[\mathrm{e}^{-r T_{a}}\right]=0, \tag{5.68}
\end{equation*}
$$

we see that $\psi_{a}^{(b)}\left(r_{0}\right)-p_{4}(\{b\}) P_{b}^{\text {stop }}\left[\mathrm{e}^{-r_{0} T_{a}}\right]>0$ for some $r_{0}>0$. Hence, by (5.66) we obtain $R_{r_{0}} g(a)-f(a)=0$ and by (5.63) we obtain $f=R_{r_{0}} g$. Now we conclude that $D(\mathcal{G}) \supset \tilde{D}$.
(2) Suppose that $b$ is natural or [entrance and regular-for-itself]. Set

$$
\begin{equation*}
\tilde{D}=\left\{f \in D(\mathcal{L}): f, \mathcal{L} f \in C_{b}([a, b]), \Phi_{a}(f)=p_{4}(\{b\}) f(b), \Phi_{b}(f)=0\right\} \tag{5.69}
\end{equation*}
$$

Let us prove that $D(\mathcal{G})=\tilde{D}$.
Let $g \in D(\mathcal{G})$. Let $r>0$ be fixed and set $g=(r-\mathcal{G}) f$. In the same way as (1), we can prove that $f=R_{r} g$ and that $f \in C_{b}([a, b))$ with finite left limit $f(b-)$, $\mathcal{L} f \in C_{b}([a, b])$ and $\Phi_{a}(f)=p_{4}(\{b\}) f(b)$. For any $r>0$, we can find $g \in C_{b}([a, b])$ such that $f=R_{r} g$. Using Theorem 2.2 where the roles of $a$ and $b$ are switched, and using the Dynkin formula (5.56), we have

$$
\begin{align*}
\psi_{b}^{(a)}(r) f(b) & =q_{3} g(b)+\int_{(a, b)} q_{4}(\mathrm{~d} x) R_{r}^{0} g(x)+q_{4}(\{a\}) R_{r} g(a)  \tag{5.70}\\
& =q_{3} g(b)+q_{4}[f] . \tag{5.71}
\end{align*}
$$

Noting that $g=(r-\mathcal{G}) f$, that $g(b)=g(b-)=r f(b-)-\mathcal{L} f(b)$, and that

$$
\begin{equation*}
\psi_{b}^{(a)}(r)=q_{3} r+n_{b}^{(a)}\left[1-\mathrm{e}^{-r T_{b}}\right]=q_{1}+q_{3} r+q_{4}([a, b)), \tag{5.72}
\end{equation*}
$$

we have

$$
\begin{equation*}
\left\{q_{1}+q_{4}([a, b))\right\} f(b)+q_{3} r\{f(b)-f(b-)\}+q_{3} \mathcal{L} f(b)=q_{4}[f] . \tag{5.73}
\end{equation*}
$$

This shows that

$$
\begin{equation*}
\Phi_{b}(f)+q_{3} r\{f(b)-f(b-)\}=0 . \tag{5.74}
\end{equation*}
$$

Since $q_{3}>0$ and since $r>0$ is arbitrary, we obtain $\Phi_{b}(f)=f(b)-f(b-)=0$. Hence we obtain $D(\mathcal{G}) \subset \tilde{D}$.

Suppose that $f \in \tilde{D}$. Let $r>0$ be fixed. Set $g=(r-\mathcal{L}) f \in C_{b}([a, b])$. Then, in the same way as (1), we can prove that $f=R_{r} g$ on $[a, b]$, and hence we obtain $D(\mathcal{G}) \supset \tilde{D}$.

The proof is now complete.
The proof of Theorem 2.10 is quite similar to that of Theorem 2.9, and so we omit it.
5.5. The case of $\mathbf{4}^{\circ}$ ). Now we prove Theorem 2.11.

Proof of Theorem 2.11. Suppose that both $a$ and $b$ are accessible. Let $g \in \mathcal{B}_{b}=$ $\mathcal{B}_{b}([a, b])$. By the strong Markov property, we obtain the Dynkin formula:

$$
\begin{equation*}
R_{r} g=R_{r}^{0} g+R_{r} g(a) \frac{v_{r}}{v_{r}(a)}+R_{r} g(b) \frac{u_{r}}{u_{r}(b)} . \tag{5.75}
\end{equation*}
$$

By Proposition 2.3, we have $R_{r} g \in D(\mathcal{L})$, and we have

$$
\begin{align*}
\mathcal{L} R_{r} g & =r R_{r}^{0} g-g+R_{r} g(a) \frac{r v_{r}}{v_{r}(a)}+R_{r} g(b) \frac{r u_{r}}{u_{r}(b)}  \tag{5.76}\\
& =r R_{r} g-g . \tag{5.77}
\end{align*}
$$

Using Lemmas 5.1 and 5.3 and then using Theorem 2.2, we have

$$
\begin{align*}
\Phi_{a}\left(R_{r} g\right) & =\Phi_{a}\left(R_{r}^{0} g\right)+R_{r} g(a) \frac{\Phi_{a}\left(v_{r}\right)}{v_{r}(a)}+R_{r} g(b) \frac{\Phi_{a}\left(u_{r}\right)}{u_{r}(b)}  \tag{5.78}\\
& =-N_{a, r}^{(b)}(g)+R_{r} g(a) \psi_{a}^{(b)}(r)+R_{r} g(b)\left\{-n_{a}^{(b)}\left[\mathrm{e}^{-r T_{b}} ; T_{b}<\infty\right]\right\}  \tag{5.79}\\
& =0 . \tag{5.80}
\end{align*}
$$

Replacing the roles of $a$ and $b$, we obtain $\Phi_{b}\left(R_{r} g\right)=0$. Thus we obtain the following:

$$
\begin{equation*}
\text { if } g \in \mathcal{B}_{b}, \quad \text { we have } \quad R_{r} g \in D(\mathcal{L}) \text { and } \Phi_{a}\left(R_{r} g\right)=\Phi_{b}\left(R_{r} g\right)=0 \tag{5.81}
\end{equation*}
$$

Let $f \in D(\mathcal{G})$. Let $r>0$ be fixed and set $g=(r-\mathcal{G}) f$. Then we have $f=R_{r} g$. By (5.81), we have $\Phi_{a}(f)=\Phi_{b}(f)=0$. Hence we see that $D(\mathcal{G})$ is contained in the right-hand side of (2.54). By (5.77), we have

$$
\begin{equation*}
\mathcal{L} f=\mathcal{L}\left(R_{r} g\right)=r R_{r} g-g=\mathcal{G} f . \tag{5.82}
\end{equation*}
$$

Conversely, let $f \in D(\mathcal{L})$ such that $f, \mathcal{L} f \in C_{b}([a, b])$ and suppose that $\Phi_{a}(f)=$ $\Phi_{b}(f)=0$. Let $r>0$ be fixed and set $g=(r-\mathcal{L}) f$. Then, by Proposition 4.2, we have

$$
\begin{align*}
R_{r}^{0} g & =r R_{r}^{0} f-R_{r}^{0} \mathcal{L} f  \tag{5.83}\\
& =r R_{r}^{0} f-\left\{r R_{r}^{0} f-f+f(a) \frac{v_{r}}{v_{r}(a)}+f(b) \frac{u_{r}}{u_{r}(b)}\right\}  \tag{5.84}\\
& =f-f(a) \frac{v_{r}}{v_{r}(a)}-f(b) \frac{u_{r}}{u_{r}(b)} . \tag{5.85}
\end{align*}
$$

Set $h=R_{r} g-f$. By (5.81), we have $\Phi_{a}\left(R_{r} g\right)=\Phi_{b}\left(R_{r} g\right)=0$, and hence we have $\Phi_{a}(h)=\Phi_{b}(h)=0$. From (5.75) and (5.85), it follows that

$$
\begin{equation*}
h=\left\{R_{r} g(a)-f(a)\right\} \frac{v_{r}}{v_{r}(a)}+\left\{R_{r} g(b)-f(b)\right\} \frac{u_{r}}{u_{r}(b)} . \tag{5.86}
\end{equation*}
$$

Since $\Phi_{a}(h)=\Phi_{b}(h)=0$, we obtain

$$
\begin{equation*}
\binom{0}{0}=A\binom{R_{r} g(a)-f(a)}{R_{r} g(b)-f(b)}, \tag{5.87}
\end{equation*}
$$

where $A$ is the matrix defined in (5.27). Hence, by Proposition 5.2, we obtain

$$
\begin{equation*}
R_{r} g(a)-f(a)=R_{r} g(b)-f(b)=0 \tag{5.88}
\end{equation*}
$$

This shows that $h=0$, which implies that $f=R_{r} g$. Now we conclude that the righthand side of $(2.54)$ is contained in $D(\mathcal{G})$, and thus the proof is complete.
