ON THE CLOSED IMAGES OF PARACOMPLEXES

Let X be an image of a paracomplex by a closed mapping. Then the following are proved: (1) X is an M_1 -space, and this solves positively the problem proposed by J. Nagata, (2) dim X=Ind X, and (3) dim $X\leq n$ if and only if there exists a σ -closure-preserving base \mathscr{W} for X such that dim $B(W)\leq n-1$ for every $W\in \mathscr{W}$.

1. Introduction. J. Nagata in [5] proved that every paracomplex is an M_1 -space in the sense of J. G. Ceder [2], and proposed the problem whether every closed image of a paracomplex is an M_1 -space or not [5, Problem 1]. As noted there, the closed image of a paracomplex is at least stratifiable in the sense of Borges [1]. It is well known that every closed image of a metric space is an M_1 -space [6]. Since a metric space is a 0-paracomplex, it seems to be natural to propose the problem.

The author proves in this paper that every closed image of a paracomplex is an M_i -space, and therefore the above problem is solved positively. The point of the proof is to use the notion of uniformly approaching anti-covers, which is first introduced by K. Nagami [4]. The importance of this notion consists in the fact that this property is hereditary with respect to closed mappings. Moreover the author gives two results on dimension theory, one of which is that the coincidence theorem for dim and Ind holds for a closed image of a paracomplex, and the other is that if X is a closed image of a paracomplex, then dim $X \leq n$ if and only if there exists a σ -closure-preserving base \mathscr{W} for X such that dim $B(W) \leq n - 1$ for every $W \in \mathscr{W}$, though it is proved by J. Nagata there for a paracomplex itself.

All spaces are assumed to be Hausdorff. All mappings are assumed to be continuous, and onto unless the contrary is stated explicitly. A closed image of a space means the image by a closed mapping. N always denotes the positive integers.

2. Definitions and lemmas. Let H be a closed set of a space X and f a mapping of H into a space Y. The quotient space $Z = X \bigcup_f Y$ obtained from the topological disjoint sum $X \vee Y$ by identifying each $x \in H$ with f(x) is called the *adjunction space of* X and Y. If $p: X \vee Y \to Z$ is the quotient mapping, then we set $p_X = p | X$ and $p_Y = p | Y$, which are used in the sequel without the explanation.

DEFINITION 1 (D. M. Hyman). A 0-paracomplex is a metric space. Assume that *n*-paracomplexes have been defined for $n \in N$. Then the space $Z = X \bigcup_{f} Y$, where X is a metric space and Y is an *n*-paracomplex, is called an n + 1-paracomplex.

DEFINITION 2([5, Definition 1]). Let $X = \bigcup_{i=1}^{\infty} X_i$, where $\{X_i: i \in N\}$ is a closed cover of a space X such that $X_i \subset X_{i+1}$ for each $i \in N$ and each X_i is an n_i -paracomplex for some n_i with $0 \leq n_i < \infty$. If X is dominated by $\{X_i\}$ (namely $F \subset X$ is closed in X if and only if $F \cap X_i$ is closed in X_i for every $i \in N$), then X is called a paracomplex.

DEFINITION 3 ([4, Definitions 1.1 and 4.4]). Let X be a space and F a closed set of X. An open cover of X - F is said to be an *anti-cover of* F in X. An anti-cover \mathscr{U} is said to be approaching to F in X if for each neighborhood U of F in X, $\overline{S(X - U, \mathscr{U})} \cap$ $F = \emptyset$. An anti-cover \mathscr{U} is said to be uniformly approaching to F in X if for every open set U of X, $\overline{S(X - U, \mathscr{U})} \cap F \cap U = \emptyset$.

The following are known and used later.

Fact 1([4, Remark 4.5(2)]). Every closed set of a metric space has a uniformly approaching anti-cover.

Fact 2 ([4, Theorem 1.3]). Let X be a hereditarily paracompact space and F a closed set of X. If F has an approaching anti-cover, then F has a closure-preserving open neighborhood base.

LEMMA 1. Let $f: X \to Y$ be a closed mapping. Let $\mathscr{U} = \{U_{\alpha}: \alpha \in A\}$ be a locally finite open collection of X. Let \varDelta be the totality of subsets δ of A and set $V_{\delta} = \bigcup \{U_{\alpha}: \alpha \in \delta\}, \ \delta \in \varDelta$. Then $\{f(X - V_{\delta}): \delta \in \varDelta\}$ is closure-preserving in Y.

Proof. Let Δ_0 be an arbitrary subset of Δ and suppose $x \notin f(X - V_{\delta})$ for every $\delta \in \Delta_0$. This implies $f^{-1}(x) \subset V_{\delta}$ for every $\delta \in \Delta_0$. For each $y \in f^{-1}(x)$, take an open neighborhood N(y) of y such that $N(y) \subset V_{\delta}$ for every $\delta \in \Delta_0$. Set

$$N = \bigcup \{N(y): y \in f^{-1}(x)\}, \ N^* = Y - f(X - N)$$
.

Then N^* is an open neighborhood of x such that $N^* \cap f(X-V_{\delta}) = \phi$ for every $\delta \in A_0$. This implies $x \notin \bigcup \{f(X-V_{\delta}): \delta \in A_0\}$.

LEMMA 2. Let $f: X \to Y$ be a closed mapping of a hereditarily

paracompact space X onto Y, and F a closed set of Y. If $f^{-1}(F)$ has a uniformly approaching anti-cover in X, then so does F in Y.

Proof. Let $\mathscr{U} = \{U_{\alpha}: \alpha \in A\}$ be a uniformly approaching anticover of F in X and \varDelta the totality of subsets δ of A. Set $V_{\delta} = \bigcup \{U_{\alpha}: \alpha \in \delta\}$ for each $\delta \in \varDelta$. Since X is hereditarily paracompact, we can assume that \mathscr{U} is locally finite in $X - f^{-1}(F)$. For each point y of Y - F, define the following:

Observe $W(y) \cap F = \emptyset$ for every $y \in Y - F$. Since $\{f(\overline{V}_{\delta}): \delta \in \Delta\}$ and $\{f(X - V_{\delta}): \delta \in \Delta\}$ are closure-preserving in Y - F by Lemma 1, W(y) is an open neighborhood of y in Y. Therefore $\mathscr{W} = \{W(y): y \in Y - F\}$ is an anti-cover of F in Y. We shall show that \mathscr{W} is uniformly approaching to F in Y. Let W be an open set of Y. Since \mathscr{U} is uniformly approaching, there exist $\delta_1, \delta_2 \in \Delta$ such that

are open sets of X such that

$$N_{\scriptscriptstyle 1}\!\subset f^{\scriptscriptstyle -1}\!(W)$$
 , $N_{\scriptscriptstyle 2}\cap S\!(X-f^{\scriptscriptstyle -1}\!(N_{\scriptscriptstyle 1}^{\,st}),\,\mathscr{U})=\phi$,

where $N_1^* = Y - f(X - N_1)$. It follows from the definition of W(y)that if $y \in Y - (f(X - V_{\delta_1}) \cup F)$, then $W(y) \subset W$. Therefore if $W(y) \cap (Y - W) \neq \emptyset$ for $y \in Y - F$, then $y \in f(X - V_{\delta_1})$. This implies $y \notin f(\bar{V}_{\delta_2})$. Thus we have $W(y) \cap f(\bar{V}_{\delta_2}) = \emptyset$. If we set $N_2^* = Y - f(X - N_2)$, then N_2^* is an open neighborhood of $F \cap W$ in Y such that $N_2^* \cap W(y) = \emptyset$. Hence we have $S(Y - W, \mathscr{W}) \cap N_2^* = \emptyset$. This completes the proof.

DEFINITION 4. A space X is said to have the property (P) if for every closed set F of X and for every open set V of F, there corresponds an open set V' of X such that $V' \cap F = V$ and $V' \cap$ $W' = \emptyset$ if V, W are disjoint open sets of F. Such an open extension V' of V is said to be a special extension of V to X.

LEMMA 3. Every n-paracomplex has the property (P).

Proof. First we consider the case of n = 0. Let F be a closed set of a metric space (X, d) and V an open set of F. For every point $x \in V$, choose a positive number $\varepsilon = \varepsilon(x)$ such that $S_{\varepsilon}(x) \cap F \subset V$, where $S_{\varepsilon}(x)$ denotes the ε -neighborhood of x with respect to d. Set

$$V' = \bigcup \{S_{\varepsilon/2}(x) \colon x \in V\}$$
.

Then V' is easily seen to be a special extension of V to X. We consider the general case. Assume that every *n*-paracomplex has the property (P). Let $Z = X \bigcup_f Y$ be an n + 1-paracomplex stated in Definition 1. Let F be a closed set of Z and V an open set of F. Since Y has (P) by the induction assumption, $p_T^{-1}(V)$ has a special extension \tilde{V} to Y. Let d be a compatible metric on X. Choose for each point x of $p_X^{-1}(V \cup p(\tilde{V}))$ a positive number $\varepsilon = \varepsilon(x)$ such that

where $S_{\varepsilon}(x)$ denotes the ε -neighborhood of x with respect to d. Set

$$V'=p(\widetilde{V})\cup p(oldsymbol{\bigcup}\left\{S_{\epsilon/2}(x)\colon x\in p_{X}^{-1}(V\cup p(\widetilde{V}))
ight\})\;.$$

Then by a routine check V' is shown to be a special extension of V to Z.

LEMMA 4. Every closed image of a space with the property (P) also has (P).

Proof. Let $f: X \to Y$ be a closed mapping of a space with (P) onto Y. Let F be a closed set of Y and V an open set of F. There exists a special extension $f^{-1}(V)'$ of $f^{-1}(V)$ to X. Set $V' = Y - f(X - f^{-1}(V)')$. Then V' is an open set of Y such that $V' \cap F = V$. It is obvious that if V, W are disjoint open sets of F, then $V' \cap W' = \emptyset$. Hence Y has the property (P).

DEFINITION 5. A space X is said to be cp-expandable if the following condition (CP) is satisfied:

(CP) Let F be an arbitrary closed set of X and $\mathcal{U} = \{U_{\alpha} : \alpha \in A\}$ a closure-preserving open collection of F. Then for each $\alpha \in A$ there exists an open collection $\{U_{\alpha\beta} : \beta \in B_{\alpha}\}$ of X with $U_{\alpha\beta} \cap F = U_{\alpha}$ for every $\beta \in B_{\alpha}$, which satisfies the following (1) and (2):

(1) $\mathscr{V} = \{U_{\alpha\beta} : \beta \in B_{\alpha}, \ \alpha \in A\}$ is closure-preserving in X.

(2) If $U_{\alpha} = W \cap F$ for an open set W of X and for $\alpha \in A$, then $U_{\alpha\beta} \subset W$ for some $\beta \in B_{\alpha}$.

In the next two lemmas, we shall show that every closed image of an n-paracomplex is cp-expandable, and this fact plays an important role when Theorem 1 is proved.

LEMMA 5. Every closed image T of an n-paracomplex has a collection $\{T_i: i = 1, \dots, k\}$ of T satisfying the following:

(1) $T = \bigcup_{i=1}^{k} T_i, T_i \cap T_j = \emptyset$ for each pair i, j with $i \neq j$ and

each $T'_i = T_1 \cup \cdots \cup T_i$ is closed in T.

(2) If F is a closed set of T, then F and each $F \cup T'_i$, $i=1, \cdots$, k-1, have uniformly approaching anti-covers in $F \cup T_1$ and $F \cup T_{i+1}$, respectively.

Proof. Part 1. We shall show that every *n*-paracomplex Z has the collection $\{Z_i: i = 1, \dots, k\}$ of subsets of Z satisfying (1) and (2) in Lemma 5. A 0-paracomplex Z has obviously a collection $\{Z_i\} = \{Z\}$ satisfying (1) and (2) by virtue of Fact 1. Assume that every *n*-paracomplex has such a collection. Suppose that we are given $Z = X \bigcup_f Y$, where Y is an *n*-paracomplex and f is a mapping of a closed set H of a metric space X into Y. By the induction assumption Y has a collection $\{Y_1, \dots, Y_k\}$ satisfying (1) and (2). Set

$$oldsymbol{Z}_{\scriptscriptstyle 1}=p(Y_{\scriptscriptstyle 1}),\,\cdots,\,oldsymbol{Z}_{\scriptscriptstyle k}=p(Y_{\scriptscriptstyle k}),\,\,oldsymbol{Z}_{\scriptscriptstyle k+1}=oldsymbol{Z}-p(Y)$$
 .

Then $\{Z_1, \dots, Z_{k+1}\}$ obviously satisfies (1) in Lemma 5. Let F be a closed set of Z. By Fact 1, $H \cup p_X^{-1}(F)$ has a uniformly approaching anti-cover \mathscr{V} in X. Let $\mathscr{U}_0, \mathscr{U}_i, i = 1, \dots, k-1$, be uniformly approaching anti-covers of $p_Y^{-1}(F), p_Y^{-1}(F) \cup (Y_1 \cup \dots \cup Y_i)$ in $p_Y^{-1}(F) \cup Y_1, p_Y^{-1}(F) \cup (Y_1 \cup \dots \cup Y_{i+1})$, respectively. Set

$${\mathscr W}_{\scriptscriptstyle 0}=p({\mathscr U}_{\scriptscriptstyle 0}), \,\, {\mathscr W}_{\scriptscriptstyle 1}=p({\mathscr U}_{\scriptscriptstyle 1}),\, \cdots, \,\, {\mathscr W}_{k-1}=p({\mathscr U}_{k-1})$$
 .

Then obviously \mathscr{W}_{0} , \mathscr{W}_{i} , $i = 1, \dots, i - 1$, are uniformly approaching anti-covers of F, $F \cup (Z_{1} \cup \dots \cup Z_{i})$ in $F \cup Z_{1}$, $F \cup (Z_{1} \cup \dots \cup Z_{i+1})$, respectively. It is obvious that $\mathscr{W}_{k} = p(\mathscr{V})$ is a uniformly approaching anti-cover of $F \cup (Z_{1} \cup \dots \cup Z_{k}) = F \cup p(Y)$ in Z.

Part 2. Let $g: Z \to T$ be a closed mapping of an *n*-paracomplex Z onto T. By Part 1, there exists a collection $\{Z_1, \dots, Z_t\}$ of subsets of Z satisfying (1) and (2). Set

$$T_{_1}=g(Z_{_1}),\ T_{_i}=g(Z_{_i})-(g(Z_{_1})\cup\cdots\cup g(Z_{_{i-1}}))\ , \ i=2,\ \cdots,\ t\ .$$

Then obviously $\{T_i: i = 1, \dots, t\}$ satisfies (1). Let F be a closed set of T. Set

$$g_i = g | P_i, P_i = (Z_1 \cup \cdots \cup Z_i) \cup g^{-1}(F), i = 1, \cdots, t$$

Then $g_i: P_i \to F \cup (T_1 \cup \cdots \cup T_i)$ is a closed mapping. Since $g_1^{-1}(F)$ has a uniformly approaching anti-cover in P_1 , by Lemma 2 so does F in $F \cup T_1$. Observe that $g_{i+1}^{-1}(F \cup (T_1 \cup \cdots \cup T_i))$ is a closed set of P_{i+1} containing $Z_1 \cup \cdots \cup Z_i$, and therefore by (2) for $\{Z_1, \cdots, Z_i\}$ it has a uniformly approaching anti-cover in P_{i+1} . Consequently by Lemma 2 $F \cup (T_1 \cup \cdots \cup T_i)$, $i = 1, \cdots t - 1$, has a uniformly approaching anti-cover in $F \cup (T_1 \cup \cdots \cup T_i)$. This completes the proof.

LEMMA 6. Every closed image of an n-paracomplex is cp-expandable.

Proof. Let $f: \mathbb{Z} \to T$ be a closed mapping of an *n*-paracomplex \mathbb{Z} onto T. Then by Lemma 5 there exists a collection $\{T_1, \dots, T_k\}$ satisfying (1) and (2) in Lemma 5. Let F be a closed set of T and $\mathscr{U} = \{U_{\alpha}: \alpha \in A\}$ a closure-preserving open collection of F. By (2) $F, F \cup (T_1 \cup \dots \cup T_i), i = 1, \dots, k-1$, have uniformly approaching anti-covers $\mathscr{U}_0, \ \mathscr{U}_i$ in $F \cup T_1, \ F \cup (T_1 \cup \dots \cup T_{i+1})$, respectively. Since T is hereditarily paracompact, we can assume that $\mathscr{U}_0 = \{U_{0\alpha}: \alpha \in A_0\}, \ \mathscr{U}_i = \{U_{i\alpha}: \alpha \in A_i\}, \ i = 1, \dots, k-1$, are locally finite in $T_1 - F, \ T_{i+1} - F$, respectively. For each $\alpha \in A_0$, let $\varDelta(\alpha)$ be the totality of subsets δ_0 of A_0 such that

$$U_{\alpha}(\delta_0) = U_{\alpha} \cup (\bigcup \{U_{0\alpha} : \alpha \in \delta_0\})$$

is an open set of $F \cup T_1$ such that $U_{\alpha}(\delta_0) \subset U'_{\alpha}$, where U'_{α} is a special extension of U_{α} to T, the existence of which is assured by Lemmas 3 and 4. For each $\delta_0 \in \Delta(\alpha)$, let $\Delta(\alpha, \delta_0)$ be the tatality of subsets δ_1 of A_1 such that

$$U_{\alpha}(\delta_0, \delta_1) = U_{\alpha}(\delta_0) \cup (\cup \{U_{1\alpha}: \alpha \in \delta_1\})$$

is an open set of $F \cup (T_1 \cup T_2)$ such that

$$U_{lpha}(\delta_{\scriptscriptstyle 0},\,\delta_{\scriptscriptstyle 1})\subset U_{lpha}'\,\cap\, U_{lpha}(\delta_{\scriptscriptstyle 0})'$$
 ,

where $U_{\alpha}(\delta_0)'$ is a special extension of $U_{\alpha}(\delta_0)$ to T. Repeating this process, we reach an open set of T

$$U_{lpha}(\delta_{\scriptscriptstyle 0},\,\cdots,\,\delta_{k-1})=\,U_{lpha}(\delta_{\scriptscriptstyle 0},\,\cdots,\,\delta_{k-2})\cup(igcup \{U_{k-1lpha}\!:lpha\in\delta_{k-1}\})$$

for $\delta_{k-1} \in \Delta(\alpha, \delta_0, \dots, \delta_{k-2})$. For each $\beta = (\delta_0, \delta_1, \dots, \delta_{k-1})$, we set $U_{\alpha\beta} = U_{\alpha}(\delta_0, \dots, \delta_{k-1})$ and consider the collection

$$\mathscr{V}=\{U_{lphaeta};eta=(\delta_0,\,\cdots,\,\delta_{k-1}),\,\delta_0\in\varDelta(lpha)\;,\ \delta_1\in\varDelta(lpha,\,\delta_0),\,\cdots,\,\delta_{k-1}\in\varDelta(lpha_0,\,\cdots,\,\delta_{k-2}),\,lpha\in A\}\;.$$

Then obviously $U_{\alpha\beta} \cap F = U_{\alpha}$ for each α , β . To show that \mathscr{V} is closure-preserving in T, let M be an arbitrary subset of $\{(\alpha, \beta): \beta = (\delta_0, \dots, \delta_{k-1}), \delta_0 \in \mathcal{A}(\alpha), \dots, \delta_{k-1} \in \mathcal{A}(\alpha, \delta_0, \dots, \delta_{k-2}), \alpha \in A\}$. Suppose $x \notin \overline{U}_{\alpha\beta}$ for every $(\alpha, \beta) \in M$. If $x \in F$, then there exists an open neighborhood N of x in F such that $N \cap U_{\alpha} = \emptyset$ for every $\alpha \in A$ with $(\alpha, \beta) \in M$. Let N' be a special extension of N to T. Then $U_{\alpha\beta} \cap N' = \emptyset$ for every $(\alpha, \beta) \in M$ by the property of special extensions. If $x \notin F$, then $x \in T_i - F$ for some i. Since \mathscr{U}_{i-1} is locally finite at x, there exists an open neighborhood N of x in $F \cup$

 $(T_1\cup\cdots\cup T_i)$ such that $N\cap U_{\alpha}(\delta_0, \cdots, \delta_{i-1}) = \emptyset$ for every $(\alpha, \beta) \in M$, $\beta = (\delta_0, \cdots, \delta_{k-1})$. Let N' be a special extension of N to T, if $i \neq k$. If i = k, let N' = N. Since $U_{\alpha\beta} \subset U_{\alpha}(\delta_0, \cdots, \delta_{i-1})'$ and $U_{\alpha}(\delta_0, \cdots, \delta_{i-1})' \cap N' = \emptyset$ for every $(\alpha, \beta) \in M$, $\beta = (\delta_0, \cdots, \delta_{i-1})$, $N' \cap U_{\alpha\beta} = \emptyset$ for every $(\alpha, \beta) \in M$. Therefore in either case $p \notin \bigcup \{U_{\alpha\beta} : (\alpha, \beta) \in M\}$, proving that \mathscr{V} is closure-preserving in T. Let U be an open set of T such that $U \cap F = U_{\alpha}$ for some α . Then since \mathscr{U}_1 is uniformly approacing in $F \cup T_1$, there exists a $\delta_0 \in \Delta(\alpha)$ such that $U_{\alpha}(\delta_0) \subset U$. Similarly we can choose $\delta_1 \in \Delta(\alpha, \delta_0)$ such that $U_{\alpha}(\delta_0, \delta_1) \subset U$. Repeating this process, we get $\beta = (\delta_0, \cdots, \delta_{k-1})$ such that $U_{\alpha\beta} \subset U$. This completes the proof.

As stated in the introduction, every closed image of an *n*-paracomplex is at least stratifiable, and consequently it is a σ -space, that is, it has a σ -discrete closed network. In the next proof, a collection \mathscr{F} of subsets of a space T is said to be *local network* of a point $x \in T$ if $x \in U$ with U open in T implies $x \in F \subset U$ for some $F \in \mathscr{F}$.

LEMMA 7. Every closed image of an n-paracomplex is an M_1 -space.

Proof. Since every closed image of a 0-paracomplex is a Lašnev space, it is an M_1 -space, [6]. Assume that every closed image of an *n*-paracomplex is an M_1 -space. Let $g: Z = X \bigcup_f Y \to T$ be a closed mapping of an n + 1-paracomplex Z onto T, where X is a metric space, Y is an *n*-paracomplex and f is a mapping of a closed set H into Y. By the induction assumption, g(p(Y)) is an M_1 -space. Therefore g(p(Y)) has a σ -closure-preserving base $\mathscr{U} = \{U_{\alpha}: \alpha \in A\}$. By Lemma 6 T is *cp*-expandable and g(p(Y)) is closed in T. We apply the *cp*-expandability of T to \mathscr{U} to get a σ -closure-preserving open collection $\mathscr{U}_0 = \{U_{\alpha\beta}: \beta \in B_{\alpha}, \alpha \in A\}$ of T such that

$$U_{lphaeta}\cap g(p(Y))=U_{lpha} ext{ for } eta\in B_{lpha}, \ lpha\in A$$
 ,

and such that if $U \cap g(p(Y)) = U_{\alpha}$ for an $\alpha \in A$ and for an open set U of T, then $U_{\alpha\beta} \subset U$ for some $\beta \in B_{\alpha}$. Let F be an arbitrary closed set of T such that $F \cap g(p(Y)) = \emptyset$. Then it is obvious that $g^{-1}(F)$ has a uniformly approaching anti-cover in Z. Thus by Lemma 2, F has a (uniformly) approaching anti-cover in T. Therefore by Fact 2 F has a closure-preserving open neighborhood base $\mathscr{U}(F)$ in T. Let $\mathscr{F} = \bigcup_{i=1}^{\infty} \mathscr{F}_i$, with each \mathscr{F}_i discrete in T, be a closed collection of T, which is a local network of each point of T - g(p(Y)) in T. By the paracompactness of T, there exists for

each $i \in N$ a discrete open collection $\{H(F): F \in \mathscr{F}_i\}$ such that $F \subset H(F)$ and $H(F) \cap g(p(Y)) = \emptyset$ for every $F \in \mathscr{F}_i$. Set

$$\mathcal{U}'(F) = \{ U \in \mathcal{U}(F) \colon U \subset H(F) \},\$$
$$\mathcal{U}_1 = \bigcup \{ \mathcal{U}'(F) \colon F \in \mathcal{F} \},\$$
$$\mathcal{W} = \mathcal{U}_0 \cup \mathcal{U}_1.$$

Since $\bigcup \{ \mathscr{U}'(F) : F \in \mathscr{F}_i \}$ is closure-preserving in T, \mathscr{W} is a σ -closure-preserving open collection. It is obvious that \mathscr{W} is a base for T. Hence T is an M_1 -space.

3. Theorems.

THEOREM 1. Every closed image of a paracomplex is an M_1 -space.

Proof. Let $f: X \to Y$ be a closed mapping of a paracomplex Xonto Y. Let $\{X_i: i \in N\}$ be a closed cover of X stated in Definition 2. Since X_1 is an n_1 -paracomplex, by Lemma 7 there exists a σ -closure-preserving base $\mathscr{U} = \bigcup_{m=1}^{\infty} \mathscr{U}_m$ for $f(X_1)$, where each $\mathscr{U}_m =$ $\{U(\alpha): \alpha \in A_m\}$ is a closurepreserving open collection of $f(X_1)$. Observe that $f(X_2)$ is *cp*-expandable by Lemma 6 and that $f(X_1)$ is closed in $f(X_2)$. Therefore for each $\alpha_1 \in A_m$, there exists an open collection $\{U(\alpha_1, \alpha_2): \alpha_2 \in A_m(\alpha_1)\}$ of $f(X_2)$ such that

$$U(lpha_1, \, lpha_2) \cap f(X_1) = U(lpha_1), \ U(lpha_1, \, lpha_2) \subset U(lpha_1)'$$
,

where $U(\alpha_1)'$ is a special extension of $U(\alpha_1)$ to $f(X_2)$ and such that (1) { $U(\alpha_1, \alpha_2): \alpha_2 \in A_m(\alpha_1), \alpha_1 \in A_m$ } is closure-preserving in $f(X_2)$, and

(2) if V is an open set of $f(X_2)$ with $V \cap f(X_1) = U(\alpha_1)$ for an $\alpha_1 \in A_m$, then $U(\alpha_1, \alpha_2) \subset V$ for some $\alpha_2 \in A_m(\alpha_1)$.

Again by the *cp*-expandability of $f(X_3)$, we define the following collection: For each (α_1, α_2) with $\alpha_2 \in A_m(\alpha_1)$, $\alpha_1 \in A_m$, there corresponds an open collection $\{U(\alpha_1, \alpha_2, \alpha_3): \alpha_3 \in A_m(\alpha_1, \alpha_2)\}$ of $f(X_3)$ such that

$$egin{aligned} U(lpha_1,\,lpha_2,\,lpha_3)\cap f(X_2)&=U(lpha_1,\,lpha_2)\ ,\ U(lpha_1,\,lpha_2,\,lpha_3)\subset U(lpha_1,\,lpha_3)'\ , \end{aligned}$$

where $U(\alpha_1, \alpha_2)'$ is a special extension of $U(\alpha_1, \alpha_2)$ to $f(X_3)$, and such that

(1)' the collection $\{U(\alpha_1, \alpha_2, \alpha_3): \alpha_3 \in A_m(\alpha_1, \alpha_2), \}$

 $\alpha_2 \in A_m(\alpha_1), \ \alpha_1 \in A_m$ is closure-preserving in $f(X_3)$, and

(2)' if V is an open set of $f(X_3)$ with $V \cap f(X_2) = U(\alpha_1, \alpha_2)$ for an $\alpha_2 \in A_m(\alpha_1)$, $\alpha_1 \in A_m$, then $U(\alpha_1, \alpha_2, \alpha_3) \subset V$ for some $\alpha_3 \in A_m(\alpha_1, \alpha_2)$. Repeating this process, for each $i \in N$ we get a closure-preserving open collection $\{U(\alpha_1, \dots, \alpha_i): \alpha_i \in A_m(\alpha_1, \dots, \alpha_{i-1}), \dots, \alpha_1 \in A_m\}$, which satisfies the conditions corresponding to (1), (1)' and (2), (2)'. For each sequence $\mu = (\alpha_1, \alpha_2, \dots)$ with $\alpha_1 \in A_m$, $\alpha_2 \in A_m(\alpha_1), \dots$, we set

$$U_{\mu} = igcup_{i=1}^{\infty} U(lpha_{\scriptscriptstyle 1}, \, \cdots, \, lpha_{\scriptscriptstyle n}) \; .$$

Set

$$\mathscr{W}(m) = \{ U_{\mu}: \mu = (\alpha_1, \alpha_2, \cdots), \alpha_1 \in A_m, \alpha_2 \in A_m(\alpha_1), \cdots \},$$

 $\mathscr{W}_1 = \bigcup \{ \mathscr{W}(m): m \in N \}.$

First, it is shown that each $\mathscr{W}(m)$ is closure-preserving open collection of Y. Indeed, take a $U_{\mu} \in \mathscr{W}(m)$, $\mu = (\alpha_1, \alpha_2, \cdots)$. Then U_{μ} is open in Y because

$$U_{\mu} \cap f(X_i) = U(\alpha_1, \cdots, \alpha_i), \ i \in N$$

is open in $f(X_i)$ and $\{f(X_i): i \in N\}$ dominates Y. Let M be an arbitrary subset of $\{\mu = (\alpha_1, \alpha_2, \cdots): \alpha_1 \in A_m, \alpha_2 \in A_m(\alpha_1), \alpha_3 \in A_m(\alpha_1, \alpha_2), \cdots\}$ and suppose $x \in \overline{U}_{\mu}$ for every $\mu \in M$. There exists an $i \in N$ such that $x \in f(X_i)$. Since $\{U(\alpha_1, \cdots, \alpha_i): \mu = (\alpha_1, \alpha, \cdots) \in M\}$ is closure-preserving in $f(X_i)$ by (1), (1)', \cdots , there exists an open neighborhood N of x in $f(X_i)$ such that

$$N \cap (\bigcup \{ U(\alpha_1, \cdots, \alpha_i) : \mu = (\alpha_1, \alpha_2, \cdots) \in M \}) = \phi .$$

Let N_{i+1} be a special extension of N to $f(X_{i+1})$. For each $j \ge 2$, let N_{i+j} be a special extension of N_{i+j-1} to $f(X_{i+j})$. Set $E(N) = \bigcup_{j=1}^{\infty} N_{i+j}$. Then E(N) is an open neighborhood of x in Y such that

$$E(N) \cap (\bigcup \{U_{\mu}: \mu \in M\}) = \phi$$
.

Therefore $x \in \bigcup \{U_n: \mu \in M\}$, which proves that $\mathscr{W}(m)$ is closurepreserving in Y. Secondly, we show that \mathscr{W}_1 is a local base of each point x of $f(X_1)$ in Y. To see this, let $x \in V$ for an open set V of Y and a point x of $f(X_1)$. Since \mathscr{U} is a base for $f(X_1)$, there exists an $\alpha_1 \in A_m$, $m \in N$, such that $x \in U(\alpha_1) \subset V$. By (2) and (2)', there exist $\alpha_2 \in A_m(\alpha_1)$ and $\alpha_3 \in A_m(\alpha_1, \alpha_2)$ such that $x \in U(\alpha_1, \alpha_2, \alpha_3) \subset$ V. Inductively we can get an α_i such that $x \in U(\alpha_1, \cdots, \alpha_i) \subset V$. Therefore $x \in U_{\mu} \subset V$ for $\mu = (\alpha_1, \alpha_2, \cdots)$. By the same way as \mathscr{W}_1 , we can construct a σ -closure-preserving open collection \mathscr{W}_i of Y which is a local base of each point of $f(X_i)$ in Y. Then $\mathscr{W} = \bigcup_{i=1}^{\infty} \mathscr{W}_i$ is a σ -closure-preserving base for Y, proving that Y is an M_1 -space.

We consider the dimension for the closed image of a paracomplex. To state it, we prepare some definitions and some lemmas.

DEFINITION 6 ([4, Definition 3.4]). A collection $\mathscr{T} = \{(H_{\alpha}, K_{\alpha}): \alpha \in A\}$ of disjoint pairs of closed sets of a space X is said to determine Ind X if there exists a pair $(H_{\alpha}, K_{\alpha}) \in \mathscr{T}$ such that for each closed set P separating H_{α} and K_{α} , Ind $P \geq \text{Ind } X - 1$. Let M be subset of X. Then \mathscr{T} is said to determine Ind M if $\mathscr{T} \mid M$ determines Ind M.

It is proved in [4, Theorem 4.1] that if X is a paracompact σ -space which has a countable collection of disjoint pairs of closed sets determining Ind of all closed sets of X, then Ind $X = \dim X$, and it is also proved in [4, Lemma 3.5] that every L-space has such a collection. Since every Lašnev space is an L-space, [4, Theorem 1.6], every Lašnev space has such a collection. Since every closed image of a paracomplex is a paracompact σ -space and is the countable union of closed Lašnev spaces, it has a countable collection of disjoint pairs of closed sets determining Ind of all closed sets. Thus we have:

THEOREM 2. If X is a closed image of a paracomplex, then $\dim X = \operatorname{Ind} X$.

Let (A) be the statement that dim $X \leq n$ if and only if there exists a σ -closure-preserving base \mathscr{W} for X such that dim $B(W) \leq n-1$ for every $W \in \mathscr{W}$, where B(W) denotes the boundary of W in X.

As shown by J. Nagata, if X is a paracomplex, (A) hold for X. But we shall show in the next theorem that (A) holds for every closed image of a paracomplex. The proof is given by modifying the argument in Theorem 1.

DEFINITION 7. A space X is said to be *n*-dimensionally cp-expandabe if the following condition $(CP)_n$ is satisfies:

 $(CP)_n$ Let F be a closed set of X and $\mathscr{U} = \{U_{\alpha} : \alpha \in A\}$ a closure-preserving open collection of F such that dim $B_F(U_{\alpha}) \leq n-1$ for every $\alpha \in A$, where $B_F(U_{\alpha})$ denotes the boundary of U_{α} in F. Then there exists an open collection $\mathscr{V} = \{U_{\alpha\beta} : \beta \in B_{\alpha}, \ \alpha \in A\}$ of X with $U_{\alpha\beta} \cap F = U_{\alpha}$ for every $\beta \in B_{\alpha}, \ \alpha \in A$, satisfying (1) and (2) stated in Definition 5 and the additional condition (3).

(3) dim $B(U_{\alpha\beta}) \leq n-1$ for every $\beta \in B_{\alpha}$, $\alpha \in A$.

LEMMA 8. Every closed image T with dim $T \leq n$ of an m-

paracomplex is n-dimensionally cp-expandable.

Proof. Suppose that we are given a closed mapping f of an m-paracomplex Z onto T with dim $T \leq n$. In this proof we use the same denotion as in the proof of Lemma 6. Let F be a closed set of T and $\mathscr{U} = \{U_{\alpha}: \alpha \in A\}$ a closure-preserving open collection of F such that dim $B_F(U_{\alpha}) \leq n-1$ for every $\alpha \in A$. Since T satisfies dim $T \leq n$, in addition to the assumption stated in the proof of Lemma 6 we can assume that

$$\dim B_{T_{1}-F}(U_{\scriptscriptstyle 0\alpha}) \leq n-1, \ \dim B_{T_{i+1}-F}(U_{\scriptscriptstyle i\alpha'}) \leq n-1$$

for every $\alpha \in A_0$ and for every $\alpha' \in A_i$, $i = 1, \dots, k-1$. It follows from an easy check that for each $\beta = (\delta_0, \dots, \delta_{k-1})$

$$B(U_{\alpha\beta}) \subset B_F(U_{\alpha}) \cup \left(\bigcup_{i=0}^{k-1} \{\bigcup_{\alpha \in \delta_i} B_{T_{i+1}-F}(U_{i\alpha})\}\right)$$

Then by the sum theorem we have

$$\dim B(U_{lphaeta}) \leqq n-1 ext{ for every } eta ext{ .}$$

Thus $(CP)_n$ is satisfied.

LEMMA 9. If T is a closed image of an m-paracomplex such that dim $T \leq n$, then there exists a σ -closure-preserving base \mathscr{W} for T such that dim $B(W) \leq n-1$ for every $W \in \mathscr{W}$.

Proof. Let $g: Z \to T$ be a closed mapping of an *m*-paracomplex Z onto T. Suppose dim $T \leq n$. If Z is a 0-paracomplex, then T is a Lašnev space and therefore by [3, Theorem 2] there exists a σ -closure-preserving base with the required property. Assume that every closed image of an *m*-paracomplex has such a base. Let $Z = X \bigcup_f Y$, where Y is an *m*-paracomplex and X is a metric space. By the induction assumption g(P(Y)) has a σ -closure-preserving base $\mathscr{U} = \{U_{\alpha}: \alpha \in A\}$ such that dim $B_{g(p(Y))}(U_{\alpha}) \leq n-1$ for every $\alpha \in A$. Since by Lemma 8 T is *n*-dimensionally *cp*-expandable, there exists an open collection $\mathscr{U}_0 = \{U_{\alpha\beta}: \beta \in B_{\alpha}, \alpha \in A\}$ of T satisfying the following:

(1) \mathcal{U}_0 is σ -closure-preserving in T.

(2) If $V \cap g(p(Y)) = U_{\alpha}$ for an $\alpha \in A$, then $U_{\alpha\beta} \subset V$ for some $\beta \in B_{\alpha}$.

(3) dim $B(U_{\alpha\beta}) \leq n-1$ for every $\beta \in B_{\alpha}$, $\alpha \in A$.

Let $\mathscr{F} = \bigcup_{i=1}^{\infty} \mathscr{F}_i$, $\{H(F): F \in \mathscr{F}_i\}$ be the same as in the proof of Lemma 7. By Lemma 2 every $F \in \mathscr{F}$ has a (uniformly) approaching anti-cover $\mathscr{V}_F = \{V_{\lambda}: \lambda \in \Lambda(F)\}$. Since dim $(T - g(p(Y))) \leq n$ and

T is hereditarily paracompact, we can assume that \mathscr{V}_F is locally finite in T - F and dim $B_{T-F}(V_{\lambda}) \leq n-1$ for every $\lambda \in \Lambda(F)$. Let $\Lambda(F)$ be the totality of subsets δ of $\Lambda(F)$ such that

$$V(\delta) = F \cup (\bigcup \{V_{\lambda}: \lambda \in \delta\})$$

is an open neighborhood of F in T. Then we have dim $B(V(\delta)) \leq n-1$ for every $\delta \in \Delta(F)$. Set

$$\begin{split} \mathscr{V}(F) &= \{ V(\delta) \colon V(\delta) \subset H(F), \ \delta \in \varDelta(F) \} , \\ \mathscr{V}_i &= \bigcup \left\{ \mathscr{V}(F) \colon F \in \mathscr{F}_i \right\} , \\ \mathscr{U}_1 &= \bigcup \left\{ \mathscr{V}_i \colon i \in N \right\} , \\ \mathscr{W} &= \mathscr{U}_0 \cup \mathscr{U}_1 . \end{split}$$

Then \mathcal{W} is the required base for T.

THEOREM 3. If Y is a closed image of a paracomplex, then Y satisfies (A).

Proof. Since by Theorem 1 is an M_1 -space, the if part of (A) is nothing but [5, Lemma 7]. Let $f: X \to Y$ be a closed mapping of a paracomplex X onto Y with dim $Y \leq n$. We use the same denotion as in the proof of Theorem 1. By Lemmas 8 and 9, we can take each $U(\alpha_1, \dots, \alpha_i)$ so that

$$\dim B_{f(X_i)}(U(\alpha_1, \cdots, \alpha_i)) \leq n-1.$$

From the construction of $U(\alpha_1, \dots, \alpha_i)$, we have dim $B(U_{\mu}) \leq n-1$ for every μ because

$$B(U_{\mu}) \subset \bigcup_{i=1}^{\infty} B_{f(X_i)}(U(\alpha_1, \cdots, \alpha_i)), \ \mu = (\alpha_1, \alpha_2, \cdots).$$

This completes the proof.

Acknowledgment. I would like to thank the refree for informing me that the main result, Theorem 1, of this paper is independently proved by Gary Gruenhage in his new paper "On the $M_3 \Rightarrow M_1$ question", the result of which states that the closed image of a stratifiable \mathscr{F} -metrizable space is M_1 .
