On Boundedness and Attractiveness of Nonlinear Switched Delay Systems

This paper is concerned with the boundedness and attractiveness of nonlinear switched delay systems whose subsystems have different equilibria. Some sufficient conditions which can guarantee the system's boundedness are obtained. In addition, we work out the region where the solution will remain and furthermore the relationship between the initial function and the bounded region. Based on the new concept of attractor with switching laws, we show that the nonlinear switched delay system is attractive and then obtain the attractive region.

1. Introduction

A switched system is a collection of finite continuous variable systems (called subsystems) along with a discrete event governing the "switching" among them (called the switching law). In reality, there are many switched systems that occur naturally or by design, such as those in the fields of control, communication, computer, and signal processes. Indeed, these systems are always suited to describe practical dynamical behaviors with hybrid nature in engineering and technology [1, 2]. In the last decades, they have attracted considerable attention among control theorists, computer scientists, and practicing engineers in the study of switched systems and switching control design and hence rich theoretical results have been obtained (see [3–20] and the references therein).

Up to now, most of the studies on switched systems require that all subsystems share a common equilibrium. However, in many real world problems, the assumption that all subsystems share a common equilibrium may not hold and thus the assumption may limit the applicability of stability results. Recently, it is pointed out in [21, 22] that, when

subsystems have different equilibria or no equilibrium, a switched system can still exhibit interesting behaviors under appropriate switching laws. Such behaviors are similar to those of a conventional bounded or stable system near an equilibrium point. In this paper, we introduce some boundedness and attractiveness notions to define such behaviors for switched delay systems. Such notions are extensions of the traditional boundedness and attractiveness concepts in [15, 16].

In this paper, we focus on the boundedness and attractiveness problems for a simple yet important class of nonlinear switched delay systems, which includes three main contributions. First, we propose the concept of attractor with the switching law and the notation of a function $\varphi \in C_{\tau}$ in the neighbourhood of a subset $\Omega \in \mathbb{R}^n$ which is different from the conventional concept of the distance between two subsets of \mathbb{R}^n . Second, we propose sufficient conditions which guarantee that the switched delay system is bounded or attractive. Third, we explicitly construct a switching law and the region in which the solutions remain (boundedness) and explicitly construct the attractor for the switched delay systems.

2. Problem Statement

Consider the nonlinear switched delay system

$$\dot{x} = A_{\gamma}x + f_{\gamma}\left(x\left(t-\tau\right)\right), \quad \gamma \in \mathbb{I} \triangleq \{1, 20, \dots, N\}, \quad (1)$$

where $x \in R^n$, $f_{\gamma} \in C(R^n, R^n)$, and $A_{\gamma} \in R^{n \times n}$, $\tau \ge 0$. It is assumed that

- (H1) there exist $\alpha > 0$, $M \ge 1$ such that $||e^{A_{\gamma}t}|| \le Me^{-\alpha t}$;
- (H2) there exists L, $0 < L < \alpha/M$, such that $||f_{\gamma}(x) f_{\nu}(y)|| \le L ||x y||$, $x, y \in \mathbb{R}^{n}, \gamma \in \mathbb{I}$;
- (H3) $A_{\gamma}x + f_{\gamma}(x) = 0$ has only one solution $x^{\gamma} \in \mathbb{R}^{n}$ and $x^{\gamma} \neq x^{l}$ for $\gamma \neq l, \gamma, l \in \mathbb{I}$.

Let $\Gamma = \{x_{\gamma}(t; 0, x^{j}), \gamma, j \in \mathbb{I}, t \in \mathbb{R}^{+}\}$, where

$$x_{\gamma}(t;0,x^{j}) = e^{A_{\gamma}t}x^{j} + \int_{0}^{t} e^{A_{\gamma}(t-u)}f_{\gamma}(x_{\gamma}(u-\tau))du \quad (2)$$

and denote that $\widetilde{D} = \max\{||x^{\gamma} - x^{j}||, \gamma \neq j, \gamma, j \in \mathbb{I}\}, C_{\tau} \triangleq C([-\tau, 0], R^{n})$, and for $\varphi \in C_{\tau}$, define

$$\left\|\varphi\right\|_{\tau} = \sup_{\theta \in [-\tau, 0]} \left\|\varphi\left(\theta\right)\right\|.$$

Let $x_{\gamma}(t; t_0, \varphi) \triangleq x_{\gamma}(t)$ be the solution of the initial value problem

$$\dot{x}_{\gamma}(t) = A_{\gamma}x_{\gamma} + f_{\gamma}\left(x_{\gamma}(t-\tau)\right),$$

$$x_{\gamma}(\theta) = \varphi(\theta), \quad \theta \in [-\tau, 0].$$

If $\varphi \equiv x^j$ especially, denote that $x_{\gamma}(t; t_0, x^j) \triangleq \tilde{x}_{\gamma}^j(t), j \in \mathbb{I}$, and let $x(t; t_0, \varphi, \sigma) \triangleq x(t)$ be the solution of (1) with the switching law σ as

$$\dot{x}(t) = A_{\gamma}x + f_{\gamma}(x(t-\tau)), \quad \gamma \in \mathbb{I},$$

$$x(\theta) = \varphi(\theta), \quad \theta \in [-\tau, 0],$$

where $x_t \triangleq x(t + \theta), \theta \in [-\tau, 0]$. Since all the subsystems are autonomous, we can take $t_0 = 0$ without loss of generality. Let $\sigma = ((t_1, i_1), \dots, (t_k, i_k), \dots)$ be the switching law of the switched system (1), where $i_k \in \mathbb{I}$ and $0 = t_0 < t_1 < \dots < t_k < \dots$; that is, under the switching law σ , the subsystem i_k is active during the time interval $[t_{k-1}, t_k)$. Suppose that $i_k \neq i_{k+1}$ holds, which means that a subsystem will be definitely switched to a different subsystem when the switching triggers.

3. Boundedness

In this section, we will study the boundedness problem of the switched delay system (1).

Definition 1. Suppose that $\delta > 0$, $\Omega \subset \mathbb{R}^n$, and then a neighborhood of Ω in C_{τ} is defined as

$$B_{\delta}(\Omega) = \left\{ \varphi \mid \varphi \in C_{\tau}, \sup_{\theta \in [-\tau,0]} \rho\left(\varphi\left(\theta\right), \Omega\right) \le \delta \right\}, \quad (6)$$

where the distance ρ between $x \in \mathbb{R}^n$ and Ω is defined as

$$\rho(x,\Omega) = \inf \left\{ \left\| x - y \right\| \mid y \in \Omega \right\}.$$

Definition 2. A nonnegative number μ is called the dwell time of the switching law

$$\sigma = \left(\left(t_1, i_1 \right), \dots, \left(t_k, i_k \right), \dots \right), \tag{8}$$

if

$$\mu = \inf \left\{ \left| t_{k+1} - t_k \right|, k = 1, 2, \ldots \right\}$$

holds.

Lemma 3. Let μ be the dwell time of the switching law $\sigma = ((t_1, i_1), \ldots, (t_k, i_k), \ldots)$, and $\delta > 0$ is a constant. If $\mu \ge \max\{\tau, (\ln(M(\delta + \widetilde{D})/\delta))/(\alpha - ML)\}$, then $\varphi \in B_{\delta}(x^{i_0})$ implies that $x_{t_k} \in B_{\delta}(x^{i_k})$, where

$$x_{t_k} = x_{t_k} \left(\theta \right) = x \left(t_k + \theta, 0, \varphi, \sigma \right), \quad \theta \in \left[-\tau, 0 \right].$$
(10)

Proof. Suppose that $\varphi \in B_{\delta}(x^{i_0})$ and the switching law is defined as $\sigma = ((t_1, i_1), \dots, (t_k, i_k), \dots)$. Then, we will use induction to prove the result. When $m = 1, t \in [0, t_1]$, we will prove that

$$\sup_{\mathbf{t}\in[-\tau,0]} \left\| x\left(t_1+\theta,0,\varphi,\sigma\right) - x^{i_1} \right\| \le \delta.$$

In fact,

$$\begin{aligned} \left\| x \left(t, 0, \varphi, \sigma\right) - x^{i_{1}} \right\| \\ &= \left\| x_{i_{1}} \left(t\right) - x^{i_{1}} \right\| \\ &= \left\| e^{A_{i_{1}}t} \varphi \left(0\right) + \int_{0}^{t} e^{A_{i_{1}}(t-u)} f_{i_{1}} \left(x_{i_{1}} \left(u-\tau\right)\right) du \\ &- e^{A_{i_{1}}t} x^{i_{1}} - \int_{0}^{t} e^{A_{i_{1}}(t-u)} f_{i_{1}} \left(x^{i_{1}}\right) du \right\| \\ &\leq \left\| e^{A_{i_{1}}t} \right\| \left\| \varphi \left(0\right) - x^{i_{1}} \right\| \\ &+ \int_{0}^{t} \left\| e^{A_{i_{1}}(t-u)} \right\| \left\| f_{i_{1}} \left(x_{i_{1}} \left(u-\tau\right)\right) - f_{i_{1}} \left(x^{i_{1}}\right) \right\| du \\ &\leq M e^{-\alpha t} \left\| \varphi \left(0\right) - x^{i_{1}} \right\| \\ &+ ML \int_{0}^{t} e^{-\alpha (t-u)} \left\| x_{i_{1}} \left(u-\tau\right) - x^{i_{1}} \right\| du. \end{aligned}$$

Then,

$$e^{\alpha t} \|x_{i_{1}}(t) - x^{i_{1}}\|$$

$$\leq M \|\varphi(0) - x^{i_{1}}\| + ML \int_{0}^{t} e^{\alpha u} \|x_{i_{1}}(u - \tau) - x^{i_{1}}\| du$$

$$\leq M \|\varphi(0) - x^{i_{1}}\| + ML \int_{0}^{t} e^{\alpha u} \|x_{i_{1}}(u - \tau) - x^{i_{1}}\| du$$

$$\leq M \left[\|\varphi(0) - x^{i_{0}}\| + \|x^{i_{0}} - x^{i_{1}}\| \right]$$

$$+ ML \int_{0}^{t} e^{\alpha u} \|x_{i_{1}}(u - \tau) - x^{i_{1}}\| du$$

$$\leq M \left[\delta + \widetilde{D} \right] + ML \int_{0}^{t} e^{\alpha u} \|x_{i_{1}u} - x^{i_{1}}\|_{\tau} du.$$

Furthermore, since the right hand side of the inequality is increasing function, we have

$$e^{\alpha t} \left\| x_{i_1 t} - x^{i_1} \right\|_{\tau} \le M \left[\delta + \widetilde{D} \right]$$

+ $ML \int_0^t e^{\alpha u} \left\| x_{i_1 u} - x^{i_1} \right\|_{\tau} du,$ (14)

and then, by applying the Bellman-Gronwall inequality to (14), we have

$$e^{\alpha t} \left\| x_{i_1 t} - x^{i_1} \right\|_{\tau} \le M \left[\delta + \widetilde{D} \right] e^{M L t}, \tag{15}$$

and thus

$$\left\|x_{i_1t} - x^{i_1}\right\|_{\tau} \le M\left[\delta + \widetilde{D}\right] e^{-(\alpha - ML)t}.$$
(16)

Let $t = t_1$; we get

$$\|x_{t_1} - x^{i_1}\|_{\tau} = \|x_{i_1t_1} - x^{i_1}\|_{\tau} \le M \left[\delta + \widetilde{D}\right] e^{-(\alpha - ML)t_1} \le \delta,$$
(17)

and (11) is proved. Suppose that, when m = k, the result is right; that is, $x_{t_k} \in B_{\delta}(x^{i_k})$, and then we will prove that $x_{t_{k+1}} \in B_{\delta}(x^{i_{k+1}})$; that is,

$$\sup_{\theta \in [-\tau,0]} \left\| x \left(t_{k+1} + \theta, 0, \varphi, \sigma \right) - x^{i_{k+1}} \right\| \le \delta.$$
(18)

In fact, when $t \in [t_k, t_{k+1}]$, $x(t, 0, \varphi, \sigma) = x_{i_{k+1}}(t - t_k, 0, x_{t_k})$, and thus

$$\begin{aligned} \left\| x\left(t,0,\varphi,\sigma\right) - x^{i_{k+1}} \right\| \\ &= \left\| x_{i_{k+1}}\left(t - t_{k},0,x_{t_{k}}\right) - x^{i_{k+1}} \right\| \\ &= \left\| e^{A_{i_{k+1}}(t-t_{k})} x_{t_{k}}\left(0\right) \\ &+ \int_{0}^{t-t_{k}} e^{A_{i_{k+1}}(t-t_{k}-u)} f_{i_{k+1}}\left(x_{i_{k+1}}\left(u - \tau\right)\right) du \\ &- e^{A_{i_{k+1}}(t-t_{k})} x^{i_{k+1}} \\ &- \int_{0}^{t-t_{k}} e^{A_{i_{k+1}}(t-t_{k}-u)} f_{i_{k+1}}\left(x^{i_{k+1}}\right) du \right\| \qquad (19) \\ &\leq \left\| e^{A_{i_{k+1}}(t-t_{k})} \right\| \left\| x_{t_{k}}\left(0\right) - x^{i_{k+1}} \right\| \\ &+ \int_{0}^{t-t_{k}} \left\| e^{A_{i_{k+1}}(t-t_{k}-u)} \right\| \\ &\times \left\| f_{i_{k+1}}\left(x_{i_{k+1}}\left(u - \tau\right)\right) - f_{i_{k+1}}\left(x^{i_{k+1}}\right) \right\| du \\ &\leq M e^{-\alpha(t-t_{k})} \left\| x_{t_{k}}\left(0\right) - x^{i_{k+1}} \right\| \\ &+ ML \int_{0}^{t-t_{k}} e^{-\alpha(t-t_{k}-u)} \left\| x_{i_{k+1}}\left(u - \tau\right) - x^{i_{k+1}} \right\| du, \end{aligned}$$

and then we have

$$e^{\alpha(t-t_{k})} \|x_{i_{k+1}}(t-t_{k},0,\varphi) - x^{i_{k+1}}\|$$

$$\leq M \|x_{t_{k}}(0) - x^{i_{k+1}}\|$$

$$+ ML \int_{0}^{t-t_{k}} e^{\alpha u} \|x_{i_{k+1}}(u-\tau) - x^{i_{k+1}}\| du$$

$$\leq M [\|x_{t_{k}}(0) - x^{i_{k}}\| + \|x^{i_{k}} - x^{i_{k+1}}\|]$$

$$+ ML \int_{0}^{t-t_{k}} e^{\alpha u} \|x_{i_{k+1}}(u-\tau) - x^{i_{k+1}}\| du$$

$$\leq M [\delta + \widetilde{D}] + ML \int_{0}^{t-t_{k}} e^{\alpha u} \|x_{i_{k+1}}u - x^{i_{k+1}}\|_{\tau} du.$$
(20)

Since the right hand side of the inequality is increasing function, we have

$$e^{\alpha(t-t_{k})} \left\| x_{i_{k+1}(t-t_{k})} - x^{i_{k+1}} \right\|_{\tau}$$

$$\leq M \left[\delta + \widetilde{D} \right] + ML \int_{0}^{t-t_{k}} e^{\alpha u} \left\| x_{i_{k+1}u} - x^{i_{k+1}} \right\|_{\tau} du.$$
(21)

Applying the Bellman-Gronwall inequality to (21) yields

$$\|x_{i_{k+1}(t-t_k)} - x^{i_{k+1}}\|_{\tau} = \|x_t - x^{i_{k+1}}\|_{\tau}$$

$$\leq M \left[\delta + \widetilde{D}\right] e^{-(\alpha - ML)(t-t_k)}.$$
 (22)

Let $t = t_{k+1}$, and then we get

$$\left\|x_{t_{k+1}} - x^{i_{k+1}}\right\|_{\tau} \le M\left[\delta + \widetilde{D}\right] e^{-(\alpha - ML)(t_{k+1} - t_k)} \le \delta, \quad (23)$$

and (18) is proved. The proof is completed. $\hfill \Box$

Remark 4. Lemma 3 shows that if the initial function φ is in the δ neighborhood of x^{i_0} , then the solution $x(t, 0, \varphi, \sigma)$ with the switching law σ whose dwell time satisfies $\mu \ge \max\{\tau, (\ln(M(\delta + \widetilde{D})/\delta))/(\alpha - ML)\}$ has the following property: at the *k*th switching point, the function $x(t_k + \theta, 0, \varphi, \sigma)(\theta \in [-\tau, 0])$ is in the δ neighborhood of x^{i_k} .

Theorem 5. Let μ be the dwell time of the switching law $\sigma = ((t_1, i_1), \dots, (t_k, i_k), \dots)$ and $\delta > 0$ is a constant. If $\mu \ge \max\{\tau, \ln(M(\delta + \widetilde{D})/\delta)/(\alpha - ML)\}$, then $\varphi \in B_{\delta}(x^{i_0})$ implies that the solution $x(t, 0, \varphi, \sigma)$ of (1) satisfies $x(t) \in B_{M\delta}(\Gamma)$.

Proof. We use mathematical induction to prove the result. When $t \in [0, t_1]$,

$$\begin{split} \rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) &\leq \left\|x\left(t,0,\varphi,\sigma\right)-x\left(t,0,x^{i_{0}},\sigma\right)\right\| \\ &= \left\|x_{i_{1}}\left(t,0,\varphi,\sigma\right)-\tilde{x}_{i_{1}}\left(t,0,x^{i_{0}}\right)\right\| \\ &= \left\|x_{i_{1}}\left(t\right)-\tilde{x}_{i_{1}}\left(t\right)\right\| \\ &= \left\|e^{A_{i_{1}}t}\varphi\left(0\right)+\int_{0}^{t}e^{A_{i_{1}}\left(t-u\right)}f_{i_{1}}\left(x_{i_{1}}\left(u-\tau\right)\right)du \\ &-e^{A_{i_{1}}t}x^{i_{0}}-\int_{0}^{t}e^{A_{i_{1}}\left(t-u\right)}f_{i_{1}}\left(\tilde{x}_{i_{1}}\left(u-\tau\right)\right)du\right\| \\ &\leq \left\|e^{A_{i_{1}}t}\left(\varphi\left(0\right)-x^{i_{0}}\right)\right\| \\ &+ \left\|\int_{0}^{t}e^{A_{i_{1}}\left(t-u\right)}\left(f_{i_{1}}\left(x_{i_{1}}\left(u-\tau\right)\right)-f_{i_{1}}\left(\tilde{x}_{i_{1}}\left(u-\tau\right)\right)\right)du\right\| \\ &\leq Me^{-\alpha t}\left\|\varphi\left(0\right)-x^{i_{0}}\right\| \\ &+ LM\int_{0}^{t}e^{-\alpha(t-u)}\left\|x_{i_{1}}\left(u-\tau\right)-\tilde{x}_{i_{1}}\left(u-\tau\right)\right\|du \\ &\leq e^{-\alpha t}\left[M\delta+LM\int_{0}^{t}e^{\alpha u}\left\|x_{i_{1}u}-\tilde{x}_{i_{1}u}\right\|_{\tau}du\right],
\end{split}$$

$$(24)$$

which implies that

$$e^{\alpha t} \| x_{i_1 t} - \widetilde{x}_{i_1 t} \|_{\tau} \leq M\delta + LM \int_0^t e^{\alpha u} \| x_{i_1 u} - \widetilde{x}_{i_1 u} \|_{\tau} du,$$

$$\| x_{i_1 t} - \widetilde{x}_{i_1 t} \|_{\tau} \leq M\delta e^{-(\alpha - LM)t} \leq M\delta.$$
(25)

Thus, for $t \in [0, t_1]$ and $\varphi \in B_{\delta}$,

$$\rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) \le M\delta. \tag{26}$$

Suppose that, when $t \in [t_{k-1}, t_k]$, (26) holds. Now we prove that, when $t \in [t_k, t_{k+1}]$,

$$\rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) \le M\delta. \tag{27}$$

In fact, by Lemma 3, we know that $x_{t_k} \in B_{\delta}(x^{i_k})$ and

$$\begin{split} \rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) &\leq \left\|x\left(t,0,\varphi,\sigma\right)-\bar{x}_{i_{k+1}}^{i_{k}}\left(t-t_{k},0,x^{i_{k}}\right)\right\| \\ &= \left\|x_{i_{k+1}}\left(t-t_{k},0,x_{t_{k}},\sigma\right)-\bar{x}_{i_{k+1}}^{i_{k}}\left(t-t_{k},0,x^{i_{k}}\right)\right\| \\ &= \left\|x_{i_{k+1}}\left(t-t_{k}\right)-\bar{x}_{i_{k+1}}^{i_{k}}\left(t-t_{k}\right)\right\| \\ &= \left\|e^{A_{i_{k+1}}\left(t-t_{k}\right)}x_{t_{k}}\left(0\right) \\ &+ \int_{0}^{t-t_{k}}e^{A_{i_{k+1}}\left(t-t_{k}-u\right)}f_{i_{k+1}}\left(x_{i_{k+1}}\left(u-\tau\right)\right)du \\ &- e^{A_{i_{k+1}}\left(t-t_{k}\right)}x^{i_{k}} \\ &- \int_{0}^{t-t_{k}}e^{A_{i_{k+1}}\left(t-t_{k}-u\right)}f_{i_{k+1}}\left(\bar{x}_{i_{k+1}}^{i_{k}}\left(u-\tau\right)\right)du\right\| \\ &\leq Me^{-\alpha\left(t-t_{k}\right)}\left\|x_{t_{k}}\left(0\right)-x^{i_{k}}\right\| \\ &+ LM\int_{0}^{t-t_{k}}e^{-\alpha\left(t-t_{k}-u\right)}\left\|x_{i_{k+1}}\left(u-\tau\right)-\bar{x}_{i_{k+1}}^{i_{k}}\left(u-\tau\right)\right\|du \\ &\leq e^{-\alpha\left(t-t_{k}\right)}\left[M\delta + LM\int_{0}^{t-t_{k}}e^{\alpha u}\left\|x_{i_{k+1}}u-\bar{x}_{i_{k+1}}^{i_{k}}u\right\|_{\tau}du\right], \end{split}$$

$$(28)$$

which implies that

$$\left\|x_{i_{k+1}}(t-t_k) - \tilde{x}_{i_{k+1}}^{i_k}(t-t_k)\right\|_{\tau} \le M\delta e^{-(\alpha - LM)(t-t_k)} \le M\delta$$
(29)

and thus

$$\rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) \le \left\|x_{i_{k+1}}(t-t_k) - \widetilde{x}_{i_{k+1}}^{i_k}(t-t_k)\right\|_{\tau} \le M\delta.$$
(30)

Thus, for all $t \ge 0$, we have

$$\rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) \le M\delta. \tag{31}$$

The proof is completed.

Remark 6. (i) The result in Theorem 5 shows that if the initial function φ is in the δ neighborhood of x^{i_0} , then the solution $x(t, 0, \varphi, \sigma)$ with the switching law whose dwell time satisfies $\mu \geq \max\{\tau, (\ln(M(\delta + \widetilde{D})/\delta))/(\alpha - ML)\}$ is in the $M\delta$ neighborhood of the set Γ .

(ii) Theorem 5 not only shows the boundedness of the switched system but also gives the region in which the solution will remain.

By the same procedure of Lemma 3 and Theorem 5, we can study the boundedness of the solution of the following nonlinear switched multidelays system:

$$\dot{x} = A_{\gamma}x + \sum_{j=1}^{P} f_{\gamma j}\left(x, x\left(t - \tau_{\gamma j}\right)\right), \quad \gamma \in \mathbb{I} \triangleq \{1, 2, \dots, N\},$$
(32)

where $x \in \mathbb{R}^n$, $f_{\gamma j} \in C(\mathbb{R}^n \times \mathbb{R}^n, \mathbb{R}^n)$, $A_{\gamma} \in \mathbb{R}^{n \times n}$, and $0 \le \tau_{\gamma j} \le \tau$.

Assume that

- (H1)' there exist $\alpha > 0$, $M \ge 1$ such that $||e^{A_{\gamma}t}|| \le Me^{-\alpha t}$;
- (H2)' there exists $L, 0 < L < \alpha/2PM$, such that $||f_{\gamma j}(x_1, x_2) f_{\gamma j}(y_1, y_2)|| \le L[||x_1 y_1|| + ||x_2 y_2||], x_1, x_2, y_1, y_2 \in \mathbb{R}^n, \gamma \in \mathbb{I}$, and j = 1, 2, ..., P;
- (H3)' $A_{\gamma}x + \sum_{j=1}^{p} f_{\gamma j}(x, x) = 0$ has only one solution $x^{\gamma} \in \mathbb{R}^{n}$ and $x^{j} \neq x^{l}$ for $j \neq l, j, l \in \mathbb{I}$.

Let $\Gamma' = {\tilde{x}_i^j(t; 0, x^j), i, j \in \mathbb{I}, t \in R^+}$. Similarly, we can obtain the following.

Lemma 7. Let μ be the dwell time of the switching law $\sigma = ((t_1, i_1), \ldots, (t_k, i_k), \ldots)$, and $\delta > 0$ is a constant. If $\mu \ge \max\{\tau, (\ln(M(\delta + \widetilde{D})/\delta))/(\alpha - 2PML)\}$, then $\varphi \in B_{\delta}(x^{i_0})$ implies that the solution $x(t, 0, \varphi, \sigma)$ of (32) satisfies $x_{t_k} \in B_{\delta}(x^{i_k})$.

Theorem 8. Let μ be the dwell time of the switching law $\sigma = ((t_1, i_1), \dots, (t_k, i_k), \dots)$, and $\delta > 0$ is a constant. If $\mu \ge \max\{\tau, (\ln(M(\delta + \widetilde{D})/\delta))/(\alpha - 2PML)\}$, then $\varphi \in B_{\delta}(x^{i_0})$ implies that the solution $x(t, 0, \varphi, \sigma)$ of (32) satisfies $x(t) \in B_{M\delta}(\Gamma')$ for all $t \in \mathbb{R}^+$.

4. Attractiveness

In this section, we first give the concept of an attractor of the switched system with switching law, and then we study the existence of the attractor of the nonlinear switched delay system (1). We will establish sufficient conditions which guarantee the existence of the attractor and furthermore we can find out the switching law and the attractor of the switching delay system (1).

Definition 9. A set $\Omega \subset \mathbb{R}^n$ is called an attractor of the switched system (1) with a switching law σ , if there exists a $\delta > 0$ such that, for any $\varepsilon > 0$, there exists a T > 0, such that, for any $\varphi \in B_{\delta}(\Omega) \cap C_{\tau}$, $t \ge T$ implies $\rho(x(t, 0, \varphi, \sigma), \Omega) \le \varepsilon$.

Remark 10. According to Definition 9, Ω is an attractor of the switched system (1) with a switching law σ if and only if there exists $\delta > 0$ such that $\varphi \in B_{\delta}(\Omega)$ implies

$$\lim_{t \to \infty} x(t, 0, \varphi, \sigma) = 0.$$
(33)

In this section, we will prove that Γ is the attractor of system (1). For convenience, we first show that

$$\varphi \in B_{\delta}(\Gamma) \Longrightarrow \lim_{t \to \infty} x(t, 0, \varphi, \sigma) = 0$$
(34)

is equivalent to

$$\varphi \in B_{\delta}\left(x^{i}\right) \Longrightarrow \lim_{t \to \infty} x\left(t, 0, \varphi, \sigma\right) = 0.$$
 (35)

Lemma 11. For any given $\varepsilon > 0$, $\lambda > 0$, there exists $T(\varepsilon, \lambda) = \ln(M\Delta/\lambda\varepsilon)/(\alpha - ML) > 0$ such that if $\varphi \in B_{\varepsilon}(\Gamma)$, $\varphi \in C_{\tau}$, then the solution $x_i(t, 0, \varphi)$ of the ith subsystem of (1) satisfies $x_{it} \in B_{\lambda\varepsilon}(x^i)$, $t \ge T$, where $\Delta \triangleq \sup\{\|x - y\|, x, y \in B_{\varepsilon}(\Gamma)\}$, If $\varphi \in B_{\varepsilon}(x^j)$ and $\varphi \in C_{\tau}$ especially, then one can take $T(\varepsilon, \lambda) = \ln(M(\varepsilon + \widetilde{D})/\lambda\varepsilon)/(\alpha - ML) > 0$ such that when $t \ge T$ implies the solution of the ith subsystem of (1) $x_i(t, 0, \varphi)$ satisfies $x_{it} \in B_{\lambda\varepsilon}(x^i)$.

Proof. Let $x_i(t, 0, \varphi) \triangleq x_i(t)$ be the solution of the *i*th subsystem of (1) and $\varphi \in B_{\varepsilon}(\Gamma)$, and then

$$\begin{aligned} \left\| x_{i}(t) - x^{i} \right\| \\ &= \left\| e^{A_{i}t}\varphi(0) + \int_{0}^{t} e^{A_{i}(t-u)} f_{i}\left(x_{i}\left(u-\tau\right)\right) du \\ &- e^{A_{i}t}x^{i} - \int_{0}^{t} e^{A_{i}(t-u)} f_{i}\left(x^{i}\right) du \right\| \\ &\leq \left\| e^{A_{i}t}\left(\varphi(0) - x^{i}\right) \right\| \qquad (36) \\ &+ \left\| \int_{0}^{t} e^{A_{i}(t-u)} \left[f_{i}\left(x_{i}\left(u-\tau\right)\right) - f_{i}\left(x^{i}\right) \right] du \right\| \\ &\leq M e^{-\alpha t} \left\| \varphi(0) - x^{i} \right\| \\ &+ \int_{0}^{t} M L e^{-\alpha(t-u)} \left\| x_{i}\left(u-\tau\right) - x^{i} \right\| du, \end{aligned}$$

which implies that

at II

$$e^{\alpha t} \|x_{it} - x^{i}\|_{\tau} \le M \|\varphi - x^{i}\|_{\tau} + ML \int_{0}^{t} e^{\alpha u} \|x_{iu} - x^{i}\|_{\tau} du$$
(37)

and thus

$$\left\|x_{it} - x^{i}\right\|_{\tau} \le M\Delta e^{-(\alpha - ML)t}.$$
(38)

So, when $t > T = \ln(M\Delta/\lambda\epsilon)/(\alpha - ML)$, we have

i II

$$\|x_{it} - x^i\|_{\tau} \le \lambda \varepsilon$$
 and thus $x_{it} \in B_{\lambda \varepsilon}(x^i)$. (39)

If $\varphi \in B_{\varepsilon}(x^{j})$ specially, it follows from (37), that

$$e^{\alpha u} \|x_{it} - x^{i}\|_{\tau}$$

$$\leq M \|\varphi - x^{i}\|_{\tau} + ML \int_{0}^{t} e^{\alpha u} \|x_{iu} - x^{i}\|_{\tau} du$$

$$\leq M \left[\|\varphi - x^{j}\|_{\tau} + \|x^{j} - x^{i}\| \right]$$

$$+ ML \int_{0}^{t} e^{\alpha u} \|x_{iu} - x^{i}\|_{\tau} du$$

$$\leq M \left[\varepsilon + \widetilde{D} \right] + ML \int_{0}^{t} e^{\alpha u} \|x_{iu} - x^{i}\|_{\tau} du,$$
(40)

which implies that

$$\left\|x_{it} - x^{i}\right\|_{\tau} \le M\left[\varepsilon + \widetilde{D}\right]e^{-(\alpha - ML)t}$$
(41)

and thus, when $t \ge T = \ln(M(\varepsilon + \widetilde{D})/\lambda\varepsilon)/(\alpha - ML)$, we have $\|x_{it} - x^i\|_{\tau} \le \lambda\varepsilon$; that is, $x_{it} \in B_{\lambda\varepsilon}(x^i)$. This completes the proof.

Theorem 12. Suppose that the dwell time μ of the switching law $\sigma = \{(t_1, i_1), (t_2, i_2), \ldots\}$ satisfies $t_1 \ge \ln(M\Delta/\lambda\varepsilon)/(\alpha - ML)$. If $\mu \ge \max\{\tau, \ln(M\Delta/\lambda\varepsilon)/(\alpha - ML)\}$, then the set Γ is an attractor of the switched delay system (1).

Proof. From Lemma 11, we can see that we only need to prove that, for any $\varphi \in C_{\tau}$, $\varphi \in B_1(\cup_{i=1}^N x^i)$, the solution $x(t, 0, \varphi, \sigma)$ satisfies $\lim_{t \to \infty} \rho(x(t, 0, \varphi, \sigma,), \Gamma) = 0$. In fact, we take $\varepsilon = 1$ and $\lambda = 1/2$ in Lemma 11, and then $\varphi \in C_{\tau}$ and $\varphi \in B_1(x^{i_0})(i_0 \in \mathbb{I})$ implies that $x_{t_k} \in B_{1/2^k}(x^{i_k})$ if $\mu \geq \ln[2M(1 + \widetilde{D})]/(\alpha - ML), k = 1, 2, \dots$ On the other hand, for $t \in [0, t_1]$, we have

$$\rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) = \rho\left(x_{i_{1}}\left(t,0,\varphi\right),\Gamma\right) \triangleq \rho\left(x_{i_{1}}\left(t\right),\Gamma\right) \\
= \inf\left\{\left\|x_{i_{1}}\left(t\right) - y\right\|, y \in \Gamma\right\} \\
\leq \left\|x_{i_{1}}\left(t\right) - x_{i_{1}}\left(t,0,x^{i_{0}}\right)\right\| \\
= \left\|x_{i_{1}}\left(t\right) - \tilde{x}_{i_{1}}^{i_{0}}\left(t\right)\right\| \\
= \left\|e^{A_{i_{1}}t}\varphi\left(0\right) + \int_{0}^{t} e^{A_{i_{1}}\left(t-u\right)}f_{i_{1}}\left(x_{i_{1}}\left(u-\tau\right)\right)du \\
- e^{A_{i_{1}}t}x^{i_{0}} - \int_{0}^{t} e^{A_{i_{1}}\left(t-u\right)}f_{i_{1}}\left(\tilde{x}_{i_{1}}^{i_{0}}\left(u-\tau\right)\right)du\right\| \\
\leq \left\|e^{A_{i_{1}}t}\left(\varphi\left(0\right) - x^{i_{0}}\right)\right\| \\
+ \left\|\int_{0}^{t} e^{A_{i_{1}}\left(t-u\right)}\left[f_{i_{1}}\left(x_{i_{1}}\left(u-\tau\right) - f_{i_{1}}\left(\tilde{x}_{i_{1}}^{i_{0}}\left(u-\tau\right)\right)\right]du\right\| \\
\leq Me^{-\alpha t} \left\|\varphi\left(0\right) - x^{i_{0}}\right\| \\
+ \int_{0}^{t} MLe^{-\alpha(t-u)} \left\|x_{i_{1}}\left(u-\tau\right) - \tilde{x}_{i_{1}}^{i_{0}}\left(u-\tau\right)\right\|du,$$
(42)

which implies that

$$e^{\alpha t} \| x_{i_{1}}(t) - \tilde{x}_{i_{1}}^{i_{0}}(t) \|$$

$$\leq M \| \varphi - x^{i_{0}} \|_{\tau} + \int_{0}^{t} M L e^{\alpha u} \| x_{i_{1}u} - \tilde{x}_{i_{1}u}^{i_{0}} \|_{\tau} du.$$
(43)

Since the right hand side of the above inequality is an increasing function, we have

$$e^{\alpha t} \| x_{i_{1}t} - \widetilde{x}_{i_{1}t}^{i_{0}} \|_{\tau}$$

$$\leq M \| \varphi - x^{i_{0}} \|_{\tau} + \int_{0}^{t} ML e^{\alpha u} \| x_{i_{1}u} - \widetilde{x}_{i_{1}u}^{i_{0}} \|_{\tau} du, \qquad (44)$$

$$\| x_{i_{1}t} - \widetilde{x}_{i_{1}t}^{i_{0}} \|_{\tau} \leq M \| \varphi - x^{i_{0}} \|_{\tau} e^{-(\alpha - ML)t},$$

and thus

$$\rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) \le \left\|x_{i_{1}}\left(t\right) - \tilde{x}_{i_{1}}\left(t\right)\right\| \le M,$$
(45)

since $\varphi \in B_1(x^{i_0})$. When $t \in [t_1, t_2]$, since $x_{t_1} \in B_{1/2}(x^{i_1})$, we have

$$\begin{split} \rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) &= \rho\left(x_{i_{2}}\left(t-t_{1},0,x_{t_{1}}\right),\Gamma\right) \triangleq \rho\left(x_{i_{2}}\left(t-t_{1}\right),\Gamma\right) \\ &= \inf\left\{\left\|x_{i_{2}}\left(t-t_{1}\right)-y\right\|,y\in\Gamma\right\} \\ &\leq \left\|x_{i_{2}}\left(t-t_{1}\right)-x_{i_{2}}\left(t-t_{1},0,x^{i_{1}}\right)\right\| \\ &= \left\|x_{i_{2}}\left(t-t_{1}\right)-\overline{x}_{i_{2}}^{i_{1}}\left(t-t_{1}\right)\right\| \\ &= \left\|e^{A_{i_{2}}(t-t_{1})}x_{t_{1}}\left(0\right) \\ &+ \int_{0}^{t-t_{1}}e^{A_{i_{2}}(t-t_{1}-u)}f_{i_{2}}\left(\overline{x}_{i_{2}}\left(u-\tau\right)\right)du \\ &- e^{A_{i_{2}}t}x^{i_{1}} - \int_{0}^{t-t_{1}}e^{A_{i_{2}}(t-t_{1}-u)}f_{i_{2}}\left(\overline{x}_{i_{2}}^{i_{1}}\left(u-\tau\right)\right)du \\ &\leq \left\|e^{A_{i_{2}}(t-t_{1})}\left(x_{t_{1}}\left(0\right)-x^{i_{1}}\right)\right\| \\ &+ \left\|\int_{0}^{t-t_{1}}e^{A_{i_{2}}(t-t_{1}-u)} \\ &\times \left[f_{i_{2}}\left(x_{i_{2}}\left(u-\tau\right)\right)-f_{i_{2}}\left(\overline{x}_{i_{2}}^{i_{1}}\left(u-\tau\right)\right)\right]du\right\| \\ &\leq Me^{-\alpha(t-t_{1})}\left\|x_{t_{1}}\left(0\right)-x^{i_{1}}\right\| \\ &+ \int_{0}^{t-t_{1}}MLe^{-\alpha(t-t_{1}-u)}\left\|x_{i_{2}}\left(u-\tau\right)-\overline{x}_{i_{2}}^{i_{1}}\left(u-\tau\right)\right\|du, \end{aligned}$$
(46)

which implies that

$$e^{\alpha(t-t_{1})} \| x_{i_{2}t} - \widetilde{x}_{i_{2}t}^{i_{1}} \|_{\tau}$$

$$\leq M \| x_{t_{1}} - x^{i_{1}} \|_{\tau} + \int_{0}^{t-t_{1}} ML e^{\alpha u} \| x_{i_{2}u} - \widetilde{x}_{i_{2}u}^{i_{1}} \|_{\tau} du, \quad (47)$$

$$\| x_{i_{2}t} - \widetilde{x}_{i_{2}t}^{i_{1}} \|_{\tau} \leq M \| x_{t_{1}} - x^{i_{1}} \|_{\tau} e^{-(\alpha - ML)(t-t_{1})},$$

and thus

$$\rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) \le \left\|x_{i_{2}t} - \widetilde{x}_{i_{2}t}^{i_{1}}\right\|_{\tau} \le \frac{1}{2}M,\tag{48}$$

since $x_{t_1} \in B_{1/2}(x^{i_1})$. Suppose that, for $t \in [t_{k-1}, t_k]$,

$$\rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) \le \frac{1}{2^{k-1}}M.$$
(49)

When $t \in [t_k, t_{k+1}]$, since $x_{t_k} \in B_{1/2^k}(x^{i_k})$, (take $\varepsilon = 1/2^k$ in Lemma 11), we have

$$\begin{split} \rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) &= \rho\left(x_{i_{k+1}}\left(t-t_{k},0,x_{t_{k}}\right),\Gamma\right) \\ &= \rho\left(x_{i_{k+1}}\left(t-t_{k}\right),\Gamma\right) \\ &= \inf\left\{\left\|x_{i_{k+1}}\left(t-t_{k}\right)-y\right\|,y\in\Gamma\right\} \\ &\leq \left\|x_{i_{k+1}}\left(t-t_{k}\right)-x_{i_{k+1}}\left(t-t_{k},0,x^{i_{k}}\right)\right\| \\ &\triangleq \left\|x_{i_{k+1}}\left(t-t_{k}\right)-\tilde{x}_{i_{k+1}}^{i_{k}}\left(t-t_{k}\right)\right\| \\ &= \left\|e^{A_{i_{k+1}}\left(t-t_{k}\right)}x_{t_{k}}\left(0\right) \\ &+ \int_{0}^{t-t_{k}}e^{A_{i_{k+1}}\left(t-t_{k}-u\right)}f_{i_{k+1}}\left(x_{i_{k+1}}\left(u-\tau\right)\right)du \\ &- e^{A_{i_{k+1}}\left(t-t_{k}\right)}x^{i_{k}} \\ &- \int_{0}^{t-t_{k}}e^{A_{i_{k+1}}\left(t-t_{k}-u\right)}f_{i_{k+1}}\left(\tilde{x}_{i_{k+1}}^{i_{k}}\left(u-\tau\right)\right)du \\ &\leq Me^{-\alpha\left(t-t_{k}\right)}\left\|x_{t_{k}}\left(0\right)-x^{i_{k}}\right\| \\ &+ ML\int_{0}^{t-t_{k}}e^{-\alpha\left(t-t_{k}-u\right)}\left\|x_{i_{k+1}}\left(u-\tau\right)-\tilde{x}_{i_{k+1}}^{i_{k}}\left(u-\tau\right)\right\| \end{split}$$

which implies that

$$\|x_{i_{k+1}t} - \tilde{x}_{i_{k+1}t}^{i_k}\|_{\tau} \le M \|x_{t_k} - x^{i_k}\|_{\tau} e^{-(\alpha - ML)(t - t_1)} \le \frac{1}{2^k} M$$
(51)

and thus

$$\rho\left(x\left(t,0,\varphi,\sigma\right),\Gamma\right) \le \frac{1}{2^{k}}M, \quad t \in \left[t_{k},t_{k+1}\right].$$
(52)

Therefore, we have

$$\lim_{t \to \infty} \rho\left(x\left(t, 0, \varphi, \sigma\right), \Gamma\right) = 0, \tag{53}$$

which means that Γ is the attractor of system (1) with a switching law σ .

Similarly, we can study the existence of the attractor of the switched delay system (32) with the assumptions (H1)'-(H3)' and obtain the following results.

Lemma 13. For any given $\varepsilon > 0$, $\lambda > 0$, there exists

$$T(\varepsilon,\lambda) = \max\left\{\tau, \frac{\ln\left(M\left(\delta + \Delta\right)/\delta\right)}{\alpha - 2PML}\right\},\tag{54}$$

such that if $\varphi \in B_{\varepsilon}(\Gamma')$ and $\varphi \in C_{\tau}$, then the solution $x_i(t, 0, \varphi)$ of the ith subsystem of (32) satisfies $x_{it} \in B_{\lambda\varepsilon}(x^i), t \ge T$. If $\varphi \in B_{\varepsilon}(x^j)$ especially, then one can take $T(\varepsilon, \lambda) = \ln(M(\varepsilon + \widetilde{D})/\lambda\varepsilon)/(\alpha - 2PML) > 0$ such that when $t \ge T$ implies the solution $x_i(t, 0, \varphi)$ of the ith subsystem of (32) satisfies $x_{it} \in B_{\lambda\varepsilon}(x^i), t \ge T$.

Theorem 14. Suppose that the dwell time μ of the switching law $\sigma = \{(t_1, i_1), (t_2, i_2), \ldots\}$ satisfies $t_1 \ge \ln(M\Delta/\lambda\varepsilon)/(\alpha - 2PML)$; if $\mu \ge \max\{\tau, \ln(M\Delta/\lambda\varepsilon)/(\alpha - 2PML)\}$, then the set Γ' is an attractor of the switched delay system (32).
