# CLT for eigenvalue statistics of large-dimensional general Fisher matrices with applications

#### Abstract

Random Fisher matrices arise naturally in multivariate statistical analysis and understanding the properties of its eigenvalues is of primary importance for many hypothesis testing problems like testing the equality between two covariance matrices, or testing the independence between sub-groups of a multivariate random vector. Most of the existing work on random Fisher matrices deals with a particular situation where the population covariance matrices are equal. In this paper, we consider general Fisher matrices with arbitrary population covariance matrices and develop their spectral properties when the dimensions are proportionally large compared to the sample size. The paper has two main contributions: first the limiting distribution of the eigenvalues of a general Fisher matrix is found and second, a central limit theorem is established for a wide class of functionals of these eigenvalues. Applications of the main results are also developed for testing hypotheses on high-dimensional covariance matrices.


Keywords: central limit theorem; equality of covariance matrices; large-dimensional covariance matrices; large-dimensional Fisher matrix; linear spectral statistics

## 1. Introduction

For testing the equality of variances from two populations, a well-known statistic is the Fisher statistic defined as the ratio of two sample variances. Its multivariate counter-part is a random Fisher matrix defined by

where $\mathbf{B}_{1}$ and $\mathbf{B}_{2}$ are $p$-dimensional sample covariance matrices from two independent samples, say $\left\{\boldsymbol{\xi}_{k}, 1 \leq k \leq n_{1}\right\}$ and $\left\{\boldsymbol{\eta}_{\ell}, 1 \leq \ell \leq n_{2}\right\}$ with population covariance matrices $\boldsymbol{\Sigma}_{1}$ and $\boldsymbol{\Sigma}_{2}$, respectively. Fisher matrices, especially their eigenvalues, arise in many hypothesis testing problems in multivariate analysis. Examples include the test of the equality hypothesis $\boldsymbol{\Sigma}_{1}=\boldsymbol{\Sigma}_{2}$ where the likelihood ratio (LR) statistic can be written as a functional of the eigenvalues of a Fisher matrix, see Bai et al. [2]. In multivariate analysis of variance (MANOVA), the test on the equality of means is reduced to a statistic depending on a Fisher matrix which is a functional of the "between" sum of squares and the "within" sum of squares (Anderson [1], page 346). In multivariate linear regression, the likelihood ratio criterion for testing linear hypotheses about
regression coefficients is expressed as a functional of the eigenvalues of a Fisher matrix (Anderson [1], page 298). To test the independence between sub-groups of a multivariate population, the LR statistic is a functional of a Fisher matrix defined by sub-matrices of sample covariance matrices (Anderson [1], page 381). Fisher matrices appear also in the canonical correlation analysis, see Yang and Pan [26] for a recent account.

This paper concerns the high-dimensional situation where the population dimension $p$ is large compared to the sample sizes $n_{1}$ and $n_{2}$. It is now well understood that classical procedures as those presented in Anderson [1] become impracticable or dramatically lose efficiency in highdimensional data. For example, the deficiency of the Hotelling's $T^{2}$ statistic has been reported in Dempster [12] and Bai and Saranadasa [3]. Regarding hypothesis testing on one population high-dimensional covariance matrix, many recent works appeared in the literature, see Ledoit and Wolf [13], Srivastava [23], Srivastava et al. [24] and Schott [18,19], among others. About the equality of two population covariance matrices, please see Bai et al. [2], Cai, Liu and Xia [10], Li and Chen [14] and Zheng, Bai and Yao [29] among others. For two-sample tests on covariance matrices, Cai, Liu and Xia [10] and Li and Chen [14] use some ad-hoc distance measures to avoid the corresponding Fisher matrix, particularly when $p>n$ where the Fisher matrix is indeed undefined. However, all these works are not scale invariant and require some regularities of the population covariance matrix, for example, Cai, Liu and Xia [10] requires the sparsity condition, and Li and Chen [14] requires that the eigenvalues of the population covariance matrices are not dominated by a few of them. Therefore, tests defined by Fisher matrices are still important ones in multivariate analysis. Furthermore, Zheng, Bai and Yao [29] presented an example showing that tests defined by $F$ matrices has larger powers than the method of Li and Chen [14] in a few cases, after corrections using random matrix theory.

In the literature from random matrix theory and assuming that the dimension grows to infinity proportionally to sample sizes, the convergence of the eigenvalues of a Fisher matrix to a limiting distribution has been studied under the equality of two population covariance matrices by several authors, see e.g. Wachter [25], Bai [5], Bai et al. [9], Pillai [16], Pillai and Flury [17], Silverstein [20] and Yin et al. [27]. As an important contribution of the paper, we establish a limiting distribution for the eigenvalues of a general Fisher matrix with arbitrary population covariance matrices. Regarding central limit theorems for linear spectral statistics (or LSS), Chatterjee [11] establishes the existence of a Gaussian limit assuming that the populations are Gaussian. However, he does not provide explicit formulae for the asymptotic mean and asymptotic covariances of the Gaussian limit. A closely related work by Bai and Silverstein [7] establishes a CLT for spectral statistics of a general sample covariance matrices of form $\mathbf{B}_{1} \mathbf{T}_{p}$ where $\mathbf{B}_{1}$ is a sample covariance matrix and $\mathbf{T}_{p}$ is a non-random Hermitian matrix. This CLT is later refined in Pan and Zhou [15] where the original restriction on the values of the fourth moments of the population components is removed. However, the CLT in Bai and Silverstein [7] cannot cover spectral statistics of a Fisher matrix through simply replacing $\mathbf{T}_{p}$ by $\mathbf{B}_{2}^{-1}$ for the reason that the centering term of this CLT would thus become a random term without an explicit expression. To overcome this difficulty, Zheng [28] establishes a CLT for LSS of a Fisher matrix which has a non-random and explicit centering term. In particular, the components of the observations $\left\{\boldsymbol{\xi}_{i}\right\}$ and $\left\{\boldsymbol{\eta}_{j}\right\}$ can have an arbitrary fourth moment. To our best knowledge, this is the only CLT reported in the literature for LSS of a Fisher matrix. However, this CLT has a severe limitation with the assumption that the population covariance matrices are equal that is, $\boldsymbol{\Sigma}_{1}=\boldsymbol{\Sigma}_{2}$. Although the derivation
of this CLT is complex and highly nontrivial, it has a small impact on the statistical problems mentioned above where the population covariance matrices $\boldsymbol{\Sigma}_{i}$ can be arbitrary and not necessarily equal. Specifically, for the test of the equality hypothesis " $\boldsymbol{\Sigma}_{1}=\boldsymbol{\Sigma}_{2}$ ", this CLT enables us to find the distribution of the LR statistic under the null hypothesis, but not under the alternative " $\boldsymbol{\Sigma}_{1} \neq \boldsymbol{\Sigma}_{2}$ ", that is, the asymptotic test size of the test can be found by this CLT but not the power function.

The main contribution of the paper is the establishment of a central limit theorem for linear spectral statistics $\left\{W_{\mathbf{n}}\right\}$ of a general Fisher matrix where the population covariance matrices $\boldsymbol{\Sigma}_{i}$ are arbitrary. Under this scheme and as a preparatory step, we also establish a limiting distribution for their eigenvalues and give an explicit equation satisfied by its Stieltjes transform. Due to the fact that the population covariance matrices are arbitrary, the proofs of these results have required several new techniques compared to the existing literature on the central limit theory although the general scheme remains similar to the one used in Bai and Silverstein [7], Zheng [28]. A significantly different tool used here is another CLT reported in Zheng, Bai and Yao [30] for random matrix of type $\mathbf{S}^{-1} \mathbf{T}_{p}$ where $\mathbf{S}$ is a standard sample covariance matrix (with i.i.d. standardised components) and $\mathbf{T}_{p}$ a nonnegative definite and deterministic Hermitian matrix. These two papers are related to each other but focus on different random matrices.

The paper is organized as follows. In Section 2, we first introduce the asymptotic scheme and the technical assumptions used, and then establish the limiting spectral distribution of the eigenvalues. Section 3 presents the CLT for linear spectral statistics of general Fisher matrices which is the main result of the paper. Section 4 gives two algorithms for approximation of the limiting spectral density, the asymptotic mean and covariance functions involved in the new CLT. In Section 5, applications of the main results are proposed for hypothesis testing and confidence intervals about high-dimensional covariance matrices. Technical lemmas and proofs are postponed to the Appendix B.

## 2. Limiting spectral distribution of large dimensional general $F$-matrices

Following Bai and Silverstein [7] and Zheng [28], we will impose the following structure on the observation model. Assume that the samples can be expressed as

where the observation matrices

are the upper-left corners, of size $p \times n_{1}$ and $p \times n_{2}$, of two independent arrays of independent random variables $\left\{X_{j k}, j, k=1,2, \ldots\right\}$ and $\left\{Y_{j k}, j, k=1,2, \ldots\right\}$, respectively, and $\mathbf{Q}_{i}$ is any square matrix such that $\mathbf{Q}_{i} \mathbf{Q}_{i}^{*}=\mathbf{\Sigma}_{i}, i=1,2$ where $*$ denotes the (complex) adjoint of a matrix
(i.e., transpose and conjugate). The corresponding sample covariance matrices become

\mathbf{B}_{2}=\frac{1}{n_{2}} \sum_{\ell=1}^{n_{2}} \boldsymbol{\eta}_{\ell} \boldsymbol{\eta}_{\ell}^{*}=\mathbf{Q}_{2} \mathbf{S}_{2} \mathbf{Q}_{2}^{*}, & \text { with } \mathbf{S}_{2}=\frac{1}{n_{2}} \sum_{\ell=1}^{n_{2}} \mathbf{Y}_{\cdot \ell} \mathbf{Y}_{\cdot \ell}^{*} . \tag{2.2}

Because $\mathbf{F}=\mathbf{B}_{1} \mathbf{B}_{2}^{-1}$ has the same eigenvalues as $\mathbf{S}_{1} \mathbf{T}_{p, 1 / 2}^{*} \mathbf{S}_{2}^{-1} \mathbf{T}_{p, 1 / 2}$ where $\mathbf{T}_{p, 1 / 2}=\mathbf{Q}_{2}^{-1} \mathbf{Q}_{1}$, we can define as well the Fisher matrix to be $\mathbf{F}:=\mathbf{S}_{1} \mathbf{T}_{p, 1 / 2}^{*} \mathbf{S}_{2}^{-1} \mathbf{T}_{p, 1 / 2}$. It is also noticed that obviously, the matrix $\mathbf{S}_{2}$ should be invertible (almost surely) so that in our asymptotic analysis, we will assume $n_{2}>p$ for large $p$ and $n_{2}$.

Throughout the paper, the empirical spectral distribution (or ESD) of a complex $p \times p$ matrix $\mathbf{A}$ is the probability measure $F_{n}^{\mathbf{A}}(x)=p^{-1} \sum_{j=1}^{p} \delta_{\lambda_{j}}$ where $\left\{\lambda_{j}\right\}_{j=1}^{p}$ are the eigenvalues of $\mathbf{A}$, and $\delta_{a}$ denotes the Dirac mass at a point $a$. We consider the following assumptions.

Assumption [A]. The two double arrays $\left\{X_{k i}, i, k=1,2, \ldots\right\}$ and $\left\{Y_{k i}, i, k=1,2, \ldots\right\}$ consist of independent but not necessarily identically distributed random variables with mean 0 and variance 1 .

Assumption [B1]. For any fixed $\eta>0$ and when $n_{1}, n_{2}, p \rightarrow \infty$,

Assumption [B2]. If the two arrays are either both real, we then set the indicator $\kappa=2$; or both complex, we then set $\kappa=1$, with homogeneous 4th moments: $\mathrm{E}\left|X_{j k}\right|^{4}=1+\kappa+\beta_{x}+o(1)$, $\mathrm{E}\left|Y_{j k}\right|^{4}=1+\kappa+\beta_{y}+o(1)$. Moreover, for any fixed $\eta>0$ when $n_{1}, n_{2}, p \rightarrow \infty$,

In addition, $\mathrm{E} X_{j k}^{2}=o\left(n_{1}^{-1}\right), \mathrm{E} Y_{j k}^{2}=o\left(n_{2}^{-1}\right)$ when both arrays $\left\{X_{j k}\right\}$ and $\left\{Y_{j k}\right\}$ are complex.
Assumption [C]. The sample sizes $n_{1}, n_{2}$ and the dimension $p$ grow to infinity in such a way that

where $\mathbf{S}_{2}$ has the inverse matrix $\mathbf{S}_{2}^{-1}$.
Assumption [D]. The matrices $\mathbf{T}_{p}=\mathbf{T}_{p, 1 / 2} \mathbf{T}_{p, 1 / 2}^{*}$ are non-random and nonnegative definite Hermitian matrices and the sequence $\left\{\mathbf{T}_{p}\right\}$ is bounded in spectral norm. Moreover, the ESD $H_{p}$ of $\mathbf{T}_{p}$ tends to a proper probability measure $H$ when $p \rightarrow \infty$.

Here $m_{\mathbf{n}}(z)=\int \frac{1}{\lambda-z} d U_{\mathbf{n}}(x), m_{\mathbf{y}}(z)=\int \frac{1}{\lambda-z} d U_{\mathbf{y}}(x), \underline{m}_{\mathbf{n}}(z)=\int \frac{1}{\lambda-z} d \underline{U}_{\mathbf{n}}(x), \underline{m}_{\mathbf{y}}(z)=\int \frac{1}{\lambda-z} d \underline{U}_{\mathbf{y}}(x), f$ is an analytic function, $U_{\mathbf{n}}(f)=p^{-1} \sum_{j=1}^{p} f\left(\lambda_{j}^{\mathbf{F}}\right)$ with the eigenvalues $\left\{\lambda_{j}^{\mathbf{F}}\right\}_{j=1}^{p}$ of $\mathbf{F}$ and $U_{\mathbf{y}_{\mathbf{n}}}(x)$ is obtained by substituting $\mathbf{y}_{\mathbf{n}}=\left(y_{n_{1}}, y_{n_{2}}\right)$ for $\mathbf{y}=\left(y_{1}, y_{2}\right)$ in $U_{\mathbf{y}}(x)$.

The assumptions (2.3) and (2.4) are standard Lindeberg type conditions which are necessary for the existence of the limiting spectral distribution for $\mathbf{F}$, and for the CLT for LSS of $\mathbf{F}$, respectively. Moreover, under these conditions, the variables $\left\{X_{i k}\right\}$ and $\left\{Y_{i k}\right\}$ can be truncated at size $\eta_{p} \sqrt{p}\left(\eta_{p} \downarrow 0\right)$ without altering asymptotic results.

The following notations are used throughout the paper:

In the sequel, the limiting results will be investigated under the regime (2.5) that will be simply referred as $\mathbf{n} \rightarrow \infty$. Some useful concepts are now recalled. The Stieltjes transform of a positive Borel measure $G$ on the real line is defined by

This transform has a natural extension to the lower-half plane by the formula

In addition to $\mathbf{F}$, we will also need several other matrices. Table 1 contains the notations used in the sequel for the characteristics of these matrices: ESD, LSD, the associated Stieltjes transforms and LSS.
The matrices $\mathbf{F}$ and $\mathbf{X}^{*} \mathbf{T}_{p, 1 / 2}^{*} \mathbf{S}_{2}^{-1} \mathbf{T}_{p, 1 / 2} \mathbf{X} / n_{1}$ are companion matrices each other sharing same nonnull eigenvalues so that we have

Furthermore, when $\boldsymbol{\Sigma}_{1}=\boldsymbol{\Sigma}_{2}$, that is, $\mathbf{T}_{p}=\mathbf{I}_{p}$, it is well-known that the LSD $U_{\mathbf{y}}$ of $\mathbf{F}$ and its Stieltjes transform $m_{\mathbf{y}}(z)$ can be found on page 79 of Bai and Silverstein [4]. As a first result of the paper, we prove the existence of $U_{\mathbf{y}}$ and one of its characteristics for general Fisher matrix $\mathbf{F}$ where $\mathbf{T}_{p}$ is a Hermitian matrix.

Theorem 2.1. Under Assumptions [A], [B1], [C] and [D], The Fisher matrix

\mathbf{F}=\mathbf{S}_{1} \mathbf{T}_{p, 1 / 2}^{*} \mathbf{S}_{2}^{-1} \mathbf{T}_{p, 1 / 2}
$$

has a non-random LSD $U_{\mathbf{y}}$. Moreover, $U_{\mathbf{y}}$ is characterized by the fact that the Stieltjes transform $\underline{m}_{\mathbf{y}}(z)$ of its companion measure $\underline{U}_{\mathbf{y}}$ is the unique solution to the equation

where $m_{0}(z)=\underline{m}_{y_{2}}\left(-\underline{m}_{\mathbf{y}}(z)\right)$ and $\underline{m}_{y_{2}}(z)$ satisfies the equation $z=-\left(\underline{m}_{y_{2}}(z)\right)^{-1}+y_{2} \int(t+$ $\left.\underline{m}_{y_{2}}(z)\right)^{-1} d H(t)$.

The proof of this theorem is given in Appendix B.1.
Remark 2.1. If the Assumption [B1] in Theorem 2.1 is strengthened to [B2], following Bai and Yin [8], after truncation, one can show that with probability $1, \mathbf{S}_{2}$ is invertible. However, under the Assumption [B1], there may be a small portion of eigenvalues of $\mathbf{B}_{2}$ equal or tending to zero. In this case, Theorem 2.1 remains true if $\mathbf{S}_{2}^{-1}$ is understood as the Moore-Penrose generalized inverse of $\mathbf{S}_{2}$.

Remark 2.2. For a given $z \in \mathbb{C}^{+}$, the equation (2.9) has a unique solution $m_{0}$ such that $\mathfrak{J}\left(m_{0}\right)<0$.

In fact by Silverstein [21], $\underline{m}_{\mathbf{y}}(z)$ is the unique solution to the equation

subject to the condition that $\mathfrak{J}\left(\frac{1-y_{1}}{z}+\underline{m} y(z)\right) \Im(z)>0$. Here, $G_{y_{2}}$ denotes the limiting spectral distribution of the random matrix $\mathbf{T}_{p, 1 / 2}^{*} \mathbf{S}_{2}^{-1} \mathbf{T}_{p, 1 / 2}$.

In the sequel, for brevity, the notations $m_{\mathbf{y}}(z)$ and $\underline{m}_{\mathbf{y}}(z)$ will be simplified to $m(z)$ and $\underline{m}(z)$, or even to $m$ and $\underline{m}$, respectively, if no confusion would be possible. We will use the notation $G_{y_{n_{2}}}$ that is obtained by substituting $y_{n_{2}}=p / n_{2}$ for $y_{2}$ in $G_{y_{2}}$.

## 3. CLT for LSS of large dimensional general Fisher matrices

We consider a centered version of the LSS

$$

\end{equation*}
$$

with the eigenvalues $\left\{\lambda_{j}^{\mathbf{F}}\right\}_{j=1}^{p}$ of $\mathbf{F}$. Note that (3.1) is translation-invariant in $f$, we may assume $f(0)=0$. Due to the exact separation theorem (see Bai and Silverstein [6]), with probability
one, for large enough $n_{j}$ and $p$, the possible point mass at the origin of $U_{\mathbf{n}}$ will coincide exactly with that of $U_{\mathbf{y}_{\mathbf{n}}}$. By Theorem 1.1 of Silverstein and Choi [22], $U_{\mathbf{y}}$ has the continuous density $u_{\mathbf{y}}$ except $x=0$. Therefore, we can restrict the integral (3.1) to their continuous components on $(0, \infty)$, that is,

where $u_{\mathbf{y}_{\mathbf{n}}}(x)$ is the density of $U_{\mathbf{y}_{\mathbf{n}}}(x)$.
Regarding the central limit theory on linear spectral statistics of random matrices, it has been well known (Bai and Silverstein [7], Pan and Zhou [15], Zheng [28]) that the mean and covariance parameters of the limiting Gaussian distribution depend on the values of the fourth moments of $\left\{X_{j k}\right\}$ and $\left\{Y_{j k}\right\}$. When these moments match the Gaussian case, that is, $\beta_{x}=0$ or $\beta_{y}=0$ in Assumption [B2], the limiting parameters have a simpler expression. Otherwise, they have a more involved expression that depends on other limiting functionals of sample covariance matrices. More specifically, if $\beta_{x} \neq 0$, we will need the existence of the following limits

where $E_{j}$ denotes the conditional expectation given $\mathbf{X}_{\cdot 1}, \ldots, \mathbf{X}_{\cdot j}$ and $\mathbf{S}_{2}$, and if $\beta_{y} \neq 0$, we will need the existence of the limits

where $E_{j}$ denotes the conditional expectation given $\mathbf{Y}_{\cdot 1}, \ldots, \mathbf{Y}_{\cdot j}$. Here

and $\mathbf{e}_{i}$ denotes the $i$ th vector of the canonical basis of $\mathbb{C}^{p}$ where $\boldsymbol{\eta}_{j}=n_{2}^{-1 / 2} \mathbf{Y}_{\cdot j}$ and $\boldsymbol{\gamma}_{j}=$ $n_{1}^{-1 / 2} \mathbf{S}_{2}^{-1 / 2} \mathbf{T}_{p, 1 / 2} \mathbf{X}_{\cdot j}$.

The following CLT is the main result of the paper.

Theorem 3.1. Under the Assumptions [A], [B2], [C] and [D], assume that the limits (3.3)-(3.4) exist whenever $\beta_{x} \neq 0$, and the limits (3.5)-(3.6) exist whenever $\beta_{y} \neq 0$. Let $f_{1}, \ldots, f_{s}$ be $s$ functions analytic in an open domain of the complex plane that enclosed the support interval [ $c_{1}, c_{2}$ ] of the continuous component of the LSD $U_{\mathbf{y}}$. Then, as $\mathbf{n} \rightarrow \infty$, the random vector

where the contours $\mathcal{C}, \mathcal{C}_{1}$ and $\mathcal{C}_{2}$ all enclose the support of $U_{\mathbf{y}}$, and $\mathcal{C}_{1}$ and $\mathcal{C}_{2}$ are disjoint.

Similar to CLT's developed in Bai and Silverstein [7], Zheng [28], all the limiting parameters depend on contour integrals using the associated Stieltjes transforms. Some specific examples of calculations of such integrals can be found in these references.

When $\mathbf{T}_{p}$ 's are diagonal, we find explicit expressions for the limiting functions $h_{m j}(z)$ and $h_{v j}\left(z_{1}, z_{2}\right), j=1,2$. This in turn simplifies the expressions of limiting mean and covariance functions in the CLT. Two propositions about $h_{m j}(z)$ and $h_{v j}\left(z_{1}, z_{2}\right)$ are given in Appendix A. In this case, the limiting mean and covariance function in Theorem 3.1 are simplified as follows.

Theorem 3.2. Under the conditions of Theorem 3.1 and assuming that the matrices $\mathbf{T}_{p}$ 's are diagonal, we obtain that as $\mathbf{n} \rightarrow \infty$, the random vector

where the contours $\mathcal{C}, \mathcal{C}_{1}$ and $\mathcal{C}_{2}$ all enclose the support of $U_{\mathbf{y}}$, and $\mathcal{C}_{1}$ and $\mathcal{C}_{2}$ are disjoint.
Remark 3.1. The contours in Theorem 3.1 and Propositions A.1-A. 2 are taken in the $z$ space. In this case, the contours can be arbitrary provided that they enclose the support of the LSD $U_{\mathbf{y}}$. Since the integrands are functions of $m_{0}$, thus the integrals can be taken in the $m_{0}$ space using the change of variable $z \mapsto m_{0}(z)$.

Remark 3.2. When $\mathbf{T}_{p}$ is an identity matrix, (A.3) and (A.4) are the same as (3.6) and (3.7) in Zheng [28]. That is, Theorem 3.2 in Zheng [28] is a special case of Theorem 3.2 in this paper when $\mathbf{T}_{p}=\mathbf{I}_{p}$.

## 4. Evaluation of the asymptotic parameters $E X_{f}$, $\operatorname{Cov}\left(X_{f_{i}}, X_{f_{j}}\right)$ and the limiting density $u_{y}(x)$

Notice that practical applications of Theorem 3.1 or Proposition A. 1 require the knowledge of the limiting spectral density $u_{\mathbf{y}}(x)$, the asymptotic mean $E X_{f}$ and covariance function $\operatorname{Cov}\left(X_{f_{i}}, X_{f_{j}}\right)$. In particular, the last two functions depend on some non trivial contour integrals. In the simple case where $\mathbf{T}_{p}=\mathbf{I}_{p}$ and for simple functions like $f(x)=x^{j}$ or $f(x)=\log (x)$, analytical results can be found exactly, see Zheng [28]. However, this is a very particular case and for general population matrices or more complex functions $f$, such exact results are not available. In this section, we introduce some numerical procedures to approximate these asymptotic parameters while deliberately place ourselves in the context of practical applications with real data sets. In such a situation, the sample sizes and dimension of data ( $n_{1}, n_{2}, p$ ) are given and the empirical spectral distribution $H_{p}$ of $\mathbf{T}_{p}=\mathbf{T}_{p, 1 / 2} \mathbf{T}_{p, 1 / 2}^{*}$ is known. In this section, we denote the eigenvalues of $\mathbf{T}_{p}$ simply by $\left\{\lambda_{j}^{0}\right\}_{j=1}^{p}$ so that $H_{p}(t)=p^{-1} \sum_{j=1}^{p} I_{\left(\lambda_{j}^{0} \leq t\right)}$. However in such a concrete application situation, the LSD $H$ is never known and we need an estimate of $H$. A very reasonable and widely used estimate of $H$ is indeed just $H_{p}$.

Notice that the parameters $u_{\mathbf{y}}(x), \mathrm{E} X_{f}$ and $\operatorname{Cov}\left(X_{f_{i}}, X_{f_{j}}\right)$ all depend on the Stieltjes transform $m_{0}(z)$. By (2.9), we have

z=\frac{h^{2} m_{0}(z)}{y_{2}\left(-1+y_{2} \int \frac{m_{0}(z) d H(t)}{t+m_{0}(z)}\right)}+\frac{y_{1}}{y_{2}} m_{0}(z) .
$$

That is,

which leads to numerical approximations of $m_{0}(z)$. Choose $s_{0}(z)$ be the initial values of $m_{0}(z)$ and iterate for $k \geq 0$ the above mapping

until convergence and let $s_{k}(z)$ be the final values. Define the approximate value for $m_{0}(z)$ be $s_{k}(z)$.

Next, the limiting spectral density $u_{\mathbf{y}}(x)$ can be approximated as follows.

Remark 4.1. By Theorem B. 10 of Bai and Silverstein [4], we have

where $\left\{\lambda_{j}^{0}\right\}_{j=1}^{p}$ are the eigenvalues of $\mathbf{T}_{p}$.
The following remark will give a simplified form of the asymptotic mean function $\mathrm{E} X_{f}$ and asymptotic covariance function $\operatorname{Cov}\left(X_{f_{i}}, X_{f_{j}}\right)$.

Remark 4.2. In Proposition A.1, assuming that $\mathbf{T}_{p}$ 's are diagonal, then by (A.3)-(A.4) and (1.7) in Bai and Silverstein [7], the mean and covariance functions have the alternative expressions

Combining Remarks 4.1 and 4.2, we now describe the general procedure to approximate the limiting spectral density $u_{\mathbf{y}}(x)$, the asymptotic mean and covariance functions.

Algorithm 1: Approximating the limiting spectral density $u_{\mathbf{y}}(x)$. Cut the support set $\left[c_{1}, c_{2}\right]$ of the LSD of the Fisher matrix $\mathbf{F}$ into a mesh set as

Algorithm 2: Approximating the asymptotic mean function (4.4) and covariance function (4.5). Step 1. Choose two disjoint contours $\mathcal{C}_{1}$ and $\mathcal{C}_{2}$ both enclosing the support $\left[c_{1}, c_{2}\right]$ of $u_{\mathbf{y}}$ as depicted on Figure 1 where $\varepsilon$ and $\zeta$ are small numbers, for example, $\varepsilon=\zeta=10^{-3}$.

Step 2. Let $K_{1}$, $K_{2}$ be large integers, e.g. $10^{3}$. Then $\mathcal{C}_{1}$ and $\mathcal{C}_{2}$ are cut into a grid set as

## 5. Applications to high-dimensional statistical analysis

In this section, we introduce two applications of the theory developed in the paper to two highdimensional statistical problems.

### 5.1. Power function for testing the equality of two high-dimensional covariance matrices

First, we consider the two-sample test of the hypothesis that two high-dimensional covariance matrices are equal, that is,

By Zheng, Bai and Yao [29], the likelihood ratio test statistic for (5.1) is

where $N_{i}=n_{i}-1$ and $y_{N_{i}}=p / N_{i}$ for $i=1$, 2. Under $H_{0}$ and as $\mathbf{n} \rightarrow \infty$, we have

where $\Phi(\cdot)$ is the standardized normal distribution function.
To show the feasibility of the proposed numerical methods (4.7)-(4.8)-(4.9), we plot the power function (5.3) for the testing problem (5.1) in the Gaussian case where $p=300, n_{1}=600, n_{2}=$ $6000, \boldsymbol{\Sigma}_{1}$ is the identity matrix and $\boldsymbol{\Sigma}_{2}=\operatorname{diag}(1, \ldots, 1, c, \ldots, c)$ with the parameter $c=1.00$, $1.05,1.10,1.15,1.20,1.25,1.30,1.40,1.50$ and the number of $c$ in $\Sigma_{2}$ being $p / 2$. The numerical power function (5.3) for the testing problem (5.1) is plotted in Figure 2. Moreover, we compare the true values with numerical values of $F_{y_{N_{1}}, y_{N_{2}}}(f), m(f), \operatorname{Cov}(f)$ in Table 2 in the case of $\boldsymbol{\Sigma}_{1}=\boldsymbol{\Sigma}_{2}$. These values are very close each other and the proposed numerical methods perform well.

### 5.2. Confidence interval of $\boldsymbol{\theta}$ in $\mathrm{T}_{\boldsymbol{p}}(\boldsymbol{\theta})$

As the second application, we consider $\mathbf{T}_{p}=\mathbf{T}_{p}(\theta)$, that is, $\mathbf{T}_{p}$ is determined by the parameter $\theta$ which takes values in an interval $[a, b]$. We are interested in the confidence interval for the parameter $\theta$. Then using the fact

we will give a method to determine the confidence interval of the parameter $\theta$.
First, cut $[a, b]$ as $\mathcal{A}_{3}=\left\{\theta_{j}=a+\frac{(b-a) j}{N}, j=0, \ldots, N\right\}$ where $N$ is a large integer, for example, $10^{3}$. Giving $\theta_{j}$, that is, $\mathbf{T}_{p}=\mathbf{T}_{p}\left(\theta_{j}\right)$ and using Algorithms 1-2, we obtain $m^{\theta_{j}}(f)=E X_{f}$, $v^{\theta_{j}}(f)=\operatorname{Cov}\left(X_{f}, X_{f}\right)$ and $F_{y_{N_{1}}, y_{N_{2}}}^{\theta_{j}}(f), j=0, \ldots, N$. Then the confidence interval of $\theta$ is [ $\theta_{L}, \theta_{U}$ ] where

## 6. Concluding remarks

In this paper, we have considered a general Fisher matrix $\mathbf{F}$ where the (high-dimensional) population covariance matrices $\boldsymbol{\Sigma}_{1}$ and $\boldsymbol{\Sigma}_{2}$ can be arbitrary and not necessarily equal. First the limiting distribution of its eigenvalues has been found. Next and more importantly, we establish a CLT for its linear spectral statistics. This CLT is unavoidable in many two-sample statistical problems with high-dimensional data. Besides, this CLT extends and covers the CLT of Zheng [28] which is related to standard Fisher matrices.

An important and unsolved issue on the developed theory is about the evaluation of the limiting mean and covariance function in the CLT. These functions have a very complex structure depending on non-trivial contour integrals. In the special case where the matrices $\boldsymbol{\Sigma}_{2}^{-1} \boldsymbol{\Sigma}_{1}$ are diagonal, we have proposed some simplifications though the obtained results are still complex. In Section 4, we have devised some numerical procedures to approximate numerically these asymptotic parameters. The advantage of these procedures is that they depend on the observed data only. However, the accuracy of these procedure is currently unknown. A precise analysis of these procedures or finding other more accurate procedures for the approximation are certainly a valuable and challenging question in future research.

## Appendix A: Two propositions about $\boldsymbol{h}_{\boldsymbol{m} j}(z)$ and $\boldsymbol{h}_{v_{1}, v_{2}}\left(z_{1}, z_{2}\right)$ when $\mathrm{T}_{\boldsymbol{p}}$ 's are diagonal

Here, we develop an important special example where the matrices $\mathbf{T}_{p}$ 's are diagonal. In this case, the explicit expressions for the limiting functions $h_{m j}(z)$ and $h_{v j}\left(z_{1}, z_{2}\right), j=1,2$ are given.

Proposition A.1. In addition to the assumptions of Theorem 3.1, assume that the matrices $\mathbf{T}_{p}$ 's are diagonal. Then, the limits (3.5) and (3.6) exist and equal to

## B.4.1. Deriving CLT of general Fisher matrix

Following the same techniques of truncation and normalization given in Bai and Silverstein [7] (see lines -9 to -6 from the bottom of page 559), the assumptions can be simplified as the following:

- $\left|X_{j k}\right|<\eta_{p} \sqrt{p},\left|Y_{j k}\right|<\eta_{p} \sqrt{p}$, for some $\eta_{p} \rightarrow 0$, as $p \rightarrow \infty$;
- $E X_{j k}=0, E Y_{j k}=0$ and $E\left|X_{j k}\right|^{2}=1, E\left|Y_{j k}\right|^{2}=1$;
- $E\left|X_{j k}\right|^{4}=1+\kappa+\beta_{x}+o(1)$ and $E\left|Y_{j k}\right|^{4}=1+\kappa+\beta_{y}+o(1)$;
- For the complex case, $E X_{j k}^{2}=o\left(n_{1}^{-1}\right)$ and $E Y_{j k}^{2}=o\left(n_{2}^{-1}\right)$.
