In no case is the author personally responsible for paying the page charge, nor is acceptance of the author's paper for publication dependent upon payment of the page charge.

INFORMATION FOR SUBSCRIBERS

Subscription prices for Volume 84 (1978) are list \$22.00, member \$11.00. The subscription price for members is included in the annual dues. Back number prices *per volume* for Volumes 1-55 (1894-1949) are list \$28.00, member \$21.00; Volumes 56-80 (1950-1974), list \$21.00, member \$15.75; Volume 81 (1975), list \$27.00, member \$20.25; Volumes 82 and 83 (1976-1977), list \$36.00, member \$27.00.

Back volumes of the BULLETIN are also available on 16 mm microfilm, either negative or positive, and may be mounted either on spools or in Eastman or 3M cartridges.
