Information for authors

Submission of manuscripts

The Illinois Journal of Mathematics endeavors to publish original research articles of high quality in all areas of mathematics. Manuscripts, in duplicate, should be sent to the Illinois Journal of Mathematics, University of Illinois, 1409 West Green St., Urbana, Illinois 61801, USA, or directly to one of the editors listed on the inside front cover. The cover letter should include the name, address, and e-mail address (if available) of the author to whom correspondence should be sent.

The submission of a paper implies the author's assurance that it has not been published or submitted for publication elsewhere. All papers will be refereed, and the decision to publish a paper rests solely with the editors. Authors are asked to sign a copyright transfer agreement upon acceptance of their paper.

Preparation of manuscripts

If possible, papers should be typeset in one of the standard flavors of T_EX . We prefer papers prepared in LAT_EX or LAT_EX2e , but we can also handle other versions of T_EX . After a paper has been accepted, the author will be contacted with instructions on submitting electronic files. However, for the initial submission of a paper, and for the submission of any revised versions, hard copies are required.

All papers should include a brief abstract. The abstract should involve as little mathematical notation as possible and have no displayed formulas since, upon acceptance of the paper, the abstract will be published on the IJM website.

The paper should also include the 1991 Mathematics Subject Classification number(s). A list of classification numbers can be found in the December issue of Mathematical Reviews.

Offprints

Fifty offprints will be provided free of charge; in case of multiple authors, each author will receive twenty-five offprints. Additional offprints may be purchased.
