

# PHYSICAL STATES ON A $C^*$ -ALGEBRA

## I. Introduction

Let  $A$  be a  $C^*$ -algebra with identity  $1$ . A *physical state* is a function  $\rho: A \rightarrow \mathbb{C}$  which is a state on each singly generated  $C^*$ -subalgebra of  $A$ . Here “singly generated” means generated by  $1$  and a single self-adjoint element  $a \in A$ . The present paper is devoted to a discussion of whether a physical state  $\rho$  on  $A$  is *linear*, i.e. whether it is a state in the ordinary sense. In the proper physical interpretation, this is the problem of linearity of the expectation functional on the algebra of observables in quantum mechanics, cf. Mackey [8] and Kadison [6].

Mathematically, the problem is also closely related to the following problem: Let  $R$  be a von Neumann algebra, and let  $P$  be the lattice of orthogonal projections in  $R$ . A function  $\mu: P \rightarrow \mathbb{R}^+$  such that  $\mu(0) = 0$  is called a *completely additive measure* on  $P$  if

$$\mu\left(\sum_{i \in I} e_i\right) = \sum_{i \in I} \mu(e_i)$$

for any family  $\{e_i\}_{i \in I}$  of mutually orthogonal projections in  $P$ .  $\mu$  is a *probability measure* if  $\mu(1) = 1$ . Given a probability measure  $\mu$  on  $P$  one may ask whether there exists a positive normal state  $\rho$  on  $R$  such that  $\rho|_P = \mu$ . This question, which poses what we may call the extension problem for measures (in non-commutative setting), was first suggested by Mackey. An affirmative solution for the special case where  $R = \mathcal{L}(H)$  = all bounded linear operators on a separable Hilbert space  $H$ , with  $\dim H \geq 3$ , was given in an ingenious paper by Gleason [5]. In the case where the measure is the dimension-function on the projections of a type  $II_1$ -factor, the problem of extension is precisely the problem of the additivity of the trace [7], [9].

The connection between the extension problem for measures and the linearity problem

for physical states, is established in this way: Let  $\mu$  be a probability measure on the projections  $P$  in a von Neumann algebra  $R$ .

For each self-adjoint element  $a \in R$  we may define

$$\varrho(a) = \int_{\sigma(a)} \lambda d\mu(e_\lambda)$$

where  $\{e_\lambda\}$  is the spectral resolution of  $a$ , and  $\sigma(a)$  is the spectrum of  $a$ . Since every element  $x \in R$  may be written  $x = a_1 + ia_2$  in a canonical way where  $a_1, a_2$  are self-adjoint elements of  $R$ , we may extend  $\varrho$  to all of  $R$  by

$$\varrho(x) = \varrho(a_1) + i\varrho(a_2).$$

$\varrho$  then becomes a physical state on  $R$ , and we have  $\varrho|_P = \mu$ .  $\varrho$  is linear on  $R$  if and only if it solves the extension problem for  $\mu$ . Hence the extension problem is a special case of the linearity problem for physical states. The latter, in the form it is given above, is due to R. V. Kadison.

In § 3 of the present paper we give a complete solution for the case of a physical state  $\varrho$  on a commutative  $C^*$ -algebra  $A$ . When  $A$  is non-commutative, the problem remains unsolved in general. However, as Gleason's result indicates, solutions in particular cases may be found. In § 4 we give a brief outline of methods and results in this direction. A detailed exposition will be published elsewhere.

Throughout this paper concepts and results from the theory of  $C^*$ -algebras will be used quite freely. Our general reference is the book by Dixmier [4].

## 2. Physical states and quasi-states

Let  $A$  be a  $C^*$ -algebra with an identity  $\mathbf{1}$ . A *physical state* is a function  $\varrho: A \rightarrow \mathbb{C}$  which is a state on each singly generated  $C^*$ -subalgebra of  $A$ . Here "singly generated" means generated by  $\mathbf{1}$  and a single selfadjoint element  $a \in A$ .

We start with two simple examples which show how much linearity it is reasonable to expect from a physical state. First, let  $A$  be non-abelian, and let  $a$  be a non-normal element in  $A$  (if each element in  $A$  is normal, then  $A$  is abelian, so non-normal elements exist). Let  $\varrho$  be a state on  $A$  such that  $\varrho(a^*a - aa^*) \neq 0$ . Define, for any  $x \in A$

$$\varrho_1(x) = \varrho(x) + \varrho(x^*x - xx^*).$$

Clearly  $\varrho_1 = \varrho$  on  $A_h$  (=the self-adjoint elements in  $A$ ) and on any abelian  $C^*$ -subalgebra of  $A$ , so  $\varrho_1$  is a physical state on  $A$ . But  $\varrho_1$  is not linear on  $A$ .

Next, let  $A$  be abelian with two generators  $a, b \in A_h$ . Then  $a + ib$  is not contained in any singly generated  $C^*$ -subalgebra of  $A$ , so the set  $N$  of elements not contained in any singly generated  $C^*$ -subalgebra is not empty. There is a state  $\varrho$  on  $A$  which does not vanish identically on  $N$ , and we define

$$\varrho_1(x) = \begin{cases} \varrho(x) & \text{if } x \in A \setminus N \\ 0 & \text{if } x \in N \end{cases}$$

Then  $\varrho = \varrho_1$  on  $A_h$  and on any singly generated  $C^*$ -subalgebra of  $A$ , but  $\varrho_1$  is not linear on  $A$ . Hence, even in the commutative case, non-linear physical states exist. This kind of non-linearity is not a serious deficiency. What we want, is to show that a physical state is linear on  $A_h$ , since the bounded observables are supposed to correspond to the self-adjoint elements of  $A$ . However, to avoid trivial technical complications, we introduce the following

*Definition.* Let  $A$  be a  $C^*$ -algebra. A *positive quasi-linear functional* is a function  $\varrho: A \rightarrow \mathbb{C}$  such that

- (i)  $\varrho|_B$  is a positive linear functional for each singly generated  $C^*$ -subalgebra  $B$  of  $A$ .
- (ii)  $\varrho(a) = \varrho(a_1) + i\varrho(a_2)$ , when  $a = a_1 + ia_2$  is the canonical decomposition of  $a$  in self-adjoint parts  $a_1, a_2$ .

If in addition

- (iii)  $\sup \{\varrho(a): a \in A; \|a\| \leq 1; a \geq 0\} = 1$  then we say that  $\varrho$  is a *quasi-state* on  $A$ .

Observe that if  $A$  has an identity, then (iii) is equivalent to the condition  $\varrho(\mathbf{1}) = 1$ . We may also note that if two positive quasi-linear functionals  $\varrho$  and  $\gamma$  coincide on each singly generated  $C^*$ -subalgebra of  $A$ , then  $\varrho = \gamma$  by (ii). Clearly (i) implies that  $\varrho$  is real on self-adjoint elements, so by (ii) it follows that  $\overline{\varrho(a^*)} = \varrho(a)$  for all  $a \in A$ . Let us use the notation

$$\|\varrho\| = \sup \{\varrho(a): a \in A; \|a\| \leq 1; a \geq 0\}$$

It is easily seen (by [7], 2.1.5 (vi)) that if  $A$  does not have an identity, then a positive quasi-linear functional  $\varrho$  may be extended to a positive quasi-linear functional  $\tilde{\varrho}$  on  $\tilde{A}$  (=the  $C^*$ -algebra obtained by adjoining an identity to  $A$ ) by defining  $\tilde{\varrho}(\mathbf{1}) = K$ ; if  $K \geq \|\varrho\|$ . In particular a quasi-state on  $A$  extends to a quasi-state on  $\tilde{A}$ .

We shall use the following notation: If  $x \in A_h$ ,  $A(x)$  is the  $C^*$ -subalgebra generated by  $x$  (and  $\mathbf{1}$  if  $A$  has an identity).

### 3. Quasi-states on abelian $C^*$ -algebras

**THEOREM 1.** *Any positive quasi-linear functional  $\varrho$  on an abelian  $C^*$ -algebra  $A$  is linear.*

The proof of this theorem is rather lengthy and essentially measure theoretic. It is obtained through a sequence of lemmas. Without loss of generality we may assume that  $A$  has an identity  $\mathbf{1}$ , and that  $\varrho(\mathbf{1})=1$ .

**LEMMA 1.** *If  $0 \leq a, 0 \leq b; a, b \in A$  and  $ab=0$ , then there is  $c \in A_n$  such that  $a, b \in A(c)$ .*

*Proof.* Let  $B$  be the  $C^*$ -subalgebra of  $A$  generated by  $a, b$  and  $\mathbf{1}$ , and let  $Y$  be the set of pure states on  $B$ , regarded as a compact Hausdorff space. It is sufficient to show that  $Y$  is homeomorphic to a compact subset of  $\mathbf{R}$ . For  $p \in Y$  we have

$$0 = p(ab) = p(a)p(b),$$

so we may define

$$\Phi(p) = \begin{cases} p(a) & \text{if } p(b) = 0 \\ -p(b) & \text{if } p(a) = 0. \end{cases}$$

Clearly  $\Phi(p)=0$  if  $p(a)=p(b)=0$ . Let  $p \neq q, p, q \in Y$ . Since  $p(\mathbf{1})=q(\mathbf{1})=1$ , we must have  $p(a) \neq q(a)$  or  $p(b) \neq q(b)$ , which shows that  $\Phi$  is one-to-one. The range of  $\Phi$  is compact. Let  $p_\nu \rightarrow p$  in  $Y$ ; we may assume  $p(a) \neq 0, p(b)=0$ . Then  $p_\nu(a) \rightarrow p(a)$ , so there is an index  $\nu_0$  such that  $\nu \geq \nu_0$  implies  $p_\nu(a) \neq 0$  and hence also  $p_\nu(b)=0$ . It follows that  $\Phi(p_\nu) \rightarrow \Phi(p)$ , so  $\Phi$  is continuous and therefore a homeomorphism.

*Some notation.* Let  $X$  be the set of pure states on  $A$ , regarded as a compact Hausdorff space. We identify  $A$  and  $C(X)$ —the space of all continuous complex functions on  $X$ . For each  $a \in A_n$ , let  $\sigma(a) = a(X)$  be the spectrum of  $a$ .  $\sigma(a)$  is a compact subset of  $\mathbf{R}$  and there is an isometric isomorphism of  $C(\sigma(a))$  into  $A$  with range  $A(a)$ . If  $f \in C(\sigma(a))$ , the map  $f \rightarrow f(a) \in A(a)$  is given by

$$f(a)(s) = f(a(s)), \quad s \in X.$$

Let  $a \in A_n$ , and suppose that  $\varrho$  is a quasi-state on  $A$ . Then  $\varrho|_{A(a)}$  is a state, and determines a state  $\varrho_a$  on  $C(\sigma(a))$  by

$$\varrho_a(f) = \varrho(f(a)), \quad f \in C(\sigma(a)).$$

By Riesz' theorem  $\varrho$  therefore gives rise to a unique regular Borel-measure  $\mu_a$  on  $\sigma(a)$  such that

$$\varrho(f(a)) = \int_{\sigma(a)} f(\lambda) d\mu_a(\lambda), \quad \lambda \in \sigma(a),$$

for all  $f \in C(\sigma(a))$ .

In the sequel, we let  $C, F, K$  denote compact sets, and we let  $U, V, W$  denote open sets without necessarily further mentioning that they are compact or open respectively. For any set  $A$ , the interior of  $A$  is denoted by  $A^\circ$ .

LEMMA 2. *Let  $a \in A_h, K \subseteq \sigma(a)$ . Suppose  $a^{-1}(K) \subseteq U \subseteq X$ . Then there is an open set  $V \subseteq \sigma(a); V \supseteq K$ , such that  $a^{-1}(K) \subseteq a^{-1}(V) \subseteq U$ .*

*Proof.*  $K' = a(X \setminus U)$  is compact and disjoint from  $K$ . Hence  $V = \sigma(a) \setminus K'$  satisfies the conditions of the lemma.

LEMMA 3. *Let  $\varrho$  be a quasi-state on  $A$  and  $\varphi$  a state on  $A$ . For each  $a \in A_h$ , let  $\mu_a$  be the measure on  $\sigma(a)$  determined by  $\varrho$ , and let  $\mu$  be the regular Borel measure on  $X$  determined by  $\varphi$ . Then  $\varrho = \varphi$  if and only if*

$$\mu_a(K) = \mu(a^{-1}(K)) \tag{*}$$

for each  $a \in A_h$  and each compact set  $K \subseteq \sigma(a)$ .

*Proof.* Suppose  $\varrho = \varphi$ . Take  $a \in A_h$  and  $K \subseteq \sigma(a)$ . Choose  $\varepsilon > 0$ . There is a continuous function  $f: \sigma(a) \rightarrow [0, 1]$  such that  $f(\lambda) \equiv 1$  for  $\lambda \in K$ , satisfying  $\varrho_a(f) = \int_{\sigma(a)} f d\mu_a \leq \mu_a(K) + \varepsilon$ . Now  $f(a): X \rightarrow [0, 1]$  and  $f(a)(s) \equiv 1$  for  $s \in a^{-1}(K)$ , so  $\mu(a^{-1}(K)) \leq \varphi(f(a)) = \varrho(f(a)) = \varrho_a(f) \leq \mu_a(K) + \varepsilon$ . Since  $\varepsilon > 0$  was arbitrary, it follows that  $\mu(a^{-1}(K)) \leq \mu_a(K)$ . On the other hand, for  $\varepsilon > 0$  we may choose  $U \supseteq a^{-1}(K)$  such that  $\mu(U \setminus a^{-1}(K)) < \varepsilon$ . We then take  $V$  as in Lemma 2, and a continuous function  $g$  on  $\sigma(a)$  satisfying  $\chi_K \leq g \leq \chi_V$ . Then

$$\mu_a(K) \leq \varrho_a(g) = \varrho(g(a)) = \varphi(g(a)) \leq \mu(U) < \mu(a^{-1}(K)) + \varepsilon.$$

It follows that  $\mu_a(K) \leq \mu(a^{-1}(K))$  and (\*) holds.

Conversely, suppose that (\*) is valid for all  $a \in A_h$  and  $K \subseteq \sigma(a)$ . Take an  $a \in A_h$  and let  $\varphi_a$  be the restriction of  $\varphi$  to  $A(a)$ , and let  $\nu_a$  be the corresponding measure on  $\sigma(a)$ . Then, by the first part of the proof,  $\nu_a(K) = \mu(a^{-1}(K))$  for each  $K \subseteq \sigma(a)$ . By (\*) it follows that  $\nu_a(K) = \mu_a(K)$  for all  $K$ , and hence by regularity  $\nu_a = \mu_a$ . But then  $\varphi_a = \varrho|_{A(a)}$ , so  $\varphi$  coincides with  $\varrho$  on each singly generated  $C^*$ -subalgebra, i.e.  $\varphi = \varrho$ . The proof is complete.

Hence, to prove that the quasi-state  $\varrho$  is linear on  $A$ , it is sufficient to construct a regular Borel measure  $\mu$  on  $X$  satisfying (\*) of Lemma 3. Let  $\mathcal{K}$  denote the collection of compact subsets of  $X$ , and let  $\mathcal{K}'$  denote the sub-collection of compact sets of the form  $a^{-1}(K); a \in A_h, K \subseteq \sigma(a)$ . We start by defining  $\mu$  on  $\mathcal{K}$  by

$$\mu(K) = \inf \{ \varrho(a); a \in A_h; a \geq \chi_K \}.$$

Then  $\mu$  is a set-function on  $\mathcal{K}$ ,  $\mu(\emptyset) = 0$ ,  $\mu(X) = 1$  and  $K_1 \subseteq K_2$  implies  $\mu(K_1) \leq \mu(K_2)$ . It is

clear that in taking the inf above for a given  $K$ , we may assume  $a \leq 1$ . Indeed, since  $a \in A_h$ ,  $\min(a, 1) \in A(a)$  so  $\varrho(\min(a, 1)) \leq \varrho(a)$ .

**LEMMA 4.** *For  $K \in \mathcal{K}$  and  $\varepsilon > 0$  given, there is  $F \in \mathcal{K}'$  such that  $K \subseteq F^o$  and  $\mu(F) < \mu(K) + \varepsilon$ .*

*Proof.* We first note that if  $a \in A_h$  and  $C \subseteq \sigma(a)$ , then  $\mu(a^{-1}(C)) \leq \mu_a(C)$ . Indeed, choose  $f \in C(\sigma(a))$ ;  $f \geq \chi_C$  such that  $\varrho_a(f) \leq \mu_a(C) + \varepsilon$ . Then  $f(a) \geq \chi_{a^{-1}(C)}$ , so  $\mu(a^{-1}(C)) \leq \varrho(f(a)) = \varrho_a(f) \leq \mu_a(C) + \varepsilon$  which proves the claim. Now let  $K \in \mathcal{K}$  and let  $\varepsilon > 0$  be given. Choose  $a \in A_h$ ;  $\chi_K \leq a \leq 1$  such that  $\varrho(a) < \mu(K) + \varepsilon$ . Then choose  $\delta > 0$  such that  $\mu_a([1 - \delta, 1] \cap \sigma(a)) < \mu_a(\{1\}) + \varepsilon$ , and put  $F = a^{-1}([1 - \delta, 1] \cap \sigma(a))$ . Then  $K \subseteq F^o$  and

$$\mu(F) \leq \mu_a([1 - \delta, 1] \cap \sigma(a)) < \mu_a(\{1\}) + \varepsilon \leq \int_{\sigma(a)} \lambda d\mu_a(\lambda) + \varepsilon = \varrho(a) + \varepsilon < \mu(K) + 2\varepsilon$$

from which the lemma follows.

**LEMMA 5.** *For any  $a \in A_h$  and  $K \subseteq \sigma(a)$  we have  $\mu_a(K) = \mu(a^{-1}(K))$ .*

*Proof.* By the first part of the proof of the preceding lemma, we already know that  $\mu(a^{-1}(K)) \leq \mu_a(K)$ . Now let  $K_1 = a^{-1}(K)$  and choose, for  $\varepsilon > 0$  given,  $F \subseteq X$  such that  $K_1 \subseteq F^o$  and  $\mu(F) < \mu(K_1) + \varepsilon$  (Lemma 4). By Lemma 2 there is an open set  $V \subseteq \sigma(a)$  such that  $K_1 \subseteq a^{-1}(V) \subseteq F^o$ . Let  $f \in C(\sigma(a))$  satisfy  $\chi_K \leq f \leq \chi_V$ . Then  $\chi_{K_1} \leq f(a) \leq \chi_{F^o}$ . Let  $b$  be any element of  $A_h$  satisfying  $\chi_F \leq b \leq 1$ . Then  $(1 - b)f(a) = 0$ , so by Lemma 1,  $f(a)$  and  $b$  belong to the same singly generated  $C^*$ -subalgebra. Since  $0 \leq f(a) \leq b$  it follows that  $\varrho(f(a)) \leq \varrho(b)$ . Thus  $\varrho(f(a)) \leq \mu(F)$  by the definition of  $\mu$ . Hence  $\mu_a(K) \leq \varrho_a(f) = \varrho(f(a)) \leq \mu(F) < \mu(a^{-1}(K)) + \varepsilon$ , so  $\mu_a(K) \leq \mu(a^{-1}(K))$ . This, together with the opposite inequality, finishes the proof.

**LEMMA 6.** *Let  $K \in \mathcal{K}$ . For each  $U \supseteq K$  and each  $\varepsilon > 0$  there is  $a \in A_h$  satisfying  $\chi_K \leq a \leq \chi_U$  and  $\varrho(a) < \mu(K) + \varepsilon$ .*

*Proof.* Let  $K \subseteq U$  and  $\varepsilon > 0$  be given. By Lemma 4 choose  $F \in \mathcal{K}'$  such that  $K \subseteq F^o$  and  $\mu(F) < \mu(K) + \varepsilon$ . Then pick an  $a \in A_h$  such that  $\chi_K \leq a \leq \chi_{U \cap F^o}$ . The same argument as in the proof of Lemma 5 shows that  $\varrho(a) \leq \varrho(b)$  for any  $b$  satisfying  $\chi_F \leq b \leq 1$ , so that  $\varrho(a) \leq \mu(F) < \mu(K) + \varepsilon$ , and the proof is complete.

**LEMMA 7.** *If  $K_1, K_2 \in \mathcal{K}$ , and  $K_1 \cap K_2 = \emptyset$ , then  $\mu(K_1 \cup K_2) = \mu(K_1) + \mu(K_2)$ .*

*Proof.* Since  $K_1 \cap K_2 = \emptyset$ , there are open sets  $U_1 \supseteq K_1$ ,  $U_2 \supseteq K_2$  such that  $U_1 \cap U_2 = \emptyset$ . By Lemma 6 we may choose  $a, b \in A_h$  satisfying  $\chi_{K_1} \leq a \leq \chi_{U_1}$ ,  $\chi_{K_2} \leq b \leq \chi_{U_2}$ , and  $\varrho(a) < \mu(K_1) + \varepsilon$ ,  $\varrho(b) < \mu(K_2) + \varepsilon$ . Now  $ab = 0$ , so by Lemma 1

$$\mu(K_1 \cup K_2) \leq \varrho(a + b) = \varrho(a) + \varrho(b) < \mu(K_1) + \mu(K_2) + \varepsilon$$

proving that  $\mu(K_1 \cup K_2) \leq \mu(K_1) + \mu(K_2)$ . On the other hand, Lemma 6 tells us that  $\mu(K_1 \cup K_2) = \inf \{\varrho(c) : \chi_{K_1 \cup K_2} \leq c \leq \chi_U\}$  for any open set  $U \supseteq K_1 \cup K_2$ . We may therefore take  $U = U_1 \cup U_2$  as above, and choose  $c \in A_h$  such that  $\varrho(c) < \mu(K_1 \cup K_2) + \varepsilon$ ,  $\chi_{K_1 \cup K_2} \leq c \leq \chi_{U_1 \cup U_2}$ . Then  $c = a + b$ , with  $ab = 0$  and  $\chi_{K_1} \leq a \leq \chi_{U_1}$ ,  $\chi_{K_2} \leq b \leq \chi_{U_2}$ , so

$$\mu(K_1) + \mu(K_2) \leq \varrho(a) + \varrho(b) = \varrho(c) < \mu(K_1 \cup K_2) + \varepsilon,$$

which gives us the opposite inequality and finishes the proof.

Now defined, for  $U$  open  $\subseteq X$

$$\mu(U) = 1 - \mu(X \setminus U)$$

If  $U$  is also compact, this is consistent with the previous definition of  $\mu$  on  $\mathcal{K}$ , by Lemma 7.

LEMMA 8. For each  $U$ ,

$$\mu(U) = \sup_{K \subseteq U} \mu(K).$$

*Proof.* Let  $K' = X \setminus U$ . If  $K \subseteq U$ ,  $K \cap K' = \emptyset$ , so  $\mu(K) + \mu(K') = \mu(K \cup K') \leq 1$ . Hence  $\mu(K) \leq 1 - \mu(K') = \mu(U)$  for each  $K \subseteq U$ .

By Lemma 4 there is  $F \in \mathcal{K}'$  such that  $F \supseteq K'$  and  $\mu(F) < \mu(K') + \varepsilon$  for any preassigned  $\varepsilon > 0$ . We have  $F = a^{-1}(C)$  for some  $a \in A_h$ ,  $C \subseteq \sigma(a)$ . Let  $W = \sigma(a) \setminus C$ , and put  $V = a^{-1}(W)$ , so  $V \subseteq U$ .  $\mu_a$  is regular, so there is a compact set  $C_1 \subseteq W$  such that  $\mu_a(C_1) > \mu_a(W) - \varepsilon$ . Then, by Lemma 5

$$\begin{aligned} \mu(a^{-1}(C_1)) &= \mu_a(C_1) > \mu_a(W) - \varepsilon \\ &= 1 - \mu_a(C) - \varepsilon = 1 - \mu(F) - \varepsilon \\ &> 1 - \mu(K') - 2\varepsilon = \mu(U) - 2\varepsilon \end{aligned}$$

which proves the lemma.

We observe that if  $a \in A_h$  and  $f \in C(\sigma(a))$ , then for any set  $B \subseteq \mathbf{R}$  we have  $f(a)^{-1}(B) = a^{-1}(f^{-1}(B))$ . Indeed

$$\begin{aligned} f(a)^{-1}(B) &= \{s \in X : f(a)(s) \in B\} \\ &= \{s \in X : f(a(s)) \in B\} \\ &= a^{-1}(f^{-1}(B)). \end{aligned}$$

LEMMA 9. Let  $K_1, K_2 \in \mathcal{K}$  with  $K_1 \subseteq K_2$ . Then  $\mu(K_2) - \mu(K_1) = \inf_{U \supseteq K_2 \setminus K_1} \mu(U)$ .

*Proof.* Let  $\varepsilon > 0$  be given. We first choose  $U \supseteq K_2$  such that  $\mu(U) < \mu(K_2) + \varepsilon$ . This choice can be made by virtue of Lemma 4 and the observation that if  $V \subseteq C$  for any  $V$  and  $C$ , then  $\mu(V) \leq \mu(C)$  (from Lemma 8). Now choose  $a \in A_h$  such that  $\chi_{K_1} \leq a \leq \chi_U$ , and let

$F = \{s \in X: a(s) \geq \frac{1}{2}\}$ . Take  $b \in A_h$  such that  $\chi_F \leq b \leq \chi_U$ , and let  $W = \{s \in X: b(s) > \frac{1}{2}\}$ . Then we have

$$K_2 \subseteq F^o \subseteq F \subseteq W \subseteq U.$$

For  $n=1, 2, \dots$ , let  $b_n \in A_h$  be chosen such that  $\chi_{K_1} \leq b_n \leq \chi_{F^o}$ , and  $\varrho(b_n) < \mu(K_1) + 1/n$  (Lemma 6). Put  $F_n = \{s \in X: b_n(s) = 1\}$ . Then  $K_1 \subseteq F_n \subseteq F^o$  for all  $n$ ; and  $\mu(K_1) \leq \mu(F_n) \leq \varrho(b_n) < \mu(K_1) + 1/n$ . Thus  $\mu(F_n) \rightarrow \mu(K_1)$  as  $n \rightarrow \infty$ . With  $V_n = (X \setminus F_n) \cap W$ ,  $V_n$  is open,  $V_n \cap F_n = \emptyset$  and  $V_n \cup F_n = W$  for all  $n$ . We observe that  $b_n(1-b) = 0$  for all  $n$ . Hence, by Lemma 1, there is an  $a_n \in A_h$  such that  $b, b_n \in A(a_n)$ ;  $n=1, 2, \dots$ . By the observation preceding this lemma, this implies that, for each  $n$ , there are sets  $V'_n, F'_n$  and  $W' \subseteq \sigma(a_n)$  such that  $V_n = a_n^{-1}(V'_n)$ ,  $F_n = a_n^{-1}(F'_n)$  and  $W = a_n^{-1}(W')$ . We have  $V'_n \cap F'_n = \emptyset$  and  $V'_n \cup F'_n = W'$ . Thus, by Lemma 5 and the definition of  $\mu(W)$ , we get

$$\mu(W) = \mu_{a_n}(W') = \mu_{a_n}(V'_n) + \mu_{a_n}(F'_n) = \mu(V_n) + \mu(F_n).$$

With  $V = (X \setminus K_1) \cap W$ ,  $V$  is open and contains  $K_2 \setminus K_1$ . Since  $F_n \supseteq K_1$ , we get  $V_n \subseteq V$ ;  $n=1, 2, \dots$ . So  $\mu(V) \geq \mu(V_n) = \mu(W) - \mu(F_n) \rightarrow \mu(W) - \mu(K_1)$ , so  $\mu(W) \leq \mu(V) + \mu(K_1)$ . On the other hand, if  $K \subseteq V$  it follows that  $K \cap K_1 = \emptyset$  and  $K \cup K_1 \subseteq W$ , so  $\mu(W) \geq \mu(K_1 \cup K_2) = \mu(K_1) + \mu(K)$  by Lemma 7. By Lemma 8 we then get  $\mu(W) \geq \mu(K_1) + \mu(V)$  which combined with the opposite inequality above gives  $\mu(V) = \mu(W) - \mu(K_1)$ . Consequently

$$\mu(K_2) - \mu(K_1) \leq \mu(W) - \mu(K_1) = \mu(V) \leq \mu(U) - \mu(K_1) < \mu(K_2) - \mu(K_1) + \varepsilon,$$

since  $W \subseteq U$ . As  $\varepsilon > 0$  was arbitrary, this inequality completes the proof.

LEMMA 10. Let  $K_1, K_2 \in \mathcal{K}$  with  $K_1 \subseteq K_2$ . Then  $\mu(K_2) - \mu(K_1) = \sup_{K \subseteq K_2 \setminus K_1} \mu(K)$ .

*Proof.* First, if  $K \subseteq K_2 \setminus K_1$ , then  $K_1 \cap K = \emptyset$  and  $K_1 \cup K \subseteq K_2$ , so  $\mu(K_1) + \mu(K) \leq \mu(K_2)$ , i.e.  $\mu(K) \leq \mu(K_2) - \mu(K_1)$ . Now choose, by Lemma 4,  $F \supseteq K_1$  such that  $F^o \supseteq K_1$  and  $\mu(F) \leq \mu(K_1) + \varepsilon$ . Put  $K = (X \setminus F^o) \cap K_2$  so  $K \subseteq K_2 \setminus K_1$ . We observe that  $(F \cap K_2) \setminus K_1 \supseteq K_2 \setminus (K \cup K_1)$ , so, by the preceding lemma, we get  $\mu(F \cap K_2) - \mu(K_1) \geq \mu(K_2) - \mu(K \cup K_1)$ . Hence we have

$$\varepsilon \geq \mu(F) - \mu(K_1) \geq \mu(F \cap K_2) - \mu(K_1) \geq \mu(K_2) - \mu(K \cup K_1) = \mu(K_2) - \mu(K_1) - \mu(K),$$

so  $\mu(K) > \mu(K_2) - \mu(K_1) - \varepsilon$  which proves the lemma.

Let

$$\Gamma = \{A \subseteq X: A = K_2 \setminus K_1; K_2 \supseteq K_1\}$$

We claim that  $\Gamma$  is a semi-ring of sets in the sense of Zaanen [10]. That is, we must check that



- (a)  $A, B \in \Gamma \Rightarrow A \cap B \in \Gamma$   
 (b)  $A, B \in \Gamma$  and  $B \subseteq A \Rightarrow A \setminus B = \bigcup_{n=1}^{\infty} C_n$ , where  $C_n \in \Gamma$  for all  $n$ , and the sets  $C_n$  are mutually disjoint  
 (c)  $\emptyset \in \Gamma$ .

LEMMA 11.  $\Gamma$  is a semi-ring.

*Proof.* (c) is evidently satisfied,  $\emptyset = X \setminus X$ . (a): If  $A = K_1 \setminus K_2$ ,  $B = C_1 \setminus C_2$  with  $K_2 \subseteq K_1$ ,  $C_2 \subseteq C_1$ , then  $A \cap B = K_1 \cap C_1 \setminus ((K_2 \cap C_1) \cup (C_2 \cap K_1))$  so  $A \cap B \in \Gamma$ . (b): Let  $A, B \in \Gamma$  with  $A \supseteq B$ . If  $A = K_1 \setminus K_2$ , then  $B \subseteq K_1$  so  $\bar{B} \subseteq K_1$ . Since  $B = C_1 \setminus C_2$  for some pair of compact sets  $C_1 \supseteq C_2$ , it follows that  $\bar{B} \setminus B$  is compact. Let  $C'_1 = \bar{B} \cup K_2$ ,  $C'_2 = (\bar{B} \setminus B) \cup K_2$ . Then  $C'_1 \supseteq C'_2$  and both sets are compact, and  $B = C'_1 \setminus C'_2$  since  $B \cap K_2 = \emptyset$ . Furthermore,  $K_1 \supset C'_1 \supseteq C'_2 \supseteq K_2$ , so we can write  $A \setminus B = (K_1 \setminus C'_1) \cup (C'_2 \setminus K_2)$  which is a disjoint union of sets in  $\Gamma$ .

Hence  $\Gamma$  is a semi-ring which contains all open and all compact subsets of  $X$ . If  $A \in \Gamma$ ,  $A = K_2 \setminus K_1$  with  $K_2 \supseteq K_1$ , we define

$$\mu(A) = \mu(K_2) - \mu(K_1).$$

By Lemma 9 and 10 this definition is unambiguous, and we have

$$\mu(A) = \sup_{K \subseteq A} \mu(K) = \inf_{U \supseteq A} \mu(U).$$

The definition of  $\mu$  on  $\Gamma$  is clearly consistent with the previous definitions of  $\mu$  on open and compact sets. We are going to show that  $\mu$  is a measure on  $\Gamma$ . First we need:

- LEMMA 12. (a) If  $U_1 \subseteq U_2$ , then  $U_2 \setminus U_1 \in \Gamma$  and  $\mu(U_2 \setminus U_1) = \mu(U_2) - \mu(U_1)$ .  
 (b) For  $U_1, U_2$  arbitrary (open)  $\mu(U_1 \cup U_2) \leq \mu(U_1) + \mu(U_2)$ .

*Proof.* (a)  $U_2 \setminus U_1 = (X \setminus U_1) \setminus (X \setminus U_2) \in \Gamma$ , so

$$\mu(U_2 \setminus U_1) = \mu(X \setminus U_1) - (X \setminus U_2) = 1 - \mu(U_1) - 1 + \mu(U_2) = \mu(U_2) - \mu(U_1).$$

(b) Put  $U = U_1 \cup U_2$ . Then, by (a),  $\mu(U) = \mu(U \setminus U_1) + \mu(U_1) \leq \mu(U_2) + \mu(U_1)$ , from Lemma 9, since  $U \setminus U_1 \subseteq U_2$  and  $U \setminus U_1 \in \Gamma$ .

LEMMA 13.  $\mu$  is a measure on  $\Gamma$ .

*Proof.* We know from the definition of  $\mu$  and Lemma 9 that  $\mu(\emptyset) = 0$ ,  $\mu(A) \geq 0$  for all  $A \in \Gamma$  and that  $A \subseteq B \Rightarrow \mu(A) \leq \mu(B)$ , for  $A, B \in \Gamma$ . The only thing left to verify is therefore that  $\mu$  is countably additive on  $\Gamma$ .

Let  $\{A_n\} \subseteq \Gamma$  with the  $A_n$  pairwise disjoint, and suppose  $A = \bigcup_{n=1}^{\infty} A_n$  belongs to  $\Gamma$ . For  $\varepsilon > 0$ , there is  $K \subseteq A$  such that  $\mu(K) > \mu(A) - \varepsilon$ , and there is  $U_n \supseteq A_n$  such that  $\mu(U_n) < \mu(A_n) + \varepsilon/2^n$  for each  $n$ . Now  $\bigcup_{n=1}^{\infty} U_n \supseteq \bigcup_{n=1}^{\infty} A_n = A \supseteq K$ , so there is an  $m$  such that  $\bigcup_{n=1}^m U_n \supseteq K$ . Hence

$$\sum_{n=1}^{\infty} \mu(A_n) \geq \sum_{n=1}^{\infty} \mu(U_n) - \varepsilon \geq \sum_{n=1}^m \mu(U_n) - \varepsilon \geq \mu\left(\bigcup_{n=1}^m U_n\right) - \varepsilon \geq \mu(K) - \varepsilon > \mu(A) - 2\varepsilon,$$

where we have used Lemma 12(b). So  $\mu(A) \leq \sum_{n=1}^{\infty} \mu(A_n)$ . On the other hand, let  $K_n \subseteq A_n$  be chosen in such a way that  $\mu(K_n) > \mu(A_n) - \varepsilon/2^n$ ,  $n = 1, 2, \dots$ . Let  $p$  be any positive integer. Then  $\bigcup_{n=1}^p K_n$  is compact and contained in  $A$ . The sets  $K_n$  are clearly disjoint, so

$$\mu(A) \geq \mu\left(\bigcup_{n=1}^p K_n\right) = \sum_{n=1}^p \mu(K_n) > \sum_{n=1}^p \mu(A_n) - \varepsilon$$

from Lemma 7. Hence  $\mu(A) \geq \sum_{n=1}^p \mu(A_n)$  for any  $p$ , which, combined with the inequality already proved, gives  $\mu(A) = \sum_{n=1}^{\infty} \mu(A_n)$ .

By standard arguments (see for instance [10]) it now follows that  $\mu$  extends to a regular measure on the  $\sigma$ -field of Borel-sets in  $X$ . By Lemma 5  $\mu$  satisfies (\*) of Lemma 3, so if we take  $\varphi$  to be the state on  $A$  given by  $\varphi(a) = \int_X a(s) d\mu(s)$ ;  $a \in A$ ,  $s \in X$ , then  $\varphi = \rho$ . The proof of the theorem is complete.

#### 4. Quasi-states on general $C^*$ -algebras

Let  $\rho$  be a quasi-state on  $\mathcal{L}(H)$  (=all bounded linear operators on a Hilbert-space  $H$ ), and let  $P$  denote the set of orthogonal projections on  $H$ . If we assume that  $\dim H \geq 3$  and that  $\rho|_P$  is completely additive, then Gleason's theorem [5] states that there is a positive, normal state  $\varphi$  on  $\mathcal{L}(H)$  such that  $\varphi|_P = \rho|_P$ . It is now simple to show that  $\rho = \varphi$ , so that  $\rho$  in fact is linear on  $H$ . Without the assumption that  $\rho|_P$  is completely additive, i.e. that it is merely finitely additive, the problem remains unsolved. However, by a slight modification and extension of Gleason's methods, one may show that *any quasi-state on  $\mathcal{L}C(H)$*  (=all compact linear operators on  $H$ ) *is linear if  $\dim H \geq 4$* . The details of this proof, and the proofs of the other results mentioned in this section will be published in a forthcoming paper [1].

Let  $A$  be a  $C^*$ -algebra and let  $Q$  be the set of all positive quasi-linear functionals  $\rho$  on  $A$  with  $\|\rho\| \leq 1$ .  $Q$  is clearly a convex set under the pointwise operations, and if we give  $Q$  the topology of pointwise convergence on  $A$ , we can show that  $Q$  is compact. Let us say that a quasi-state  $\rho$  is *pure* if each element  $\gamma \in Q$  such that  $\gamma \leq \rho$  is of the form  $\gamma = \lambda\rho$ , with  $0 \leq \lambda \leq 1$ ,  $\lambda \in \mathbf{R}$ . As for ordinary states it turns out that a quasi-state  $\rho$  is pure if and only if

$\varrho$  is an extreme point of  $Q$  different from 0. On the basis of the Krein-Milman theorem it is therefore clear that to show that an arbitrary  $\varrho \in Q$  is linear, it is sufficient to show that any pure quasi-state on  $A$  is linear.

The introduction of pure quasi-states makes a subdivision of the problem possible. Let  $\varrho$  be a pure quasi-state on the  $C^*$ -algebra  $A$ . Suppose for a moment that  $\varrho$  is actually linear. Then there is a standard way of associating a representation  $\pi_\varrho$  of  $A$  to  $\varrho$ .  $\pi_\varrho$  is irreducible and  $I = \ker \pi_\varrho$  is a primitive ideal of  $A$ .  $\varrho$  vanishes on  $I$  so it lifts to a pure state  $\bar{\varrho}$  on  $A/I$ , and if  $\varphi: A \rightarrow A/I$  is the quotient homomorphism, we have  $\varrho = \bar{\varrho} \circ \varphi$ . This procedure suggests the following subdivision of the linearity problem for a pure quasi-state  $\varrho$  on  $A$ .

- (I) Find a primitive ideal  $I$  of  $A$  such that  $\varrho(I) = 0$ .
- (II) Lift  $\varrho$  to a pure quasi-state  $\bar{\varrho}$  on  $A/I$ , such that  $\varrho = \bar{\varrho} \circ \varphi$ , where  $\varphi$  is the quotient map.
- (III) Show that  $\bar{\varrho}$  is linear on  $A/I$ .

Since  $\varphi$  is linear, a positive solution of (I), (II) and (III) will imply that  $\varrho = \bar{\varrho} \circ \varphi$  is linear.

With respect to (I), one may show that this is true if  $\text{Prim } A$  (=the set of all primitive ideals of  $A$ ) is a Hausdorff-space in the hull-kernel topology. The basis of the proof of this fact is the following recent result by Dauns and Hofmann [2]. If  $A$  is a  $C^*$ -algebra,  $C^b(\text{Prim } A)$  is the space of all bounded continuous complex-valued functions on  $\text{Prim } A$ , then for each  $x \in A$ ,  $h \in C^b(\text{Prim } A)$  there is an element  $y \in A$  such that

$$y(\text{mod } I) = h(I) \cdot (x(\text{mod } I))$$

for all  $I \in \text{Prim } A$ . More conveniently, this result may be reformulated as follows. For each  $I \in \text{Prim } A$ , let  $A/I$  be the quotient  $C^*$ -algebra, and let  $\varphi_I: A \rightarrow A/I$  be the canonical quotient homomorphism. Let  $\Gamma = \sum_{\oplus, I \in \text{Prim } A} A/I$  be the  $C^*$ -direct product of the  $A/I$ . We define a map  $\varphi: A \rightarrow \Gamma$  by

$$\varphi(x) = \{\varphi_I(x)\}.$$

$\varphi$  then becomes an isometric isomorphism of  $A$  onto a closed  $C^*$ -subalgebra of  $\Gamma$ . We may therefore identify  $A$  with its image under  $\varphi$ , and write  $x$  for  $\varphi(x)$ . In this way  $x$  becomes a vector-field on  $\text{Prim } A$  with values in the various  $A/I$ , and we write  $x(I) = \varphi_I(x)$ ;  $x \in A$ ,  $I \in \text{Prim } A$ . With these conventions the Dauns-Hofmann result takes the form: For each  $x \in A$ , and  $h \in C^b(\text{Prim } A)$ , there is  $y \in A$  such that

$$y(I) = h(I) x(I); \quad I \in \text{Prim } A.$$

Now suppose that  $\text{Prim } A$  is Hausdorff, and let  $\varrho$  be a pure quasi-state on  $A$ . The positive solution of (I) then takes the form: There is an element  $I_0 \in \text{Prim } A$  such that if  $x \in A$ , then  $x(I_0) = 0 \Rightarrow \varrho(x) = 0$ .

The lifting problem (II) now takes the form: if  $x, y \in A$  and  $x(I_0) = y(I_0)$ , can we show that  $\varrho(x) = \varrho(y)$ ? A simple calculation shows that if  $h = h^* \in C^b(\text{Prim } A)$ , and  $h(I_0) = 1$ , then  $\varrho(x) = \varrho(hx)$  for all  $x \in A$ . From this it follows that if  $x(I) = y(I)$  on some neighbourhood  $W$  of  $I_0$  in  $\text{Prim } A$ , then  $\varrho(x) = \varrho(y)$ . Indeed, choose  $h \in C^b(\text{Prim } A)$  such that  $h \geq 0$ ,  $h(I_0) = 1$  and  $h$  vanishes outside  $W$ . Then  $hx = hy$ , so  $\varrho(x) = \varrho(hx) = \varrho(hy) = \varrho(y)$ .

In the special case where  $\text{Prim } A$  is discrete, it therefore follows that (II) has a positive solution.

A positive linear functional on a  $C^*$ -algebra is automatically continuous. This is far from obvious for quasi-states. However, if we *assume* that the pure quasi-state  $\varrho$  on  $A$  is continuous, then  $\varrho$  can indeed be lifted to a pure quasi-state  $\bar{\varrho}$  on  $A/I_0$ .

With respect to part (III) of the problem, the situation is less encouraging. Only very special solutions exist. However, on the basis of the fact mentioned previously, that any quasi-state on  $\mathcal{LC}(H)$  is linear if  $\dim H \geq 3$ , one may show the following results:

(a) Any quasi-state on a dual  $C^*$ -algebra  $A$  is linear if  $\dim \pi \neq 2$  for all irreducible representations  $\pi$  of  $A$ .

(b) If  $A$  is *CCR* with  $\text{Prim } A$  Hausdorff and  $\dim \pi \neq 2$  for all irreducible representations  $\pi$  of  $A$ , then each pure, continuous quasi-state on  $A$  is linear.

Some other cases will be treated in [1].
