An open-closed cobordism category with background space

In this paper we introduce an open-closed cobordism category with maps to a background space. We identify the classifying space of this category for certain classes of background space. The key ingredient is the homology stability of mapping class groups with twisted coefficients.

1 Introduction

In the late seventies and early eighties, cobordism categories were used by Atiyah and Segal to give an axiomatic description of field theories. Indeed, much of the motivation to study cobordism categories and many of the indications of how we should do so come from mathematical physics. Informally, the relationship between mathematical physics and cobordism theory can be seen in the following: if we track the motion of a collection of strings through time then the space they sweep out, their worldsheet, is precisely a cobordism.

Cobordism categories have been studied in algebraic topology in connection with mapping class groups and infinite loop space theory. The first work of this kind was Tillmann's result in [16] relating the classifying space of the 2-dimensional cobordism category to the classifying space of the stable mapping class group. Then Galatius–Madsen-Tillmann-Weiss [6] identified the classifying space of the d-dimensional cobordism category for any $d \ge 1$, showing that it is homotopy equivalent to a familiar infinite loop space. Together, these two results give a new proof of Madsen and Weiss' generalization of the Mumford conjecture which allows the calculation of the rational cohomology of the stable mapping class group.

The cobordism categories studied in those papers feature cobordisms between *closed* manifolds. These pertain to closed field theories in physics. Also of interest are *open-closed* field theories and, correspondingly, open-closed cobordisms ie cobordisms between manifolds that may have boundary. Just as the worldsheet of a collection of (closed) strings is an (ordinary) cobordism, so the worldsheet of a collection of open and closed strings is an open-closed cobordism.

The definition is as follows. An oriented open-closed cobordism between two oriented (d-1)-manifolds M_1 and M_2 is an oriented d-dimensional manifold W such that:

- (i) $\partial W = (\partial_{in} W \sqcup \partial_{out} W) \cup \partial_f W$.
- (ii) There are diffeomorphisms $\partial_{in}W\cong M_1$ and $\partial_{out}W\cong -M_2$ where $-M_2$ means M_2 with the opposite orientation.
- (iii) $(\partial_{\text{in}} W \sqcup \partial_{\text{out}} W) \cap \partial_f W = \partial(\partial_f W) = \partial(\partial_{\text{in}} W \sqcup \partial_{\text{out}} W).$




Figure 1: An open-closed cobordism

An example of an open-closed cobordism is given in Figure 1. We call $\partial_f W$ the

free boundary of W and the closed components of $\partial_f W$ windows. The open-closed cobordism in Figure 1 has one window. We think of the boundary of an open-closed cobordism from M_1 to M_2 as the union of three pieces; M_1 , M_2 and the free boundary. Note that in particular (ii) and (iii) imply that $\partial_f W$ is a cobordism from ∂M_1 to ∂M_2 .

Open-closed cobordism categories have recently been studied for example by Baas–Cohen–Ramirez [1], Lauda–Pfeiffer [10] and Ramirez [14]. In this paper we study a 2–dimensional open-closed cobordism category in which the 1–manifolds and the cobordisms carry a map to a background space. More precisely, for a fixed background space X and subspace $N \subseteq X$, we study the category $\mathcal{C}_{X,N}$ whose objects are oriented 1–manifolds S embedded in \mathbb{R}^{∞} and equipped with a map $(S, \partial S) \to (X, N)$ and whose morphisms are oriented 2–dimensional open-closed cobordisms F embedded in $\mathbb{R}^{\infty} \times [0, 1]$ and equipped with a map $(F, \partial_f F) \to (X, N)$. There is a topology on $\mathcal{C}_{X,N}$ which we give in Section 2.1.

In open-closed string theory the strings move in a background manifold M and there is often a collection of submanifolds $\{N_b \subseteq M\}_{b \in \mathcal{B}}$ specified. These are called the D-branes and the movement of an open string is restricted by the requirement that its endpoints must move within certain of the D-branes. The category $\mathcal{C}_{X,N}$ is intended

to be a model of open and closed strings moving in X with the components of N as the set of D-branes.

The operation of disjoint union gives an ill-defined multiplicative structure on $\mathcal{C}_{X,N}$. This structure is enough to ensure that $B\mathcal{C}_{X,N}$ is an infinite loop space as we show in Section 2.3. The main result of this paper is to identify that infinite loop space in the case that X is simply connected and N is discrete. For technical reasons, we are forced to work with a modified version of $\mathcal{C}_{X,N}$ which we denote by $\widetilde{\mathcal{C}}_{X,N}^b$.

In the recent preprint [7], Genauer studies cobordism categories of manifolds with corners in a more general setting, dealing with higher dimensions and tangent structures on the manifolds. The techniques used are very different to those here, and follow Galatius–Madsen–Tillmann–Weiss [6]. One point of note is that [7] gives a calculation of $B\mathcal{C}_{*,*}$ which differs from our calculation of $B\widetilde{\mathcal{C}}_{*,*}^b$.

Summary of results We fix a space X, a subspace N and a basepoint $* \in N$. Our techniques lead us to consider moduli spaces

$$S(F; X, N)_* := E \operatorname{Diff}_{\operatorname{oc}}^+(F) \times_{\operatorname{Diff}_{\infty}^+(F)} \operatorname{Map}(F, \partial_f F; X, N)_*$$

where F is a connected 2-dimensional open-closed cobordism with $\partial_{\text{out}}F=S^1$, $\text{Diff}_{\text{oc}}^+(F)$ is the group of orientation-preserving diffeomorphisms that fix $\partial_{\text{in}}F\cup\partial_{\text{out}}F$ pointwise and $\text{Map}(F,\partial_f F;X,N)_*$ is the space of maps which carry $\partial_{\text{in}}F\cup\partial_{\text{out}}F$ to the basepoint.

In Section 3.1 we show that the spaces $S(F; X, N)_*$ have good homology stability properties. This is a consequence of the homology stability of mapping class groups with twisted coefficients which was proved by Cohen–Madsen [3] and Ivanov [9]. We actually require some extensions of the original stability theorems and we establish these in Section 3.1.

We also consider stabilized versions of the spaces $S(F;X,N)_*$. Let F^1 be obtained from F by gluing a torus with three holes to the outgoing boundary of F (here the torus with three holes is thought of as an open-closed cobordism from S^1 to itself). So F^1 is an open-closed cobordism with $\partial_{\rm in}F^1=\partial_{\rm in}F$, $\partial_{\rm out}F^1=\partial_{\rm out}F=S^1$, and F^1 has one more window and one greater genus than F. The inclusion $F\to F^1$ induces a map

$$S(F; X, N)_* \to S(F^1; X, N)_*$$

given by extending diffeomorphisms by the identity and extending the maps to X by c_* , the constant map to the basepoint. Let F^2 be obtained from F^1 by gluing on another torus with three holes and so on. Define $\mathcal{S}_{\infty}^{\infty}(F;X,N)_*$ to be

$$\operatorname{hocolim}(\mathcal{S}(F; X, N)_* \to \mathcal{S}(F^1; X, N)_* \to \mathcal{S}(F^2; X, N)_* \to \cdots).$$

Using the homology stability for the spaces $S(F; X, N)_*$ and a generalised group completion theorem, we prove the following theorem in Section 3.2.

Theorem 1.1 Suppose that X is simply connected and N is discrete. For any connected open-closed cobordism F with $\partial_{\text{out}} F = S^1$ there is a homology isomorphism

$$\mathbb{Z} \times \mathbb{Z} \times \mathcal{S}_{\infty}^{\infty}(F; X, N)_{*} \to \Omega B \widetilde{\mathcal{C}}_{X,N}^{b}.$$

When F is an ordinary cobordism, ie $\partial_{\text{in}}F$ and $\partial_{\text{out}}F$ are closed and F has no free boundary, the subspace N plays no role. In this case we will write the space $S(F;X,N)_*$ simply as $S(F;X)_*$. For such F we may also wish to stabilize with respect to genus only. Let $F^{[1]}$ denote the surface obtained from F by gluing on a torus with two holes and let $F^{[2]}$ be obtained from $F^{[1]}$ in the same fashion. Define

$$\mathcal{S}_{\infty}(F;X)_* = \text{hocolim}(\mathcal{S}(F;X)_* \to \mathcal{S}(F^{[1]};X)_* \to \mathcal{S}(F^{[2]};X)_* \to \cdots).$$

The spaces $S(F; X)_*$ and $S_{\infty}(F; X)_*$ were defined and studied by Cohen–Madsen [3].

For any space Y let Q(Y) denote the infinite loop space $\mathrm{colim}_{k\to\infty}\Omega^k\Sigma^kY$ and let Y_+ denote the union of Y and a disjoint basepoint. Using the homology stability for the spaces $\mathcal{S}(F;X,N)_*$ and splitting techniques analogous to those in [2], in Section 3.3 we prove the following.

Theorem 1.2 Suppose that X is simply connected and N is discrete. Let F be a connected open-closed cobordism from some closed, oriented 1-manifold to S^1 and let \overline{F} be the ordinary cobordism obtained by gluing a disc to each window of F. Then there is a homology isomorphism

$$\mathbb{Z} \times \mathcal{S}_{\infty}^{\infty}(F; X, N)_{*} \to \mathcal{S}_{\infty}(\overline{F}; X)_{*} \times Q((BS^{1} \times N)_{+}).$$

To state our main theorem we must first recall the definition of the spectrum MTSO(2) studied in Galatius–Madsen–Tillmann–Weiss [6], Madsen–Tillmann [11] and Madsen–Weiss [12]. Let $\mathrm{Gr}_n^+(\mathbb{R}^2)$ be the Grassmannian of oriented 2-planes in \mathbb{R}^n and γ_n be the canonical bundle over it. Let γ_n^\perp denote the orthogonal complement of γ_n , consisting of pairs (U,v) of an oriented 2-plane U in \mathbb{R}^n and an n-vector v perpendicular to it. The n-th space in the spectrum MTSO(2) is the Thom space $\mathrm{Th}(\gamma_n^\perp)$. There is a natural inclusion $\mathrm{Gr}_2^+(\mathbb{R}^n) \to \mathrm{Gr}_2^+(\mathbb{R}^{n+1})$ and we have that $\gamma_{n+1}^\perp|_{\mathrm{Gr}_2^+(\mathbb{R}^n)} \cong \gamma_n^\perp \oplus \epsilon^1$ where ϵ^1 is a trivial line bundle. Thus we obtain a map

$$\Sigma MTSO(2)_n = \Sigma Th(\gamma_n^{\perp}) \simeq Th(\gamma_n^{\perp} \oplus \epsilon^1) \to Th(\gamma_{n+1}) = MTSO(2)_{n+1}$$

and this completes the definition of MTSO(2).

It was shown in [3] that $\mathbb{Z} \times \mathcal{S}_{\infty}(\overline{F}; X)_*$ has the same homology as the infinite loop space $\Omega^{\infty}(MTSO(2) \wedge X_+)$. In Section 3.5 we use this result together with Theorem 1.1 and Theorem 1.2 to prove our main theorem.

Theorem 1.3 When X is simply connected and N is discrete there is a weak homotopy equivalence

$$\Omega B\widetilde{\mathcal{C}}_{X,N}^b \simeq \Omega^\infty(MTSO(2) \wedge X_+) \times Q((BS^1 \times N)_+).$$

The paper is organised as follows. In Section 2 we give the full definitions of the open-closed cobordism categories and investigate their path-components. We also prove that the classifying spaces carry an infinite loop space structure. In Section 3 we prove Theorems 1.1, 1.2 and 1.3. Section 4 is an appendix containing the proofs of the homology stability theorems from Section 3.

2 Definition and properties of the category

2.1 Definitions

In this section we give the full definition of $\mathcal{C}_{X,N}$ and define the modified category $\widetilde{\mathcal{C}}_{X,N}^b$.

Let $S_{m,n}$ denote the union of m oriented circles and n oriented intervals and let $\operatorname{Emb}(S_{m,n},\mathbb{R}^k)$ denote the space of smooth embeddings, equipped with the Whitney C^{∞} -topology. Set

$$\operatorname{Emb}(S_{m,n},\mathbb{R}^{\infty}) := \operatorname{colim}_{k \to \infty} \operatorname{Emb}(S_{m,n},\mathbb{R}^{k}).$$

Let $\operatorname{Diff}^+(S_{m,n})$ denote the group of orientation-preserving diffeomorphisms of $S_{m,n}$. This group acts on the right of the embedding space by precomposition. It also acts on the space $\operatorname{Map}(S_{m,n}, \partial S_{m,n}; X, N)$. The object space of $\mathcal{C}_{X,N}$ is defined to be the disjoint union of orbit spaces

$$\coprod_{m,n\geq 0} \operatorname{Emb}(S_{m,n},\mathbb{R}^{\infty}) \times_{\operatorname{Diff}^+(S_{m,n})} \operatorname{Map}(S_{m,n},\partial S_{m,n};X,N).$$

We can think of an object as an embedded 1-manifold with a map to the background space. We'll often write objects in the category as $Diff^+$ -equivalences classes [e, f].

When we have an object $\alpha = [e, f]$ and $e: S \to \mathbb{R}^{\infty}$ and $f: (S, \partial S) \to (X, N)$ we will say that S is the *underlying* 1-*manifold* of α .

Next we move on to defining the morphism space in the category. We require our cobordisms to have parametrized collars around their incoming and outgoing boundary. Explicitly, this means that if F is a 2-dimensional open-closed cobordism, we assume that F is equipped with parametrizations

$$c_{\text{in}}$$
: $[0, 1) \times \partial_{\text{in}} F \to F$ and c_{out} : $(-1, 0] \times \partial_{\text{out}} F \to F$.

If $\epsilon \in (0,1)$ and F is an open-closed cobordism, $\mathrm{Diff}_{\epsilon}^*(F)$ denotes the group of orientation-preserving diffeomorphisms of F which preserve the decomposition of ∂F and restrict to product maps on the ϵ -collars. We define

$$\operatorname{Diff}^*(F) := \operatorname{colim}_{\epsilon \to 0} \operatorname{Diff}^*_{\epsilon}(F).$$

Let $\operatorname{Emb}_{\epsilon}(F,\mathbb{R}^n \times [0,1])$ denote the space of embeddings which embed the incoming boundary in $\mathbb{R}^n \times \{0\}$, the outgoing boundary in $\mathbb{R}^n \times \{1\}$ and embed the ϵ -collars perpendicular to these walls.

Define

$$\operatorname{Emb}\left(F,\mathbb{R}^{\infty}\times[0,1]\right):=\operatorname{colim}_{n\to\infty,\epsilon\to0}\operatorname{Emb}_{\epsilon}(F,\mathbb{R}^{n}\times[0,1]).$$

The morphism space of $C_{X,N}$ is defined to be

$$\coprod_{F} \operatorname{Emb} (F, \mathbb{R}^{\infty} \times [0, 1]) \times_{\operatorname{Diff}^{*}(F)} \operatorname{Map} (F, \partial_{f} F; X, N).$$

In this disjoint union there is one open-closed cobordism from each isomorphism class; two open-closed cobordisms F, F' are isomorphic if there is an orientation-preserving diffeomorphism $\theta \colon F \to F'$ with $\theta(\partial_{\text{in}} F) = \partial_{\text{in}} F'$ and $\theta(\partial_{\text{out}} F) = \partial_{\text{out}} F'$.

We can think of a morphism as an embedded open-closed cobordism equipped with a map to the background space. We'll write morphisms as Diff*-equivalence classes $[h, \phi]$. When we have a morphism $m = [h, \phi]$ and $h: F \to \mathbb{R} \times [0, 1]$ and $\phi: (F, \partial_f F) \to (X, N)$ we will say that F is the *underlying open-closed cobordism* of m.

Note that the assignment $(X, N) \mapsto \mathcal{C}_{X,N}$ defines a functor from the category of pairs of spaces to the category of topological categories. This functor is homotopy invariant; a homotopy equivalence of pairs $(X, N) \to (X', N')$ induces a homotopy equivalence $B\mathcal{C}_{X,N} \to B\mathcal{C}_{X',N'}$.

Let us remark on two interesting choices of background space. In the case that $N = \emptyset$, there are no maps $(S, \partial S) \to (X, N)$ unless ∂S is empty. Thus the only objects in $\mathcal{C}_{X,N}$ are closed 1-manifolds. Similarly the only cobordisms are those with no free boundary.

In this case $\mathcal{C}_{X,N}$ is the same as the ordinary 2-dimensional oriented cobordism category with background space, $\mathcal{C}_2^+(X)$, as studied by Galatius-Madsen-Tillmann-Weiss [6]. When X is contractible and N is discrete, a map $(S, \partial S) \to (X, N)$ is the same thing as a labeling of the boundary points of S by points in N and a map $(F, \partial_f F) \to (X, N)$ is the same thing as a labeling of the components of $\partial_f F$ by points in N. In this case, $\mathcal{C}_{X,N}$ is a model of the open-closed cobordism category with labeling set N as studied by Baas-Cohen-Ramirez [1].

We'll now move on to define the modified category $\widetilde{\mathcal{C}}_{X,N}^b$. Let $\mathcal{C}_{X,N}^b$ denote the subcategory of $\mathcal{C}_{X,N}$ in which every component of every cobordism must have nonempty outgoing boundary. In $\mathcal{C}_{X,N}^b$, any morphism to a circle must be connected. The category $\widetilde{\mathcal{C}}_{X,N}^b$ will be an enriched version of $\mathcal{C}_{X,N}^b$; its objects are like those of $\mathcal{C}_{X,N}^b$ except that they carry an extra piece of data and the morphisms must respect that data.




Figure 2: Morphisms in the category \mathcal{D}

To explain this, let us first introduce a 1-dimensional cobordism category \mathcal{D} . The objects in \mathcal{D} are compact oriented 0-dimensional manifolds. The morphisms in \mathcal{D} are equivalence classes of oriented 1-dimensional cobordisms. Two such cobordisms L_1 and L_2 are said to be equivalent if there is an orientation-preserving diffeomorphism $I(L_1) \to I(L_2)$, where $I(L_i)$ denotes the union of the intervals in L_i , that restricts to the identity on the boundary. See Figure 2.




Figure 3: The functor R

There is a functor $R: \mathcal{C}^b_{X,N} \to \mathcal{D}$ given by sending an object with underlying 1-manifold S to ∂S and a morphism with underlying open-closed cobordism F to the equivalence class of $\partial_f F$; see Figure 3. $\widetilde{\mathcal{C}}^b_{X,N}$ is defined to be the Quillen over-category R/\varnothing . Thus the objects of $\widetilde{\mathcal{C}}^b_{X,N}$ are pairs (α,l) where α is an object in $\mathcal{C}^b_{X,N}$ and l is a morphism in \mathscr{D} from $R(\alpha) \to \varnothing$. A morphism from (α,l) to (β,k) in $\widetilde{\mathcal{C}}^b_{X,N}$ is a morphism $m: \alpha \to \beta$ in $\mathcal{C}^b_{X,N}$ such that $k \circ R(m) = l$.

If α is an object in $\mathcal{C}^b_{X,N}$ whose underlying 1-manifold is closed then there is only one morphism in \mathcal{D} from $\mathbf{R}(\alpha)=\varnothing$ to \varnothing ; the equivalence class of the empty cobordism. We will use \varnothing to denote this morphism.

If β is an object in $\mathcal{C}^b_{X,N}$ whose underlying 1-manifold is a circle then any morphism $m: (\alpha, l) \to (\beta, \emptyset)$ in $\widetilde{\mathcal{C}}^b_{X,N}$ must be connected and satisfy $\emptyset \circ R(m) = l$. If F is the underlying cobordism of m this means that there is an orientation-preserving

diffeomorphism $I(\partial_f F) \to I(l)$ that restricts to the identity on the boundary. Thus the isomorphism type of F is determined by only two invariants; the genus and the number of windows (the remaining boundary structure being prescribed by l.) This is the reason that we want to work with $\widetilde{\mathcal{C}}_{X,N}^b$; in Section 3.2 we need to have good control over the space of morphisms from an arbitrary object to a circle.

2.2 Path-components

When N has more than one path-component, the classifying space $B\widetilde{\mathcal{C}}_{X,N}^b$ is not connected. In this section we will give a description of $\pi_0 B\widetilde{\mathcal{C}}_{X,N}^b$ in the case that X is simply connected.

For an oriented 1-manifold S let $\partial_+ S \subseteq \partial S$ denote the collection of points that are positively oriented in the orientation induced from S, and $\partial_- S$ those that are negatively oriented.

Definition 2.1 The *weighted signature* of an object $(\alpha, l) = ([e, f], l)$ in $\widetilde{\mathcal{C}}_{X,N}^b$ with underlying 1-manifold S is the function $b_{(\alpha, l)} \colon \pi_0 N \to \mathbb{Z}$ given by

$$b_{(\alpha,l)}(N_i) = |\partial_+ S \cap f^{-1}(N_i)| - |\partial_- S \cap f^{-1}(N_i)|.$$

This definition does not depend on the choice of representative (e, f) for α .

Note that

(i)
$$\sum_{N_i \in \pi_0 N} b_{(\alpha,l)}(N_i) = |\partial_+ S| - |\partial_- S| = 0,$$

(ii)
$$\sum_{N_i \in \pi_0 N} |b_{(\alpha,l)}(N_i)| \le |\partial_+ S| + |\partial_- S| < \infty,$$

and as a consequence of (i),

(iii)
$$\sum_{N_i \in \pi_0 N} |b_{(\alpha,l)}(N_i)| \text{ is always even.}$$

So each $b_{(\alpha,l)}$ is an element of

$$\mathcal{B}_N := \left\{ b \colon \pi_0 N \to \mathbb{Z} \mid \sum_{N_i \in \pi_0 N} b(N_i) = 0, \sum_{N_i \in \pi_0 N} |b(N_i)| \in 2\mathbb{Z} \right\}.$$

Furthermore, every element of \mathcal{B}_N can occur as a weighted signature.

Lemma 2.2 If there is a morphism $m: (\alpha, l) \to (\beta, k)$ in $\widetilde{\mathcal{C}}_{X,N}^b$ then $b_{(\alpha, l)} = b_{(\beta, k)}$.




Figure 4: Joining oriented points

Proof Let $\alpha = [e, f]$ and $\beta = [\tilde{e}, \tilde{f}]$ have underlying 1-manifolds S and \tilde{S} respectively. Suppose that $m = [h, \phi]$ has underlying open-closed cobordism F. The path-components of $\partial_f F$ are either windows or intervals joining points of $\partial_+ S \cup \partial_- \tilde{S}$ to points of $\partial_- S \cup \partial_+ \tilde{S}$ (see Figure 4 where points of $\partial_+ S \cup \partial_- \tilde{S}$ are marked \odot and points of $\partial_- S \cup \partial_+ \tilde{S}$ are marked \bullet). If L is such an interval then $\phi(L) \subseteq N$ is a path

from $\phi(\partial_- L)$ to $\phi(\partial_+ L)$. Hence if two points are joined by an interval in $\partial_f F$, they must map into the same path-component of N. Thus for each path-component N_i we must have

$$|(\partial_{+}S \cup \partial_{-}\widetilde{S}) \cap f^{-1}(N_{i})| = |(\partial_{-}S \cup \partial_{+}\widetilde{S}) \cap f^{-1}(N_{i})|$$

which implies $b_{(\alpha,l)} = b_{(\beta,k)}$.

Corollary 2.3 The category $\tilde{\mathcal{C}}_{X,N}^b$ decomposes as the disjoint union

$$\widetilde{\mathcal{C}}_{X,N}^b = \coprod_{b \in \mathcal{B}_N} \widetilde{\mathcal{C}}_{X,N}^b(b)$$

where $\widetilde{\mathcal{C}}_{X,N}^b(b)$ is the full-subcategory of $\widetilde{\mathcal{C}}_{X,N}^b$ whose objects are those with weighted signature b.

Proposition 2.4 $\pi_0 B \widetilde{\mathcal{C}}_{XN}^b \cong \mathcal{B}_N$.




Figure 5: Morphisms $\alpha \rightarrow \gamma$ and $\beta \rightarrow \gamma$

Proof Given Corollary 2.3 it suffices to show that each $B\widetilde{\mathcal{C}}_{X,N}^b(b)$ is path-connected. To do this it is enough to show that for every pair of objects (α,l) and (β,k) in $\widetilde{\mathcal{C}}_{X,N}^b(b)$ there exists a third object (γ,j) and morphisms $(\alpha,l) \to (\gamma,j)$ and $(\beta,k) \to (\gamma,j)$. The constructions below are illustrated in Figure 5.

Let $-\alpha$ be the same as α but with the underlying 1-manifold having the opposite orientation and define $(\gamma, j) = (\alpha \cup -\alpha \cup \beta, l \cup -l \cup k)$. Here we implicitly assume that the embeddings of the objects have been shifted so as to be disjoint. The identity morphism id_{α} can be twisted around to give a morphism $\varnothing \to (\alpha \cup -\alpha, l \cup -l)$ and if we take the union of this twisted morphism with id_{β} we obtain a morphism

$$(\beta, k) \to (\alpha \cup -\alpha \cup \beta, l \cup -l \cup k) = (\gamma, j).$$

To construct a morphism $(\alpha, l) \to (\gamma, j)$ we first show that there is a morphism $m: \alpha \to \beta$ in $\mathcal{C}^b_{X,N}$. Suppose that $\alpha = [e, f]$, $\beta = [\widetilde{e}, \widetilde{f}]$ and that the underlying 1-manifolds are S, \widetilde{S} respectively. Since $b_{(\alpha,l)} = b_{(\beta,k)}$ it is possible to pair the points of $\partial_+ S \cup \partial_- \widetilde{S}$ with the points of $\partial_- S \cup \partial_+ \widetilde{S}$ in such a way that two paired points map into the same component of N. If we attach an oriented interval between paired points, we obtain a cobordism S_0 from ∂S to $\partial \widetilde{S}$.

The closed 1-manifold $S \cup S_0 \cup -\widetilde{S}$ is the boundary of some connected, oriented open-closed cobordism F from S to \widetilde{S} (with $\partial_f F = S_0$). Furthermore there is an embedding $h \colon F \to \mathbb{R}^\infty \times [0,1]$ with $h|_{\partial_{\inf} F} = e$ and $h|_{\partial_{\inf} F} = \widetilde{e}$.

Because of the way that S_0 was constructed, the maps $f: (S, \partial S) \to (X, N)$ and $\widetilde{f}: (\widetilde{S}, \partial \widetilde{S}) \to (X, N)$ can be extended over S_0 to give a map $f: (\partial F, S_0) \to (X, N)$. Since X is simply connected, \overline{f} can be extended to a map $\phi: (F, \partial_f F) \to (X, N)$. Now $m = [h, \phi]: \alpha \to \beta$ is our required morphism.

Note that m does not necessarily give a morphism $(\alpha, l) \to (\beta, k)$ because we don't know that $k \circ R(m) = l$. However, the morphism $m \cup \mathrm{id}_{\alpha}$ from $(\alpha \cup \alpha) \to (\alpha \cup \beta)$ can be twisted around to give the required morphism

$$(\alpha, l) \to (\alpha \cup -\alpha \cup \beta, l \cup -l \cup k) = (\gamma, j). \qquad \Box$$

Disjoint union in the category corresponds to addition of elements in \mathcal{B}_N . Thus we have the following corollary.

Corollary 2.5 When X is simply connected, $\pi_0 B \tilde{\mathcal{C}}_{X,N}^b$ is a group.

These methods can be adapted to show that $\pi_0 BC_{X,N}$ is in bijective correspondence with \mathcal{B}_N and that it's a group.

2.3 Infinite loop space structure

Disjoint union gives a multiplication operation on $\widetilde{\mathcal{C}}_{X,N}^b$ and, although this is not well-defined, it is enough to make $B\widetilde{\mathcal{C}}_{X,N}^b$ into a Γ -space in the sense of Segal [15]. In the case that X is simply connected, we also know that $\pi_0 B\widetilde{\mathcal{C}}_{X,N}^b$ is a group and these two facts together with [15] imply that $B\widetilde{\mathcal{C}}_{X,N}^b$ is an infinite loop space. We will now explain the Γ -space structure on $B\widetilde{\mathcal{C}}_{X,N}^b$, closely following Madsen-Tillmann [11, Theorem 2.3].

Let Γ^{op} denote the category of finite based sets $\underline{n} = \{0, 1, ..., n\}$ and based maps. A Γ -space is a functor \mathcal{F} from Γ^{op} to simplicial spaces satisfying:

- $(i) \quad \mathcal{F}(\underline{0}) \simeq *.$
- (ii) The map $\prod_{i=1}^n p_i \colon \mathcal{F}(\underline{n}) \to \mathcal{F}(\underline{1}) \times \cdots \times \mathcal{F}(\underline{1})$ is a homotopy equivalence where $p_i \colon \underline{n} \to \underline{1}$ sends i to 1 and $j \neq i$ to 0.

We now define a Γ -space \mathcal{N} , with $\mathcal{N}(\underline{1}) = \mathrm{N}_* \widetilde{\mathcal{C}}_{X,N}^b$, the nerve of the category $\widetilde{\mathcal{C}}_{X,N}^b$. Before we begin, let us introduce some notation; if $m = [h_0, \phi_0] \circ \cdots \circ [h_{q-1}, \phi_{q-1}]$ is an element of $\mathrm{N}_q \widetilde{\mathcal{C}}_{X,N}^b$, that is, a q-tuple of composable morphisms, we will use $\pi_0 m$ to denote the connected components of $\mathrm{Im}(h_0 \# \cdots \# h_{q-1})$. If the target of m is the object (α, l) , then we will say that a labelling function $\lambda \colon \pi_0 m \to \{1, \ldots, n\}$ is good if $l \colon \mathcal{R}(\alpha) \to \emptyset$ joins two points of $\mathcal{R}(\alpha)$ only if they come from elements of $\pi_0 m$ with the same label.

Now let $\mathcal{N}(\underline{n})$ be the simplicial space whose q-simplices are the pairs (m, λ) where $m \in \mathbb{N}_q \widetilde{\mathcal{C}}_{X,N}^b$ and $\lambda \colon \pi_0 m \to \{1, \dots, n\}$ is a good labeling function. Given $s \colon \underline{n} \to \underline{m}$, define $s_* \colon \mathcal{N}(\underline{n}) \to \mathcal{N}(\underline{m})$ by $s_*(m, \lambda) = (\widetilde{m}, s \circ \lambda)$ where \widetilde{m} is obtained from m by deleting any components that are labeled zero by $s \circ \lambda$.

Proposition 2.6 \mathcal{N} is a Γ -space and hence, when X is simply connected, $B\widetilde{\mathcal{C}}_{X,N}^b$ is an infinite loop space.

Proof (Following [11, Theorem 2.3]) Certainly (i) is satisfied since $\mathcal{N}(0)$ is the nerve of the category containing only the empty 1-manifold and the empty cobordism. To check (ii), note that the map p_i sends $(m, \lambda) \in \mathcal{N}(n)_q$ to the union of the components of m that are labeled i by λ . Thus $\prod_{i=1}^n p_i$ carries $\mathcal{N}(n)_q$ injectively onto the complement $(\mathcal{N}(1)_q \times \cdots \times \mathcal{N}(1)_q) - \Delta$ where Δ is the fat diagonal of elements $((m_1, \lambda_1), \ldots, (m_n, \lambda_n))$ such that $m_i \cap m_j \neq \emptyset$ for some $i \neq j$. The inclusion of the complement of the fat diagonal into $\mathcal{N}(1)_q \times \cdots \times \mathcal{N}(1)_q$ is a homotopy equivalence; this is a consequence of the fact that the embedding spaces are contractible; see Madsen-Tillmann [11] for details. Thus

$$\prod_{i=1}^{n} p_{i} \colon \mathcal{N}(\underline{n}) \to \mathcal{N}(\underline{1}) \times \cdots \times \mathcal{N}(\underline{1})$$

is the product of a homeomorphism and a homotopy equivalence, and hence is itself a homotopy equivalence. \Box

These methods can be adapted to show that $BC_{X,N}$ is also an infinite loop space.

3 The homotopy type of the category

In this section we prove the main theorem of the paper, namely, we identify the homotopy type of $B\widetilde{\mathcal{C}}_{X,N}^b$ in the case that X is simply connected and N is discrete. We work under these assumptions throughout although some of the methods apply more generally.

3.1 Some requisite homology stability

In this section we establish the homology stability of the spaces $S(F; X, N)_*$ defined in the introduction. As mentioned there, this is a consequence of the homology stability of mapping class groups with twisted coefficients but we first need to establish some extensions of the original stability results.

We use $F_{g,n}$ to denote a surface of genus g with n boundary components and $\Gamma_{g,n} = \pi_0(\operatorname{Diff}^+(F_{g,n}, \partial F_{g,n}))$ to denote the associated mapping class group. A special case of stability with coefficients is the following.

Theorem 3.1 (Cohen–Madsen [3, Theorem 0.4]) Let X be a simply connected space and * a basepoint in X. Then the homology groups

$$H_q(\Gamma_{g,n}; H_r(\operatorname{Map}(F_{g,n}, \partial F_{g,n}; X, *)))$$

are independent of g and n provided that $g \ge 2q + r + 2$.

In [3], Theorem 3.1 was used to prove homology stability for the spaces $S(F; X)_*$ defined in the introduction.

In the results that follow, "cylinder" refers to the product of any 1-manifold with an interval. We remind the reader that, with respect to the figures in this paper, precomposing a cobordism F with another cobordism means gluing another cobordism to the left of F.

Theorem 3.2 (Cohen–Madsen [3, Theorem 0.3]) Suppose that X is simply connected. Let F be an ordinary, connected cobordism with $\partial_{\text{out}} F = S^1$ and let $F^{\#}$ be a connected cobordism obtained from F by precomposing with another ordinary cobordism. Then the map $S(F;X)_* \to S(F^{\#};X)_*$ induced by extending diffeomorphisms by the identity and extending maps to X by c_* induces an isomorphism

$$H_{\mathcal{S}}(\mathcal{S}(F;X)_*) \to H_{\mathcal{S}}(\mathcal{S}(F^{\sharp};X)_*)$$

provided the genus of F is greater than 2s + 4.

The following three theorems contain the extensions of Theorem 3.1 that we'll need. The proofs are contained in the Appendix. The notation for the mapping spaces and diffeomorphism groups is as in the introduction. We use $\Gamma_{\rm oc}(F)$ to denote $\pi_0({\rm Diff}_{\rm oc}^+(F))$ where F is an open-closed cobordism. The first theorem describes the situation where the number of windows is fixed.

Theorem 3.3 Suppose that X is simply connected and N is discrete. Let F be a connected open-closed cobordism with $\partial_{\text{out}}F = S^1$ and let F^* be a connected cobordism obtained from F by precomposing with another cobordism. If F and F^* have the same number of windows then the map

$$H_s(B\Gamma_{oc}(F), H_r(\operatorname{Map}(F, \partial_f F; X, N)_*))$$

$$\longrightarrow H_s(B\Gamma_{oc}(F^\#), H_r(\operatorname{Map}(F^\#, \partial_f F^\#; X, N)_*))$$

is an isomorphism provided the genus of F is at least 2s + r + 2.

The next two results tell us what happens when we increase the number of windows.

Theorem 3.4 Suppose that X is simply connected and N is a point. Let F be an open-closed cobordism as in Theorem 3.3 and let $F^{\#}$ be obtained from F by precomposing with a cylinder with one window. Then the map

$$H_s(B\Gamma_{oc}(F), H_r(\operatorname{Map}(F, \partial_f F; X, N)_*))$$

 $\longrightarrow H_s(B\Gamma_{oc}(F^\#), H_r(\operatorname{Map}(F^\#, \partial_f F^\#; X, N)_*))$

is an isomorphism provided the genus of F is greater than 2s + r + 2 and the number of windows is greater than 2s + 8.

When N is discrete but contains more than one point, the proof of Theorem 3.4 fails; we do not know that adding an extra window induces an isomorphism on the homology

$$H_s(B\Gamma_{oc}(F), H_r(\operatorname{Map}(F, \partial_f F; X, N)_*)).$$

Instead we find that in the limit, as the genus and number of windows tend to infinity, we get a homology isomorphism.

The inclusion $F \to F^1$ from the introduction induces a map $\Gamma_{oc}(F) \to \Gamma_{oc}(F^1)$ by extending diffeomorphisms by the identity. Let

$$\Gamma_{\infty}^{\infty}(F) = \operatorname{colim}(\Gamma_{\operatorname{oc}}(F) \to \Gamma_{\operatorname{oc}}(F^1) \to \Gamma_{\operatorname{oc}}(F^2) \to \cdots).$$

We also have a map

$$\operatorname{Map}(F, \partial_f F; X, N)_* \to \operatorname{Map}(F^1, \partial_f F^1; X, N)_*$$

given by extending maps by c_* , the constant map to the basepoint. Define the stabilised mapping space $\operatorname{Map}_{\infty}^{\infty}(F, \partial_f F; X, N)_*$ to be

hocolim
$$(\operatorname{Map}(F, \partial_f F; X, N)_* \to \operatorname{Map}(F^1, \partial_f F^1; X, N)_* \to \cdots).$$

For each k there is an action of $\Gamma_{\rm oc}(F^k)$ on ${\rm Map}(F^k,\partial_f F^k;X,N)_*$ and these actions are compatible with the maps used to form the limits. Thus we have an action of $\Gamma_{\infty}^{\infty}(F)$ on $H_s({\rm Map}_{\infty}^{\infty}(F,\partial_f F;X,N)_*)$ and we can form the homology group

$$H_r(B\Gamma_{\infty}^{\infty}(F); H_s(\mathrm{Map}_{\infty}^{\infty}(F, \partial_f F; X, N)_*)).$$

If $F^{\#}$ is obtained from F by precomposing with some other open-closed cobordism then we get induced maps

$$\Gamma_{\infty}^{\infty}(F) \to \Gamma_{\infty}^{\infty}(F^{\#})$$

$$\mathrm{Map}_{\infty}^{\infty}(F, \partial_{f}F; X, N)_{*} \to \mathrm{Map}_{\infty}^{\infty}(F^{\#}, \partial_{f}F^{\#}; X, N)_{*}$$

and an induced map on the twisted homology.

Theorem 3.5 Suppose that X is simply connected and N is discrete. Let F be as in Theorem 3.3 and let $F^{\#}$ be obtained from F by precomposing with a cylinder with one window. Then the induced map

$$\begin{split} H_{\mathcal{S}}(B\Gamma_{\infty}^{\infty}(F); H_{r}(\mathrm{Map}_{\infty}^{\infty}(F, \partial_{f}F; X, N)_{*})) \\ &\longrightarrow H_{\mathcal{S}}(B\Gamma_{\infty}^{\infty}(F^{\#}); H_{r}(\mathrm{Map}_{\infty}^{\infty}(F^{\#}, \partial_{f}F^{\#}; X, N)_{*})) \end{split}$$

is an isomorphism for all s, r.

We'll now use these theorems to prove homology stability properties for the spaces $S(F; X, N)_*$.

Corollary 3.6 (to Theorem 3.3) Suppose that X is simply connected and N is discrete. Let F be as in Theorem 3.3 and let $F^{\#}$ be a connected open-closed cobordism obtained from F by precomposing with another cobordism. If F and $F^{\#}$ have the same number of windows then inclusion induces an isomorphism

$$H_{\mathcal{S}}(\mathcal{S}(F;X,N)_*) \to H_{\mathcal{S}}(\mathcal{S}(F^{\sharp};X,N)_*)$$

provided the genus of F is greater than 2s + 4.

Proof Consider the following map of fibrations:

$$\operatorname{Map}(F, \partial_f F; X, N)_* \longrightarrow \mathcal{S}(F; X, N)_* \longrightarrow B \operatorname{Diff}_{\operatorname{oc}}^+(F)$$

$$\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow$$

$$\operatorname{Map}(F^\#, \partial_f F^\#; X, N)_* \longrightarrow \mathcal{S}(F^\#; X, N)_* \longrightarrow B \operatorname{Diff}_{\operatorname{oc}}^+(F^\#)$$

By the results of Earle–Eells [4] and Earle–Schatz [5], the components of the diffeomorphism groups are contractible except in a few low genus cases so $B\mathrm{Diff}^+_{\mathrm{oc}}(F)\simeq B\Gamma_{\mathrm{oc}}(F)$. There is an induced map of the Serre spectral sequences associated to these fibrations and on the E^2 -page it is the map

$$\begin{split} E_{p,q}^2 &= H_p(\Gamma_{\text{oc}}(F), H_q(\operatorname{Map}(F, \partial_f F; X, N)_*)) \\ &\longrightarrow \widetilde{E}_{p,q}^2 = H_p(\Gamma_{\text{oc}}(F^\#), H_q(\operatorname{Map}(F^\#\partial_f F^\#; X, N)_*)). \end{split}$$

Theorem 3.3 tells us this map is an isomorphism when the genus of F is greater than 2p+q+2 and the corollary follows by the Zeeman comparison theorem (see Ivanov [9, Theorem 1.2], for the comparison theorem in precisely the form we are using). \Box

Corollary 3.7 (to Theorem 3.4) Suppose X is simply connected and N is a point. Let F be as in Theorem 3.3 and let $F^{\#}$ be obtained from F by precomposing with a cylinder with one window then

$$H_s(\mathcal{S}(F;X,N)_*) \to H_s(\mathcal{S}(F^{\sharp};X,N)_*)$$

is an isomorphism provided the genus of F is greater than 2s + 4 and the number of windows is greater than 2s + 10.

Proof The proof is analogous to that of Corollary 3.6.

Corollary 3.8 (to Theorem 3.5) Suppose that X is simply connected and N is discrete. Let F be as in Theorem 3.3 and $F^{\#}$ be obtained from F by precomposing with a cylinder with one window. Then the map

$$H_{\mathcal{S}}(\mathcal{S}_{\infty}^{\infty}(F;X,N)_{*}) \to H_{\mathcal{S}}(\mathcal{S}_{\infty}^{\infty}(F^{\#};X,N)_{*})$$

is an isomorphism for all s.

Proof Again, this is analogous to the proof of Corollary 3.6.

3.2 A group completion argument

Given a contravariant functor F from a topological category $\mathcal C$ to the category Spaces of topological spaces, we can consider the category $F \wr \mathcal C$. The objects of $F \wr \mathcal C$ are pairs (c,x) with $c \in \operatorname{Obj}(\mathcal C)$ and $x \in F(c)$. The morphisms are pairs (m,y) with $m: a \to b$ a morphism in $\mathcal C$ and $x \in F(b)$; the morphism (m,y) has source (a,F(m)(x)) and target (b,x). There is a natural projection functor $F \wr \mathcal C \to \mathcal C$.

Theorem 3.9 (Galatius–Madsen–Tillmann–Weiss [6, Proposition 7.1]) Suppose that the natural map $Obj(F \wr C) \to Obj(C)$ is a Serre fibration and that $B(F \wr C)$ is contractible. If every morphism $m: a \to b$ in C induces an isomorphism

$$F(m)_*: H_*(F(\alpha); \mathbb{Z}) \to H_*(F(\beta); \mathbb{Z})$$

then for each object $c \in C$ there is a map $F(c) \to \Omega_c BC$ that induces an isomorphism in integral homology.

Here $\Omega_c BC$ denotes the space of loops in BC based at c.

We now define a functor $\operatorname{Mor}_{\infty} : \widetilde{C}^b_{X,N} \to \operatorname{Spaces}$ and show that Theorem 3.9 applies to it. Let $\beta_0 = [e_0, e_*]$ in $\operatorname{Obj}(\mathcal{C}^b_{X,N})$ where $e_0 : S^1 \to \mathbb{R}^2 \to \mathbb{R}^\infty$ is the canonical

embedding and $c_*: S^1 \to X$ is the map which is constant at the basepoint. Define a contravariant functor Mor₀: $\tilde{\mathcal{C}}^b_{X,N} \to \text{Spaces by}$

$$\operatorname{Mor}_0((\alpha, l)) := \operatorname{Mor}_{\widetilde{\mathcal{C}}_{X,N}^b}((\alpha, l), (\beta_0, \emptyset)).$$

Note that (β_0, \emptyset) lies in the component $\widetilde{\mathcal{C}}^b_{X,N}(0)$ of $\widetilde{\mathcal{C}}^b_{X,N}$. For those objects (α,l) that lie in some other component, we know from Section 2.2 that there are no morphisms from (α,l) to (β_0,\emptyset) so $\mathrm{Mor}_0((\alpha,l))$ is empty. For (α,l) in $\widetilde{\mathcal{C}}^b_{X,N}(0)$ we have the following proposition.

Proposition 3.10 Suppose X is simply connected and N is discrete. Let (α, l) be an object in $\widetilde{\mathcal{C}}^b_{X,N}(0)$ with underlying 1-manifold S. There is a homotopy equivalence

$$\operatorname{Mor}_0((\alpha, l)) \simeq \coprod_{g \geq 0} \coprod_{w \geq 0} \mathcal{S}(F_g^w; X, N)_*$$

where F_g^w is a connected open-closed cobordism from S to S^1 with w windows, genus g and having the boundary structure prescribed by l (see Section 2.1).

Proof Let $\alpha = [e, f]$ with underlying 1-manifold S. For any open-closed cobordism F from S to S^1 let

$$\left(\operatorname{Emb}(F;\mathbb{R}^{\infty}\times[0,1])\times\operatorname{Map}(F,\partial_{f}F;X,N)\right)_{[e\cup e_{0},f\cup c_{*}]}$$

be the subspace of pairs (h, ϕ) such that $[h|_{\partial_{\text{in}}F}, \phi|_{\partial_{\text{in}}F}] = [e, f]$ and $[h|_{\partial_{\text{out}}F}, \phi|_{\partial_{\text{out}}F}] = [e_0, c_*]$. Let

$$\left(\operatorname{Emb}(F; \mathbb{R}^{\infty} \times [0, 1]) \times \operatorname{Map}(F, \partial_f F; X, N)\right)_{e \cup e_0, f \cup c_*}$$

be the subspace of pairs (h, ϕ) where $(h|_{\partial_{in}F}, \phi|_{\partial_{in}F}) = (e, f)$ and $(h|_{\partial_{out}F}, \phi|_{\partial_{out}F}) = (e_0, c_*)$.

We noted in Section 2.1 that the isomorphism type of the cobordism underlying a morphism $m: (\alpha, l) \to (\beta_0, \emptyset)$ is completely determined by its genus and the number of windows. So $\text{Mor}_{\mathcal{C}_N^t}((\alpha, l), (\beta_0, \emptyset))$ is given by

$$\coprod_{g,w\geq 0} \left(\operatorname{Emb}(F_g^w;\mathbb{R}^\infty\times[0,1]) \times \operatorname{Map}(F_g^w,\partial_f F_g^w;X,N) \right)_{[e\cup e_0,f\cup c_*]} / \operatorname{Diff}^*(F_g^w).$$

Using an argument entirely analogous to that of Madsen–Tillmann [11, Theorem 2.1], it can be shown that the (g, w) component is homotopy equivalent to

$$\left(\operatorname{Emb}(F_g^w; \mathbb{R}^\infty \times [0, 1]) \times \operatorname{Map}(F_g^w, \partial_f F_g^w; X, N)\right)_{e \cup e_0, f \cup e_w} / \operatorname{Diff}_{\operatorname{oc}}^+(F_g^w).$$

Using the fact that the embedding space is contractible (by the Whitney embedding theorems), this is homotopy equivalent to

(1)
$$E \operatorname{Diff}_{\operatorname{oc}}^+(F_g^w, \mathbb{R}^\infty \times [0, 1]) \times_{\operatorname{Diff}_{\operatorname{con}}^+(F_g^w)} \operatorname{Map}(F_g^w, \partial_f F_g^w; X, N)_{f \cup c_*}.$$

To complete the proof, we will display a homotopy equivalence

$$\mathcal{H}: \operatorname{Map}(F, \partial_f F; X, N)_{f \cup c_*} \to \operatorname{Map}(F, \partial_f F; X, N)_{c_* \cup c_*}.$$

which induces a homotopy equivalence between the space in (1), and $\mathcal{S}(F_g^w; X, N)_*$.

For ease of notation, write $F = F_g^w$. To define \mathcal{H} , we first assume that for each non-window boundary component $\partial_i F$ of F, a closed collar

$$[0,1] \times \partial_i F \hookrightarrow F$$

has been specified, with $\{1\} \times \partial_i F$ identified with $\partial_i F$. Let ϕ be an element of Map $(F,\partial_f F;X,N)_{f\cup c_*}$. Because N is discrete, f completely determines $\phi|_{\partial_i F}$ for every non-window boundary component of F. Since X is simply connected, each $\phi|_{\partial_i F}$ is null-homotopic, by a homotopy $H^i\colon S^1\times I\to X$ say. Define $\mathcal H$ as follows; glue a cylinder to each of the boundary components $\partial_i F$ and let F' denote the surface we obtain. Given $\psi\in \operatorname{Map}(F,\partial_f F;X,N)_{f\cup c_*}$, define $\psi'\colon F'\to X$ by setting ψ' equal to ψ on $F\subseteq F'$ and equal to H^i on the cylinder glued on to $\partial_i F$. Fix a diffeomorphism $d\colon F\to F'$ that is the identity on the complement of the open collars $(0,1]\times\partial_i F$ and stretches the collars along the new cylinders. Set $\mathcal H(\psi):=\psi'\circ d$. This is a homotopy equivalence with homotopy inverse given by gluing on cylinders and extending maps by the conjugate homotopies $\overline{H^i}$.

The map \mathcal{H} is not $\mathrm{Diff}^+_{\mathrm{oc}}(F)$ —equivariant but we do have the following equivariance property. Let $\widetilde{\mathrm{Diff}}^+_{\mathrm{oc}}(F) \subseteq \mathrm{Diff}^+_{\mathrm{oc}}(F)$ denote the group of diffeomorphisms that restrict to the identity on the closed collars. The map \mathcal{H} is $\widetilde{\mathrm{Diff}}^+_{\mathrm{oc}}(F)$ —equivariant and the inclusion $\widetilde{\mathrm{Diff}}^+_{\mathrm{oc}}(F) \hookrightarrow \mathrm{Diff}^+_{\mathrm{oc}}(F)$ is a homotopy equivalence. Thus \mathcal{H} induces a homotopy equivalence from the space in (1) to $\mathcal{S}(F_g^w;X,N)_*$, as required. \square

Let $t: \beta_0 \to \beta_0$ denote the morphism $[h_0, c_*]$ where $h_0: T^2 - (3 \operatorname{discs}) \to \mathbb{R}^\infty \times [0, 1]$ is an embedding restricting to e_0 on the incoming and outgoing boundary (the torus with three holes being considered as a cobordism from the circle to itself) and c_* again represents the constant map. For an object (α, l) in $\widetilde{\mathcal{C}}_{XN}^b$ define

$$\operatorname{Mor}_{\infty}((\alpha, l)) = \operatorname{hocolim} (\operatorname{Mor}_{0}((\alpha, l)) \xrightarrow{T} \operatorname{Mor}_{0}((\alpha, l)) \xrightarrow{T} \cdots)$$

where the map T is given by composing with t. By Proposition 3.10 we have

(2)
$$\operatorname{Mor}_{\infty}((\alpha, l)) \simeq \mathbb{Z} \times \mathbb{Z} \times \mathcal{S}^{\infty}_{\infty}(F_{(\alpha, l)}; X, N)_{*}$$

where $F_{(\alpha,l)}$ is some open-closed cobordism to the circle having the boundary structure prescribed by (α, l) .

Precomposition with a morphism $m: (\alpha, l) \to (\beta, k)$ induces a continuous map $\mathrm{Mor}_0((\beta, k)) \to \mathrm{Mor}_0((\alpha, l))$ which commutes with T. Thus we obtain a map $\mathrm{Mor}_\infty((\beta, k)) \to \mathrm{Mor}_\infty((\alpha, l))$ and we have that Mor_∞ is a contravariant functor from $\widetilde{\mathcal{C}}^b_{X,N}$ to Spaces.

Proposition 3.11 Suppose that X is simply connected and that N is discrete. If $m: (\alpha, l) \to (\beta, k)$ is a morphism in $\widetilde{\mathcal{C}}_{X,N}^b$ whose map to the background space is constant at the basepoint then

$$\operatorname{Mor}_{\infty}(m): \operatorname{Mor}_{\infty}((\beta, k)) \to \operatorname{Mor}_{\infty}((\alpha, l))$$

is an isomorphism on integral homology.

Proof In this case (α, l) , (β, k) both lie in $\widetilde{\mathcal{C}}_{X,N}^b(0)$ and we can think of $\mathrm{Mor}_{\infty}(m)$ as a map

$$\operatorname{Mor}_{\infty}(m) \colon \mathbb{Z} \times \mathbb{Z} \times \mathcal{S}_{\infty}^{\infty}(F_{(\beta,k)}; X, N)_{*} \to \mathbb{Z} \times \mathbb{Z} \times \mathcal{S}_{\infty}^{\infty}(F_{(\alpha,l)}; X, N)_{*}.$$

This is an isomorphism by Corollaries 3.6, 3.7 and 3.8.

For morphisms whose underlying map is nonconstant we must do a little more work. This is because our stability theorems only tell us what happens when we precompose with a cobordism and extend the maps to the background space by constant ones.

Proposition 3.12 When X is simply connected and N is discrete, every morphism $m: (\alpha, l) \to (\beta, k)$ in $\widetilde{C}^b_{X,N}$ becomes an isomorphism in integral homology after applying Mor_{∞} .

Proof If (α, l) and (β, k) are in some component of $\widetilde{\mathcal{C}}_{X,N}^b$ other than $\widetilde{\mathcal{C}}_{X,N}^b(0)$ then $\mathrm{Mor}_{\infty}((\alpha, l))$ and $\mathrm{Mor}_{\infty}((\beta, k))$ are both empty so the conclusion of the proposition holds. Assume that (α, l) and (β, k) are in $\widetilde{\mathcal{C}}_{X,N}^b(0)$.

Using the fact that X is simply connected and N is discrete, we can decompose m as $m_1 \circ m_2 \circ \cdots \circ m_k$ where for each i we have one of the following.

- (a) $m_i = [h_i, c_i]$ where c_i is constant at some point in N.
- (b) The cobordism underlying m_i is of the form $S \times I$ for some 1-manifold S.

Those m_i satisfying (a) induce homology isomorphisms on $\operatorname{Mor}_{\infty}$ by Proposition 3.11. Those $m_i = [h_i, \psi_i]$ satisfying (b) induce homotopy equivalences on $\operatorname{Mor}_{\infty}$ with homotopy inverse induced by $\overline{m}_i = [h_i, \overline{\psi}_i]$ where $\overline{\psi}_i(s, t) = \psi_i(s, 1 - t)$ for $(s, t) \in S \times I$.

Proposition 3.13 The projection map $\operatorname{Obj}(\operatorname{Mor}_{\infty} \wr \widetilde{\mathcal{C}}^b_{X,N}) \to \operatorname{Obj}(\widetilde{\mathcal{C}}^b_{X,N})$ is a Serre fibration.

Proof Consider the following pullback square.

$$\begin{array}{ccc} \operatorname{Obj}\left(\operatorname{Mor}_0\wr\widetilde{\mathcal{C}}_{X,N}^b\right) & \longrightarrow & \operatorname{Mor}\left(\widetilde{\mathcal{C}}_{X,N}^b\right) \\ & & & & & & & & \\ \downarrow & & & & & & & \\ \operatorname{Obj}\left(\widetilde{\mathcal{C}}_{X,N}^b\right) & \longrightarrow & \operatorname{Obj}\left(\widetilde{\mathcal{C}}_{X,N}^b\right) \times \operatorname{Obj}\left(\widetilde{\mathcal{C}}_{X,N}^b\right) \end{array}$$

The right-hand map is given by restricting embeddings, and maps to the background space, to the boundary and hence is a Serre fibration. Thus the left-hand map and also Obj $(\operatorname{Mor}_{\infty} \wr \widetilde{\mathcal{C}}^b_{X N}) \to \operatorname{Obj} (\widetilde{\mathcal{C}}^b_{X N})$ are Serre fibrations.

Lemma 3.14 $B(\operatorname{Mor}_{\infty} \wr \widetilde{\mathcal{C}}_{X,N}^b)$ is contractible.

Proof $B(\operatorname{Mor}_{\infty}\wr\widetilde{\mathcal{C}}^b_{X,N}) \cong \operatorname{hocolim} B(\operatorname{Mor}_1\wr\widetilde{\mathcal{C}}^b_{X,N})$ but $B(\operatorname{Mor}_1\wr\widetilde{\mathcal{C}}^b_{X,N})$ is contractible since $\operatorname{Mor}_1\wr\widetilde{\mathcal{C}}^b_{X,N}$ has a terminal object $(\beta_0,\operatorname{id}_{\beta_0})$.

Theorem 3.15 When X is simply connected and N is discrete there is a homology isomorphism

$$f: \mathbb{Z} \times \mathbb{Z} \times \mathcal{S}_{\infty}^{\infty}(F_{(\alpha,l)}; X, N)_{*} \to \Omega B \widetilde{\mathcal{C}}_{X,N}^{b}$$

for each $(\alpha, l) \in \text{Obj}(\widetilde{\mathcal{C}}^b_{X,N}(0))$.

Proof By Proposition 3.12 and Proposition 3.13 and Lemma 3.14, the conditions of Theorem 3.9 are satisfied and we can conclude that there is a homology isomorphism $\operatorname{Mor}_{\infty}((\alpha, l)) \to \Omega B \widetilde{\mathcal{C}}_{X}^{b}{}_{N}$. The theorem now follows from Equation (2).

Note that we have omitted the basepoint of the loop space from the notation. Since $B\widetilde{\mathcal{C}}_{X,N}^b$ is an infinite loop space, all of its path-components are homotopy equivalent so it doesn't matter where we base the loops.


Theorem 3.16 Let $C_{X,N}^{b,c}$ denote the full subcategory of $\widetilde{C}_{X,N}^{b}$ whose objects are closed 1-manifolds. When X is simply connected and N is discrete, the inclusion functor induces a weak homotopy equivalence

$$\Omega B \mathcal{C}_{X,N}^{b,c} \to \Omega B \widetilde{\mathcal{C}}_{X,N}^{b}$$
.

Proof We could equally well apply the methods above to yield a homology isomorphism

$$f': \mathbb{Z} \times \mathbb{Z} \times \mathcal{S}_{\infty}^{\infty}(F_{(\alpha,\emptyset)}; X, N)_{*} \to \Omega B \mathcal{C}_{X,N}^{b,c}$$

for each $(\alpha, \emptyset) \in \text{Obj}(\mathcal{C}^{b,c}_{X,N}) \subset \text{Obj}(\widetilde{\mathcal{C}}^b_{X,N})$. The map induced by the inclusion functor fits into the following commutative diagram:



Since f and f' are homology isomorphisms, so is the vertical map and since its source and target are both loop spaces, it is a weak homotopy equivalence.

3.3 A splitting




Figure 6: The surfaces F, \overline{F} and F'

Theorem 3.17 Suppose that X is simply connected and N is discrete. Let F be a connected open-closed cobordism from some closed, oriented 1-manifold to S^1 and let \overline{F} be the ordinary cobordism obtained by gluing a disc to each window of F (see Figure 6). Then there is a homology isomorphism

$$g: \mathbb{Z} \times \mathcal{S}_{\infty}^{\infty}(F; X, N)_{*} \to \mathcal{S}_{\infty}(\overline{F}; X)_{*} \times \mathcal{O}((BS^{1} \times N)_{+}).$$

Proof Let F' be the ordinary cobordism that is homeomorphic to F as a surface and has $\partial_{\text{out}} F' = S^1$ (see Figure 6).

Restriction to the windows yields a fibration

$$\begin{split} E\mathrm{Diff}^+_\mathrm{oc}(F) \times_{\mathrm{Diff}^+_\mathrm{oc}(F)} \mathrm{Map}(F, \partial_f F; X, N)_* \\ & \to E\mathrm{Diff}^+(\partial_f F) \times_{\mathrm{Diff}^+(\partial_f F)} \mathrm{Map}(\partial_f F; N) \end{split}$$
 with fibre
$$E\mathrm{Diff}^+_\mathrm{oc}(F') \times_{\mathrm{Diff}^+_\mathrm{oc}(F')} \mathrm{Map}(F', \partial_F; X, *).$$

Using the fact that $\mathrm{Diff}^+(\coprod_w S^1) \simeq \Sigma_w \wr S^1$ we see that this fibration is (homotopy equivalent to)

(3)
$$S(F';X)_* \to S(F;X,N)_* \to E(\Sigma_w \wr S^1) \times_{\Sigma_w \wr S^1} (LN)^w$$
.

There is a map from here to the trivial fibration

$$\mathcal{S}(\bar{F};X)_* \to \mathcal{S}(\bar{F};X)_* \times E(\Sigma_w \wr S^1) \times_{\Sigma_w \wr S^1} (LN)^w \to E(\Sigma_w \wr S^1) \times_{\Sigma_w \wr S^1} (LN)^w.$$

On the base space this map is the identity. On the total space the map into the first factor is induced by the inclusion $F \to \overline{F}$; we are able to extend diffeomorphisms over the glued-in discs, at least up to homotopy, and we are able to extend maps $(F, \partial_f F) \to (X, N)$ over the glued-in discs because any such map must be constant on each window (using the fact that N is discrete). The map into the second factor is given by restriction to windows, as in the previous fibration. On the fibres, the map is given by attaching discs to the extra boundary components and extending diffeomorphisms by the identity and maps to X by c_* , the constant map to the basepoint.

By Theorem 3.2 the map on the fibers is an isomorphism on H_s when the genus of F is at least 2s + 4. Thus by the Zeeman comparison theorem we conclude that the map of total spaces is an isomorphism on homology in the same range. Taking limits we get a homology isomorphism

$$S_{\infty}^{\infty}(F;X,N)_* \to S_{\infty}(\overline{F};X)_* \times \lim_{w \to \infty} E(\Sigma_w \wr S^1) \times_{\Sigma_w \wr S^1} (LN)^w.$$

To conclude, note that since N is discrete,

$$E(\Sigma_w \wr S^1) \times_{\Sigma_w \wr S^1} (LN)^w \simeq E\Sigma_w \times_{\Sigma_w} (ES^1 \times_{S^1} LN)^w$$
$$\simeq E\Sigma_w \times_{\Sigma_w} (BS^1 \times N)^w$$

and recall that by the group completion theorem and the Barratt-Priddy-Quillen theorem, there is a homology isomorphism

$$\mathbb{Z} \times \lim_{w \to \infty} E \Sigma_w \times_{\Sigma_w} (BS^1 \times N)^w \to Q((BS^1 \times N)_+).$$

The following theorem is relevant.

Theorem 3.18 (Cohen–Madsen [3, Theorem 1]) Suppose that X is simply connected. For any ordinary, connected cobordism \overline{F} there is a homology isomorphism

$$h: \mathbb{Z} \times \mathcal{S}_{\infty}(\overline{F}; X)_* \simeq \Omega^{\infty}(MTSO(2) \wedge X_+).$$

Note that in the case of general N, we still have the fibration (3) but we don't have a map to the trivial fibration. Perhaps this fibration could be useful in studying $S(F; X, N)_*$ for arbitrary N.

3.4 Maps to infinite loop spaces

Let $\mathcal{C}_{X,N}^{b,c}$ denote the full subcategory of $\widetilde{\mathcal{C}}_{X,N}^{b}$ whose objects are the closed 1-manifolds. Theorem 3.16 states that when X is simply connected and N is discrete, the inclusion functor induces a weak homotopy equivalence $\Omega B \mathcal{C}_{X,N}^{b,c} \to \Omega B \widetilde{\mathcal{C}}_{X,N}^{b}$. We now give two maps from $\Omega B \mathcal{C}_{X,N}^{b,c}$ into infinite loop spaces.

3.4.1 The map $a: \Omega BC_{X,N}^{b,c} \to \Omega^{\infty}(MTSO(2) \land X_+)$ There is a functor $\alpha: C_{X,N}^{b,c} \to C_2^+(X)$ where $C_2^+(X)$ is the ordinary 2-dimensional cobordism category with background space X, studied in [6]. These two categories have a common object set and α is the identity on the objects.

Given a morphism $[h,\phi]$ in $\mathcal{C}_{X,N}^{b\,c}$ with underlying cobordism F, define $\alpha([h,\phi])=[\overline{h},\overline{\phi}]$ with underlying cobordism \overline{F} where \overline{F} is obtained from F by gluing discs over the windows and \overline{h} , $\overline{\phi}$ are obtained from h, ϕ by extension over the discs. Since the space $\operatorname{Emb}(\overline{F},\mathbb{R}^\infty\times[0,1])$ is contractible, we can make a continuous choice of extension \overline{h} . Also, because N is discrete, the map $\phi\colon (F,\partial_f F)\to (X,N)$ must be constant on each window so there is a canonical way to define the extension $\overline{\phi}$.

After applying ΩB , the functor α yields the map a since $\Omega BC_2^+(X)$ is homotopy equivalent to $\Omega^{\infty}(MTSO(2) \wedge X_+)$ by [6].

3.4.2 The map $b: \Omega B\mathcal{C}^{b,c}_{X,N} \to Q((BS^1 \times N)_+)$ By the Barratt–Priddy–Quillen theorem, the target space is homotopy equivalent to

$$\Omega B \coprod_{n>0} E \Sigma_n \times_{\Sigma_n} (BS^1 \times N)^n.$$

The n-th space here is homotopy equivalent to

$$E$$
Diff⁺($\coprod_n S^1$) $\times_{Diff^+(\coprod_n S^1)}$ Map($\coprod_n S^1, N$)

using the facts that N is discrete and $\mathrm{Diff}^+(\coprod_n S^1)\simeq \Sigma_n\wr S^1$.

Thus to define the map $b: \Omega BC_{X,N}^{b,c} \to Q((BS^1 \times N)_+)$ it suffices to give a functor

$$\beta \colon \mathcal{C}^{b,c}_{X,N} \to \coprod_{n \geq 0} E \mathrm{Diff}^+(\coprod_n S^1) \times_{\mathrm{Diff}^+(\coprod_n S^1)} \mathrm{Map}(\coprod_n S^1, N).$$

Such a functor is given by sending every object in $C_{X,N}^{b,c}$ to the unique object in the monoid and is given on the morphisms by

$$\beta([h, \phi]) = [h|_{\text{wind}}, \phi|_{\text{wind}}]$$

where |wind means restriction to the windows of the underlying open-closed cobordism.

3.5 Proof of the main theorem

Theorem 3.19 When X is simply connected and N is discrete there is a weak homotopy equivalence

$$\Omega B \widetilde{\mathcal{C}}_{X,N}^b \simeq \Omega^\infty(MTSO(2) \wedge X_+) \times Q((BS^1 \times N)_+).$$

Proof Let F be any connected open-closed cobordism with $\partial_{\text{out}}F = S^1$ and let \overline{F} denote the ordinary cobordism obtained by gluing discs over the windows of F. The maps a,b,f',g,h from Sections 3.4, 3.2 and 3.3 fit into the following commutative diagram:

$$\mathbb{Z} \times \mathbb{Z} \times \mathcal{S}_{\infty}^{\infty}(F; X, N)_{*} \xrightarrow{g} \mathbb{Z} \times \mathcal{S}_{\infty}(\overline{F}; X)_{*} \times Q((BS^{1} \times N)_{+}) \\
\downarrow f' \qquad \qquad \qquad \downarrow h \times \mathrm{id} \\
\Omega B \mathcal{C}_{X,N}^{b,c} \xrightarrow{a \times b} \Omega^{\infty}(MTSO(2) \wedge X_{+}) \times Q((BS^{1} \times N)_{+})$$

Theorems 3.15, 3.17 and 3.18 tell us that the maps f', g and h are homology isomorphisms. Thus $a \times b$ is a homology isomorphism and since the target and source are loop spaces, it is a weak homotopy equivalence. Together with Theorem 3.16, this proves the theorem.

Since $B\widetilde{\mathcal{C}}_{X,N}^b$ is an infinite loop space, its path-components are all homotopy equivalent. Theorem 3.19 identifies $\Omega B\widetilde{\mathcal{C}}_{X,N}^b$ and by delooping, we know the homotopy type of any particular path-component of $B\widetilde{\mathcal{C}}_{X,N}^b$. Since we also know $\pi_0 B\widetilde{\mathcal{C}}_{X,N}^b$, we have completely determined $B\widetilde{\mathcal{C}}_{X,N}^b$.

We end by noting that as a special case of Theorem 3.19 we have reproved the main result of Baas-Cohen-Ramirez [1]. In that paper the authors studied a 2-category $\mathcal{S}_B^{\text{oc}}$ in which the objects are oriented 1-manifolds with their boundary points labeled by elements of a set B, the morphisms are oriented open-closed cobordisms with each free boundary component labeled by an element of B and the 2-morphisms are diffeomorphisms of cobordisms which respect the labels. In the case that X is contractible and N is discrete, $\widetilde{\mathcal{C}}_{X,N}^b$ is an embedded surface version of $\mathcal{S}_B^{\text{oc}}$ and Theorem 3.19 agrees with the calculation of $\Omega B \mathcal{S}_B^{\text{oc}}$ in [1].

4 Appendix: Homology stability proofs

In this section we will prove Theorems 3.3, 3.4 and 3.5. We will make use of the following generalized form of the Serre spectral sequence.

Theorem 4.1 (Moerdijk–Svensson [13]) Let $F \to E \to B$ be a fibration and M a $\pi_1(E)$ –module. There is an action of $\pi_1(B)$ on $H_*(F,M)$ and a Serre spectral sequence

$$E_{p,q}^2 = H_p(B, H_q(F, M)) \Longrightarrow H_{p+q}(E, M).$$

The notation continues as in Section 3.1. We use $F_{g,r}^k$ to denote the surface $F_{g,r}$ with k marked points.

Lemma 4.2 Suppose X is simply connected and N is discrete. Let F be a connected open-closed cobordism of genus g, with w windows and a total of n+w boundary components. There is an isomorphism of $\Gamma_{g,n+w}$ -modules

$$H_r(\operatorname{Map}(F, \partial_f F; X, N)_*) \cong \bigoplus_{N^w} H_r(\operatorname{Map}(F_{g,n+w}, \partial F_{g,n+w}; X, *))$$

where the $\Gamma_{g,n+w}$ -action on the left-hand side is via the inclusion $\Gamma_{g,n+w} \to \Gamma_{\rm oc}(F)$.

Proof Because N is discrete, any $f \in \operatorname{Map}(F, \partial_f F; X, N)_*$ must be constant on each window and map the free boundary intervals to the basepoint so

$$\operatorname{Map}(F, \partial_f F; X, N)_* = \operatorname{Map}(F_{g,n}^w, \operatorname{pts}; X, N)_*$$

where the subscript * on the right-hand side means that $\partial F_{g,n}^w$ must map to the basepoint. If f, f' lie in the same path-component of the mapping space $\operatorname{Map}(F_{g,n}^w, \operatorname{pts}; X, N)_*$ then $f(p_i) = f'(p_i)$ for all i where p_1, \ldots, p_w are the marked points of $F_{g,n}^w$. Thus

$$\operatorname{Map}(F_{g,n}^w,\operatorname{pts};X,N)_*=\coprod_{\underline{n}\in N^w}\operatorname{Map}^{\underline{n}}(F_{g,n}^w,\operatorname{pts};X,N)_*$$

where the superscript \underline{n} means that we only allow those f that satisfy $f(p_1, \ldots, p_w) = \underline{n}$. Since X is path-connected, for all $\underline{n} \in N^w$,

$$\operatorname{Map}^{\underline{n}}(F_{g,n}^{w},\operatorname{pts};X,N)_{*} \simeq \operatorname{Map}^{\underline{*}}(F_{g,n}^{w},\operatorname{pts};X,N)_{*}$$
$$= \operatorname{Map}(F_{g,n+w},\partial F_{g,n+w};X,*).$$

The identifications given are all $\Gamma_{g,n+w}$ -equivariant.

Proof of Theorem 3.3 Suppose that F has genus g, w windows and a total of n+w boundary components. By considering the effect of a diffeomorphism on the windows of F we obtain a map $\mathrm{Diff}^+_{\mathrm{oc}}(F) \to \Sigma_w \wr \mathrm{Diff}^+(S^1) \simeq \Sigma_w \wr S^1$. The kernel is the group of orientation-preserving diffeomorphisms that fix $\partial_{\mathrm{in}} F \cup \partial_{\mathrm{out}} F$, and the windows, pointwise, call it $\mathrm{Diff}^\wedge(F)$. Taking classifying spaces we obtain a fibration

$$B\mathrm{Diff}^{\wedge}(F) \to B\mathrm{Diff}^+_{\mathrm{oc}}(F) \to B(\Sigma_w \wr S^1).$$

Using the fact that the diffeomorphism groups have contractible components [4; 5], we have a homotopy fibration

$$B\Gamma_{g,n+w} \to B\Gamma_{\rm oc}(F) \to B(\Sigma_w \wr S^1).$$

The inclusion $F \to F^{\#}$ induces a map from this fibration to

$$B\Gamma_{g^{\#},n^{\#}+w} \to B\Gamma_{\mathrm{oc}}(F^{\#}) \to B(\Sigma_{w} \wr S^{1}).$$

Consider the Serre spectral sequences for these fibrations, taken with twisted coefficients in $H_r(\operatorname{Map}(F, \partial_f F; X, N)_*)$ and $H_r(\operatorname{Map}(F^\#, \partial_f F^\#; X, N)_*)$ respectively. There is an induced map of spectral sequences and on the E^2 -page it is of the form

$$\begin{split} E_{p,q}^2 &= H_p(B(\Sigma_w \wr S^1); H_q(\Gamma_{g,n+w}, H_r(\text{Map}(F, \partial_f F; X, N)_*))) \\ &\to \widetilde{E}_{p,q}^2 = H_p(B(\Sigma_w \wr S^1); H_q(\Gamma_{g^\#,n^\#+w}, H_r(\text{Map}(F^\#, \partial_f F^\#; X, N)_*))). \end{split}$$

By Lemma 4.2, this is isomorphic to the map

$$H_{p}(B(\Sigma_{w} \wr S^{1}); \bigoplus_{N^{w}} H_{q}(\Gamma_{g,n+w}, H_{r}(\operatorname{Map}(F_{g,n+w}, \partial F_{g,n+w}; X, *))))$$

$$\to H_{p}(B(\Sigma_{w} \wr S^{1}); \bigoplus_{N^{w}} H_{q}(\Gamma_{g^{\#},n^{\#}+w}, H_{r}(\operatorname{Map}(F_{g^{\#},n^{\#}+w}, \partial F_{g^{\#},n^{\#}+w}; X, *))))$$

which, by Theorem 3.1, is an isomorphism for $g \ge 2q + r + 2$. The map on the abutments is precisely the map in the statement of the theorem so applying the Zeeman comparison theorem yields the result.

Proof of Theorem 3.4 Let g, n, w be as above. As in the proof of Theorem 3.3 we have a map of fibrations:

$$B\Gamma_{g,n+w} \longrightarrow B\Gamma_{\text{oc}}(F) \longrightarrow B(\Sigma_{w} \wr S^{1})$$

$$\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow$$

$$B\Gamma_{g,n+w+1} \longrightarrow B\Gamma_{\text{oc}}(F^{\#}) \longrightarrow B(\Sigma_{w+1} \wr S^{1})$$

Again we look at the twisted Serre spectral sequences associated to these fibrations and the induced map between them. On the E^2 -page this now takes the form

$$\begin{split} E_{p,q}^2 &= H_p(B(\Sigma_w \wr S^1); H_q(\Gamma_{g,n+w}, H_r(\mathrm{Map}(F, \partial_f F; X, N)_*))) \\ &\to \widetilde{E}_{p,q}^2 = H_p(B(\Sigma_{w+1} \wr S^1); H_q(\Gamma_{g,n+w+1}, H_r(\mathrm{Map}(F^\#, \partial_f F^\#; X, N)_*))). \end{split}$$

Since N is a point, the coefficient groups in these homology groups are the same as

$$\begin{split} &H_q(\Gamma_{g,n+w},H_r(\mathrm{Map}(F_{g,n+w},\partial F_{g,n+w};X,*))),\\ &H_q(\Gamma_{g,n+w+1},H_r(\mathrm{Map}(F_{g,n+w+1},\partial F_{g,n+w+1};X,*))) \end{split}$$

so by Theorem 3.1 the map of coefficients is an isomorphism when $g \ge 2q + r + 2$. By the next lemma, the Σ_w -action on these coefficients is trivial in this range. Thus, in the stable range, the map on the E^2 -page is of the form

$$H_p(B(\Sigma_w \wr S^1), G) \to H_p(B(\Sigma_{w+1} \wr S^1), G)$$

for a constant, untwisted coefficient group G. Since $B(\Sigma_w \wr S^1) \simeq E\Sigma_w \times_{\Sigma_w} (BS^1)^w$ this is an isomorphism for $w \geq 2p+6$; see Hanbury [8, Theorem 5]. An application of the Zeeman comparison theorem completes the proof.

Lemma 4.3 For $g \ge 2q + r + 2$, the Σ_w -action on

$$H_q(\Gamma_{g,n+w}, H_r(\operatorname{Map}(F_{g,n+w}, \partial F_{g,n+w}; X, *)))$$

is trivial.

Proof The Σ_w -action is induced by the first fibration in (4). Thus it is given by lifting a permutation $\sigma \in \Sigma_w$ to a mapping class $\phi_\sigma \in \Gamma_{\rm oc}(F)$ and then acting by conjugation on $\Gamma_{g,n+w}$ and by left-multiplication on $H_r({\rm Map}(F_{g,n+w},\partial F_{g,n+w};X,*))$.

Think of F as $F_1\#F_2$ where F_1 has no windows and F_2 is a cylinder with w windows. Similarly, think of $F_{g,n+w}$ as $F_{g,n}\#F_{0,w+2}$. The inclusion $\Gamma_{g,n+w}\to\Gamma_{\rm oc}(F)$ restricts to an inclusion $\Gamma_{g,n}\to\Gamma_{\rm oc}(F_1)$. By Theorem 3.1, there is an isomorphism

$$H_q(\Gamma_{g,n}, H_r(\operatorname{Map}(F_{g,n}, \partial F_{g,n}; X, *)))$$

 $\to H_q(\Gamma_{g,n+w}, H_r(\operatorname{Map}(F_{g,n+w}, \partial F_{g,n+w}; X, *)))$

so we can represent an arbitrary element of the latter group by $z \otimes v$ from the bar resolution

$$Bar(\Gamma_{g,n}) \otimes_{\Gamma_{g,n}} H_r(Map(F_{g,n}, \partial F_{g,n}; X, *)).$$

To calculate $\sigma \cdot (z \otimes v)$ choose $\phi_{\sigma} \in \Gamma_{\text{oc}}(F_2) \subseteq \Gamma_{\text{oc}}(F)$. Since ϕ_{σ} and the diffeomorphisms appearing in z have disjoint support, they commute. For similar reasons $\phi_{\sigma} \cdot v = v$ so $\sigma \cdot (z \otimes v) = z \otimes v$.

Proof of Theorem 3.5 Suppose for simplicity that F itself has no windows so that F^w has w windows and $(F^\#)^w$ has w+1 windows (see the introduction for the definition of F^w and the natural inclusion $F^w o F^{w+1}$). Suppose further that F

has genus g and n boundary components. Thus F^w has genus g+w and a total of n+w boundary components. Let $\mu_0, \mu_1 \colon \Sigma_w \wr S^1 \to \Sigma_{w+1} \wr S^1$ be defined by $\mu_0(\sigma,\underline{z}) = (\iota \times \sigma, 1 \times \underline{z})$ and $\mu_1(\sigma,\underline{z}) = (\sigma \times \iota,\underline{z} \times 1)$ where $\iota \in \Sigma_1$ is the identity permutation.

Taking the limit of diagram (4) over F^w , $(F^\#)^w$ we obtain the following diagram of fibrations:

$$B\Gamma_{\infty,\infty} \longrightarrow B\Gamma_{\infty}^{\infty}(F) \longrightarrow \operatorname{hocolim}_{w \to \infty} B(\Sigma_w \wr S^1)$$

$$\downarrow \qquad \qquad \downarrow \qquad \qquad \downarrow$$

$$B\Gamma_{\infty,\infty+1} \longrightarrow B\Gamma_{\infty}^{\infty}(F^{\#}) \longrightarrow \operatorname{hocolim}_{w \to \infty} B(\Sigma_{w+1} \wr S^1)$$

Consider the Serre spectral sequences associated to these two fibrations, with twisted coefficients taken in

$$H_r(\operatorname{Map}_{\infty}^{\infty}(F, \partial_f F; X, N)_*)$$
 and $H_r(\operatorname{Map}_{\infty}^{\infty}(F^{\#}, \partial_f F^{\#}; X, N)_*)$

respectively. There is an induced map between these spectral sequences and the map on the abutments is precisely the one in the theorem. Thus, by the Zeeman comparison theorem, it suffices to show that the map on the E^2 -page is an isomorphism. The rest of the proof is devoted to that task.

The $E_{p,q}^2$ -terms are

$$H_p(\operatorname{hocolim} B(\Sigma_w \wr S^1); H_q(B\Gamma_{\infty,\infty}; H_r(\operatorname{Map}_{\infty}^{\infty}(F, \partial_f F; X, N)_*))),$$

 $H_p(\operatorname{hocolim} B(\Sigma_{w+1} \wr S^1); H_q(B\Gamma_{\infty,\infty+1}); H_r(\operatorname{Map}_{\infty}^{\infty}(F^{\#}, \partial_f F^{\#}; X, N)_*))).$

Since limits and group homology commute these are isomorphic to the limits, as $w \to \infty$, of

$$H_p(B(\Sigma_w \wr S^1); H_q(\Gamma_{g+w,n+w}; H_r(\text{Map}(F^w, \partial_f F^w; X, N)_*))),$$

 $H_p(B(\Sigma_{w+1} \wr S^1); H_q(\Gamma_{g+w,n+w+1}; H_r(\text{Map}((F^\#)^w, \partial_f (F^\#)^w; X, N)_*))).$

It will be important for us to keep track of the maps used to form limits. The maps used here are induced by $B\mu_1$ on the spaces and by $F^w \hookrightarrow F^{w+1}$ on the coefficients.

The map between the E^2 -terms can be realised by finite-level maps

(5)
$$H_p(B(\Sigma_w \wr S^1); H_q(\Gamma_{g+w,n+w}; H_r(\text{Map}(F^w, \partial_f F^w; X, N)_*)))$$

 $\to H_p(B(\Sigma_{w+1} \wr S^1); H_q(\Gamma_{g+w,n+w+1}; H_r(\text{Map}((F^\#)^w, \partial_f (F^\#)^w; X, N)_*))).$

These are induced on the spaces by $B\mu_0$ and on the coefficients by $F^w \hookrightarrow (F^{\#})^w$.

By Lemma 4.2, the group in (5) is isomorphic to

$$H_p\bigg(B(\Sigma_w \wr S^1); \bigoplus_{\underline{n} \in N^w} H_q(\Gamma_{g+w,n+w}; H_r(\operatorname{Map}(F_{g+w,n+w}, \partial F_{g+w,n+w}; X, *)))\bigg).$$

By Lemma 4.3 we know that the Σ_w -action on each of these summands is trivial provided the genus is sufficiently large. Furthermore, by Theorem 3.1 we know that $H_q(\Gamma_{g+w,n+w}; H_r(\operatorname{Map}(F_{g+w,n+w}, \partial F_{g+w,n+w}; X, *)))$ is independent of g, n and w for large g+w. We conclude that for sufficiently large w, the group in (5) is of the form

$$H_p\bigg(B(\Sigma_w\wr S^1); \bigoplus_{N^w}A\bigg)$$

where A is an abelian group with trivial Σ_w -action and the action of Σ_w on the coefficients is induced by the permutation action on N^w .

Let ν_0 : $\bigoplus_{N^w} A \to \bigoplus_{N^{w+1}} A$ be the map induced by $\widetilde{\nu}_0$: $N^w \to N^{w+1}$ with $\widetilde{\nu}_0(\underline{n}) = *\times\underline{n}$. Similarly we have ν_1 : $\bigoplus_{N^w} A \to \bigoplus_{N^{w+1}} A$ induced by $\widetilde{\nu}_1$ with $\widetilde{\nu}_1(\underline{n}) = \underline{n} \times *$.

Now,
$$E_{p,q}^2 \cong \lim_{w \to \infty} H_p(B(\Sigma_w \wr S^1); \bigoplus_{N^w} A),$$

$$\tilde{E}_{p,q}^2 \cong \lim_{w \to \infty} H_p(B(\Sigma_{w+1} \wr S^1); \bigoplus_{N^{w+1}} A).$$

and the maps used to form these limits are $H_p(B\mu_1, \nu_1)$. Under these identifications, the map between the E^2 -pages is induced by the finite-level maps $H_p(B\mu_0, \nu_0)$.

Let $\tau \in \Sigma_{w+1}$ be the block permutation sending (1, 2, ..., w+1) to (2, ..., w+1, 1). Let $c_{(\tau,1)} \colon \Sigma_{w+1} \wr S^1 \to \Sigma_{w+1} \wr S^1$ denote conjugation by $(\tau, 1)$ and

$$\rho_{\tau} \colon \bigoplus_{N^{w+1}} A \to \bigoplus_{N^{w+1}} A$$

be given by the action of τ . Then $c_{(\tau,1)} \circ \mu_0 = \mu_1$ and $\rho_\tau \circ \nu_0 = \nu_1$ so

$$H_p(Bc_{(\tau,1)}, \rho_{\tau}) \circ H_p(B\mu_0, \nu_0) = H_p(B\mu_1, \nu_1).$$

It is a fundamental property of group cohomology that $H_p(Bc_{(\tau,1)}, \rho_{\tau})$ is the trivial map. Thus $H_p(B\mu_0, \nu_0)$ is the same as $H_p(B\mu_1, \nu_1)$ and hence it is trivial in the limit since $H_p(B\mu_1, \nu_1)$ is used to form that limit. We conclude that the map on the E^2 -page is an isomorphism.
