In der Quantentheorie werden Observable durch Operatoren im Hilbert-Raum dargestellt. Der dafür geeignete mathematische Rahmen sind die C^X -Algebren, welche Matrizen und komplexe Funktionen verallgemeinern. Allerdings benötigt man in der Physik auch unbeschränkte Operatoren, deren Problematik eigens untersucht werden muß. Dementsprechend werden zunächst mathematische Fragen studiert und dann die Methoden auf atomare Systeme angewandt. Obgleich man außer dem Wasserstoffatom kaum explizit lösbare Probleme findet, lassen sich nicht nur allgemeine qualitative Fragen, etwa bezüglich des Energiespektrums und Streuverhaltens, beantworten, sondern auch quantitativ kann man auch für kompliziertere Systeme für meßbare Größen Schranken teils befriedigender Genauigkeit finden.
